Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements

We have performed an audit of the accompanying financial statements of McCormick Paint Works Company Profit Sharing Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. We are required to be independent of McCormick Paint Works Company Profit Sharing Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters

The supplemental schedule of assets (held for investment) and schedule of delinquent participant contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment

information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Plan Description

McCormick Paint Works Company (the Company) established the McCormick Paint Works Company Profit Sharing Retirement Plan (the Plan) in September 1970. Effective June 2017, the plan was amended to remove the nonparticipant portion of the plan to only provide a participant directed profit sharing plan. The Plan is a defined contribution plan organized under Section 401(a) of the Internal Revenue Code for the benefit of the employees of the Company. The Plan covers all eligible employees of the Company who have completed three months of service and have reached age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by a committee appointed by the Chairman of the Board of Directors of the Company. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Contributions

Each year, participants may elect to make pretax contributions to the Plan, subject to an annual limit of the lesser of 100% of eligible compensation or \$22,500. Participants aged 50 or older may make catch-up contributions which are also subject to IRS limitations. A discretionary matching contribution equal to a percentage of the amount of the salary reduction may be made by the Company. During the plan year ended September 30, 2023, the Company matched 50% of each employee’s contribution with a maximum match for the year of \$4,500 per participant. In addition, the Company may make discretionary profit-sharing contributions to non-participant directed accounts. Profit sharing contributions are allocated to participants’ accounts based on the ratio of the individual participant’s current-year compensation (which excludes bonuses and commissions) to the total of all participants’ compensation. No profit-sharing contributions were made for the plan year ended September 30, 2023.

Participant Accounts

Individual accounts are maintained for each participant and include their contributions, the participant’s share of the Company’s contributions, forfeitures, and gains and losses on investment activities. Investment income from investments is allocated daily, based on the earnings or losses of the respective investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. The Plan currently offers various mutual funds and common/collective trusts as investment options for participant directed contributions.

Vesting

Participants are always fully vested in their elective deferral contributions and the earnings thereon. Vesting in the remainder of their account is based on years of continuous service. After two years of service, a participant becomes 20% vested in employer matching and profit-sharing contributions in the Plan; the vesting percentage increases by 20% each year until the participant becomes fully vested in his or her account after six years of service. Regardless of the participant's years of service, accounts become fully vested upon attainment of the normal retirement age or in the event of total permanent disability or death. Forfeitures may be used to pay administrative expenses of the plan and to reduce employer matching contributions. During the years ended September 30, 2023 and 2022, no forfeitures were used to reduce employer matching contributions. Unused forfeitures are carried forward to the next plan year. The Plan had a balance of \$40,400 and \$20,924 for forfeited non-vested accounts at September 30, 2023 and 2022, respectively.

Participant Loans

Under the Plan's provisions, participants may borrow up to (a) 50% of the value of their vested elective account balances or (b) \$50,000 less the highest outstanding balance of loans in the past twelve months, whichever is less, with a minimum loan requirement of \$1,000. Loan terms are not to exceed five years (30 years if used for the purchase of a principal residence) and are repaid in equal bi-weekly installments. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate. The interest rate remains fixed for the term of the loan. For the year ended September 30, 2023, interest rates charged on participant loans ranged between 4.25% and 9.50%. Principal and interest are paid ratably through payroll deductions. The Plan charges administrative expenses associated with the processing of loan applications directly to the participants taking such loans.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, all amounts credited to the participants' accounts will become fully vested.

Payment of Benefits

The Plan defines normal retirement age as 59.5. Upon attainment of normal retirement age, participants that are still employees of the Company can elect to receive in-service distributions.

Payment of Benefits (continued)

Upon termination of service due to retirement, death, or disability a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may receive a distribution for their non-elective account balance upon termination if their vested balance is less than \$5,000. Upon termination and thereafter, participants can rollover their account balances, under certain conditions, to another eligible retirement plan as defined by the Internal Revenue Code. If a terminated employee reaches the age of retirement and still has funds in the Plan, the employee will receive a single payment. Under Plan provisions, in certain hardship situations, participants may withdraw from their vested elective account balances. However, such withdrawals are limited to the amount dictated by the hardship. Benefits are recorded when paid.

2. Summary of Significant Accounting Policies

Basis of Accounting

These financial statements are prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions from Plan assets during the reporting period. Actual results, including realization of assets, could differ from those estimates.

Valuation of Investments

Investments are stated at fair value (Note 3). Fair value of shares of stable value funds are valued at the net asset value (Note 4).

Security purchases and sales are reflected on a trade date basis. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Participant Loans Receivable

Loans receivable from participants are measured at the unpaid principal balance. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Expenses

The Company may, at its discretion, pay the administrative expenses of the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments. Expenses not paid by the Company are paid from the Plan's assets.

Cash and Cash Equivalents

The term cash and cash equivalents include cash held in non-interest-bearing bank accounts and funds invested in interest bearing money market funds.

Subsequent Events

Management has evaluated subsequent events through June 13, 2024, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023.

Investments in *mutual funds* are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported as of the end of the reporting period. For the years ended September 30, 2023 and 2022, there were no significant transfers in or out of levels 1, 2 or 3.

5. Party-in-Interest Transactions

Effective March 15, 2022, the Plan changed its third-party administrator and record keeper to Fidelity Investments. Fidelity Brokerage Services, LLC is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions.

6. Tax Status

The Plan is a prototype plan sponsored by FMR, LLC (FMR). which has received an opinion letter from the Internal Revenue Service (IRS) that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has not received a separate determination letter from the IRS. However, the Plan administrator and the Plan's tax counsel believe the Plan is currently designed and is being operated in accordance with the applicable IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. At September 30, 2023, plan tax filings for 2020 through 2022 are open for audit by taxing authorities. However, no such audits are currently ongoing.
