## INDEPENDENT AUDITOR'S REPORT

Plan Participants and Plan Administrator of PCSB Bank 401(k) Savings Plan  
Yorktown Heights, New York

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of PCSB Bank 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets in liquidation as of August 31, 2023 and December 31, 2022, and the related statement of changes in net assets in liquidation for the period from January 1, 2023 to August 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of August 31, 2023 and December 31, 2022, and for the period from January 1, 2023 to August 31, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year from the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

#### **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the PCSB Bank 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General: The Plan is a participant-directed 401(k) plan covering all full-time salaried employees of the plan sponsor, PCSB Bank (the “Bank,” “Employer” or “Sponsor”), who have completed one month of service and have attained age 21. Effective September 1, 2019, the Plan includes an automatic salary deferral feature for newly hired employees, where 3% of the employee’s pre-tax compensation is contributed to the Plan in a default investment. Employees may, at their sole discretion, amend or eliminate the amount of contribution or amend the investment(s) in which the contribution is made. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). PCSB Bank is the wholly-owned subsidiary of PCSB Financial Corporation (the “Company”), a publicly-traded company.

On January 1, 2023, the Sponsor was acquired by Brookline Bancorp (“Brookline”) and the Sponsor stock was delisted. In addition, the Sponsor filed a post-effective Form S-8 on January 1, 2023 to deregister the Sponsor shares that had been registered to the Plan. As a condition of the merger agreement the Plan was terminated on December 31, 2022 (“Termination Date”). As a result of the termination, the Plan was frozen such that no new employees could enter the Plan from the Termination Date, and no contributions were to be made after the Termination Date. The Plan was subsequently set to liquidate in 2023, with participants paid out through lumpsum payments by electing to roll over to an IRA, Roth IRA or other employer plan, or taking a direct payout, or a combination of both preceding options.

As of August 31, 2023, all plan assets have been distributed to plan participants based on their preferred method (distributions, rollovers or a combination of both) totaling to \$21,430,513. These distributions were offset by the existing participant loan balances, if any, as of the date of distribution.

Contributions: Each year, participants may elect to contribute from 1% to 25% of their pretax compensation, as defined, up to limits prescribed by the Internal Revenue Service. The Bank may also make additional contributions at its discretion.

Rollovers: The Plan permits rollover contributions by an employee of the Bank, whether or not a participant. Rollover contributions are contributions to the Plan of funds received by an employee from another qualified plan or transferred directly to the Plan from another qualified plan. Rollover contributions were credited to a rollover contribution account in the name of the employee, were invested as directed by the employee and were credited with any investment earnings or losses thereon.

Forfeitures: Forfeitures totaled \$29 for the year ended December 31, 2022. Forfeitures are used by the Bank to offset any fees.

Payment of Benefits: Upon normal or early retirement, death, disability or severance from service, if elected, participants’ benefits are paid in a lump sum payment or distributed in installments from the participants’ vested account balance. Additionally, a participant who is no longer employed by the Bank for reasons other than retirement or disability and whose vested balance is \$1,000 or less will have their vested balance paid in the form of a single cash payment as soon as administratively possible after termination, while those participants whose vested balance is greater than \$1,000 have the option of leaving their balance in the Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Bank's contributions, and (b) Plan earnings, and is charged with his or her withdrawals, an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Vesting: As a result of Plan termination, described above, all participants became fully vested in all contributions types.

Notes Receivable from Participants: Participants may borrow from their vested account balances. The minimum loan amount is \$1,000 and the maximum amount is equal to the lesser of: (i) \$50,000, or (ii) 50% of the vested account balance. All loans are made for a fixed term of not more than 5 years except for the purchase of a primary residence which may have a term not exceeding 15 years. Loans are collateralized by the balance in the participant's vested account and bear interest at the prime rate rounded to the nearest 0.25% plus 1%. The prime rate for this purpose is the rate published in the Wall Street Journal on the first business day of the month in which the loan is made. The interest rate charged on participant loans issued was a range of 4.25% to 6.50% for the year ended December 31, 2022.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. All other expenses of the Plan are paid by the Bank.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: Effective December 31, 2022, Plan management determined that the Plan would be terminated. As Plan management determined that liquidation would be imminent, the basis of accounting for the Plan was changed from accrual basis of accounting for an ongoing plan as of December 31, 2021 to the liquidation basis of accounting as of and for the year ended December 31, 2022 and for subsequent periods thereon. These methods of accounting are in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"). There was no material impact to the Plan's net assets as a result of the application of the liquidation basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: As of December 31, 2022, the Plan held investments in mutual funds, a collective trust fund and the Sponsor's stock whose values were exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with such investments, it was at least reasonably possible that changes in the values of investments would occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets in liquidation.

Notes Receivable from Participants: As of December 31, 2022, notes receivable from participants were reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest were received through payroll deductions and the notes were collateralized by the participants' account balances.

Benefit Payments: Benefit payments are recorded when paid.

Investment Valuation and Income Recognition: As of December 31, 2022, the Plan's investments were reported at fair value as further described in Note 3. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

Fair value is the price that would be received by the Plan for an asset or liability in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual Funds: As of December 31, 2022, the fair values of mutual fund investments were based upon the closing net asset value per share of the mutual fund on the day of the valuation as reflected on a national securities exchange (Level 1 inputs).

Collective Trust: As of December 31, 2022, the fair value of participation units held in the collective trust, the MetLife Stable Value Fund, was based on the net asset value per unit as reported by the fund manager. The collective trust provided

for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement. The collective trust had no withdrawal restrictions for participant-initiated or plan sponsor withdrawals.

Company Stock: As of December 31, 2022, the fair value of Company stock was based on the closing price of the investment on the Nasdaq Global Market exchange (Level 1 inputs). The Company's shares of common stock were traded on the NASDAQ Capital Market under the symbol "PCSB" up to December 31, 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at December 31, 2022, and net appreciation in fair value of investments and interest and dividends for the period ended August 31, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan).

#### **NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. As of December 31, 2022, certain Plan investments were shares of MetLife Stable Value Fund Series 25053 that was a collective investment fund. Reliance Trust Company, who is custodian for the Plan, was also the trustee and custodian for the fund. Pentegra Retirement Services, Inc., the record keeper of the Plan, provided investment sub-advisory services for the fund. Transactions in the fund qualify as party-in-interest transactions. Notes receivable from participants were also considered party-in-interest transactions. Fees for accounting and other administrative services are paid for by the Bank. Direct and indirect fees paid for by the Plan are considered party-in-interest transactions. As of December 31, 2022, the Plan held 335,249 shares of Company stock with a value of \$6.4 million. As a result of Brookline acquiring the Company, the Plan received a combination of 245,389 shares of Brookline, amounting to \$1,670,821 at cost basis, and cash of \$4,982,342, in lieu of 335,249 Company shares of \$6,383,141 previously held. Also, during the year, the Plan received \$25,869 in dividends from Brookline stock and sold 245,389 shares of stock with a value of \$1,670,821. Transactions within the Brookline and the Company stock are considered related party transactions.

#### **NOTE 6 – PLAN TERMINATION**

On December 21, 2022, the Sponsor approved the termination of the Plan effective December 31, 2022. The Plan subsequently liquidated as described in Note 1, in accordance with provisions of ERISA and its related regulations.

#### **NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The Plan has subsequently been amended. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of August 31, 2023 and as of December 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

#### **NOTE 8 – SUBSEQUENT EVENTS**

Plan management has evaluated subsequent events for recognition and disclosure through June 10, 2024 which is the date the financial statements were available to be issued.
