#### ***Note 1 – Plan Description***

The following description of the ARGI Financial Group, LLC 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering all eligible salaried and non-bargaining employees of ARGI Holdings, Inc. and Subsidiaries (Company or Plan Sponsor) of the Plan who have attained 21 years of age. The Plan is subject to the provisions of ERISA. The Plan administrator and external trustee are responsible for oversight of the Plan. The Plan's Retirement Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Directors. On January 6, 2023, the Company entered into an asset purchase agreement with Cerity Partners, LLC to purchase all assets of the Company. As a result of the acquisition, the Company's Board of Directors approved the termination of the Plan.

#### ***Termination of Plan***

On December 22, 2022, the Company's Board of Directors, approved the termination of this Plan, effective as of December 31, 2022. Due to the termination of the Plan effective in 2022, there were no employer or employee contributions to the Plan during 2023. All participant balances were distributed from the Plan in 2023 and as of August 31, 2023, the Plan held no assets.

#### ***Contributions***

Each year, participants may contribute up to 100 percent of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan or elect to invest in self-directed brokerage accounts that allow for participant directed investments. The Company contributes a Safe Harbor matching contribution equal to 100 percent of the participants' voluntary contribution up to three percent and 50 percent of the amount of the employee's contribution that exceeds three percent but not to exceed five percent. Additional profit sharing amounts may be contributed at the option of the Company's Board of Directors and are invested in a portfolio of investments as directed by the Company. The Company did not make any contribution to the Plan during the period ended August 31, 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Company's Safe Harbor matching contributions, profit sharing contributions if any, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Note 1 – Plan Description (Continued)***

##### *Vesting*

Participants are vested immediately in their contributions and Safe Harbor matching contributions, plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after four years of credited service. Participants became immediately vested in all contributions as a result of the Plan termination.

##### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate determined quarterly, is set at one percent above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

##### *Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in annual installments. Participants may request a hardship withdrawal of a portion of their account attributable to participant deferrals. Any hardship withdrawal is limited to the amount needed to meet the financial need.

##### *Forfeited Accounts*

There were no forfeited nonvested accounts for the period ended August 31, 2023 or the year ended December 31, 2022.

#### ***Note 2 – Significant Accounting Policies***

##### *Basis of Accounting*

On December 22, 2022, the Board of Directors of the Company agreed to terminate the Plan. Plan management considered liquidation of the Plan to be imminent once the amendment was effective on December 31, 2022. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to value Plan assets from the ongoing Plan basis to the liquidation basis for the period ended August 31, 2023 and the year ended December 31, 2022.

#### ***Note 2 – Significant Accounting Policies (Continued)***

##### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, Custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of the period ended August 31, 2023 or for the year ended December 31, 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

##### *Payment of Benefits*

Benefits are recorded when paid.

##### *Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants, benefit payments, and certain other administrative and recordkeeping services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### ***Note 4 – Fair Value Measurements***

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ASC 820 are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2            Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at August 31, 2023 and December 31, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage accounts:* Account primarily consists of mutual funds, stocks, bonds, and ETFs that are valued on the basis of readily determinable market price.

#### ***Note 5 – Fully Benefit-Responsive Investment Contract***

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America maintain the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The crediting rate is based on a formula established by the contract issuer but may not be less than four percent. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and; therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

#### ***Note 5 – Fully Benefit-Responsive Investment Contract (Continued)***

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA;
2. Premature termination of the contracts;
3. Amendments to the Plan Documents (including complete or partial Plan termination or merger with another Plan);
4. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation;
4. A material amendment to the agreements without the consent of the issuer.

#### ***Note 6 – Related Party Transactions and Party-in-Interest Transactions***

Certain Plan investments are in a self-directed brokerage account, as well as an annuity contract, managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the Custodian as defined by the Plan and; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments of \$23,784 to their investment manager, Empower Advisory Group, LLC, and other service providers which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

#### ***Note 7 – Plan Termination***

As previously disclosed in Note 1, the Company's Board of Directors agreed to terminate the Plan effective December 31, 2022. As a result of Plan termination, participants become 100 percent vested in their profit sharing contributions. Participants are already fully-vested in their contributions and employer Safe Harbor contributions. All Plan assets were distributed to participants as of August 31, 2023.

#### ***Note 8 – Tax Status***

The Plan has adopted a volume submitter plan document sponsored by Retirement Management Services, LLC. The Plan received an opinion letter from the IRS as to the Plan's qualified status. The Plan Sponsor can rely on the qualified status to the extent the Plan Document does not deviate from the IRS pre-approved provisions. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of the period ended August 31, 2022, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

#### ***Note 9 – Risks and Uncertainties***

The Plan provided options to invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near-term and that such changes could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### ***Note 10 – Subsequent Events***

The Plan has evaluated subsequent events through June 17, 2024, the date the financial statements were available to be issued.
