INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Ocular Partners, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 1, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended June 1, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 1, 2023 and December 31, 2022, and for the period ended June 1, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

1. DESCRIPTION OF PLAN:

The following description of the Ocular Partners, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Ocular Partners, Inc., Chicago Eye Institute, and Arbor Center for Eye Care, S. C. (the Company) who have completed one year of service and are age 21 or older. Participation is not permitted for union employees or nonresident aliens. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan.

In January 2022, \$490,013 was transferred into the plan from the Chicago Eye Institute Cash or Deferred Profit Sharing Plan and Trust.

During 2022, SCP Eye Care Services, LLC dba EyeSouth Partners purchased Ocular Partners, Inc. and replaced Ocular Partners, Inc. as Plan Sponsor. Effective January 1, 2023, the employees of the Company became employees of SCP Eye Care Services, LLC dba EyeSouth Partner, therefore ceasing contributions to the Ocular Partners, Inc. 401(k) Plan. Effective June 1, 2023 the Ocular Partners, Inc. 401(k) Plan was merged into the EyeSouth Partners 401(k) Plan. The following notes concern the Plan prior to the merger into the EyeSouth Partners 401(k) Plan.

Contributions

Participants could contribute up to 100% of their compensation through pre-tax or Roth contributions, as defined in the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants directed the investment of their contributions into various investment options offered by the Plan.

The Company made safe harbor nonelective contributions equal to 100% of the first 3% of eligible compensation. During the period ended June 1, 2023 and the year ended December 31, 2022, safe harbor nonelective contributions were \$-0- and \$269,705, respectively. Additional discretionary nonelective contributions may be contributed at the option of the Company. During the period ended June 1, 2023 and the year ended December 31, 2022, the Company did not make any discretionary nonelective contributions. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts

Each participant's account was credited with the participant's contributions and Company safe harbor nonelective contributions, as well as allocations of the Company's discretionary nonelective contribution and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants were vested immediately in their contributions and safe harbor nonelective contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contributions portion of their accounts was based on years of continuous service. A participant was 100% vested after six years of credited service.

Notes receivable from participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans were secured by the balance in the participant's account. The note's interest rate, was set at 1% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of benefits

Distributions are payable upon termination of employment, death, disability, or retirement. Participants may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or partial withdrawals or installments. Participants could also make withdrawals of vested account balances prior to termination upon attainment of age 59½, early retirement, or in the event of financial hardship, as defined by the plan.

Forfeited accounts

At June 1, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$-0-. Forfeited accounts could be used to reduce future Company contributions. During the period ended June 1, 2023 and December 31, 2022, no forfeitures were used to reduce Company contributions.

2. SUMMARY OF ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2022.

Payment of benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Fees related to the administration of notes receivable from participants or other participant directed transactions were charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through June 17, 2024, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of June 1, 2023 and December 31, 2022 and the supplemental schedule of assets (held at end of year) as of December 31, 2022 and the related investment activity reflected in the statements of changes in net assets available for benefits for the period ended June 1, 2023 and the year ended December 31, 2022.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2022.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Certain Plan investments are managed by Charles Schwab Trust Bank, the trustee of the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the plan's operations.

6. TAX STATUS:

The Plan operated under a pre-approved plan document which received a favorable opinion letter from the IRS dated June 30, 2020. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has since been amended. While the Plan has not obtained its own determination letter on the Plan, management believes that the Plan is designed and was operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
