Opinion

We have audited the accompanying financial statements of Oscar W Larson Company Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of March 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended March 31, 2023, and the related notes to the financial statements.

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

NOTE A - Description of Plan:

The following brief description of the Oscar W Larson Company Profit Sharing Plan ("the Plan") is provided as general information purposes only. Participants should refer to the Plan agreement for more complete information.

1. **General** - The Plan is a defined contribution profit sharing plan covering full-time employees of the Oscar W Larson Company ("Company") who have one year of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. **Contributions** - Each year, a discretionary amount out of the Company's current or accumulated net profits, if any, may be contributed at the option of the Company's owners and are invested in a portfolio of investments as directed by the Company. Contributions are subject to certain limitations.
3. **Payment of Benefits** - On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
4. **Participant Accounts** - Each participant's account is credited with an allocation of (a) the Company's discretionary contribution, (b) Plan earnings (losses), (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on compensation, participant earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
5. **Vesting** - Vesting in the Company contributions portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100 percent vested after six years of credited service.
6. **Forfeited Accounts** - For the year ended March 31, 2023, forfeited nonvested accounts totaled \$91,891.93. This balance was transferred to The Oscar W. Larson 401(k) Plan (see Note D). These accounts will be used for Plan fees with the remainder reallocated to participants in the same manner as employer contributions.

NOTE B - Summary of Significant Accounting Policies:

1. **Basis of Accounting** - The accounting records of the Plan are maintained on the accrual basis of accounting.
2. **Investment Valuation and Income Recognition** - The Plan's mutual fund investments are stated at fair value and are nonparticipant-directed. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's fair value of surrender value of participant life insurance policies is based on current cash value. The Plan administrator determines the Plan's valuation policies. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. **Use of Estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
4. **Administrative Expenses** - Certain administrative expenses of the Plan are paid directly by the Company and are therefore excluded from these financial statements.
5. **Subsequent Events** - Subsequent events were evaluated through June 12, 2024, which is the date the financial statements were available to be issued.

NOTE B - Summary of Significant Accounting Policies (continued):

6. **Payment of Benefits** - Benefits are recorded when paid.
7. **Recent Accounting Pronouncement** - In August 2018, the FASB issued Accounting Standards Update ("ASU") 2018-13, *Fair Value Measurement (Topic 820): Disclosure Framework-Changes to the Disclosure Requirements for Fair Value Measurement*, which modifies the disclosure requirements for fair value measurement by removing, modifying, or adding certain disclosures. ASU 2018-13 is effective for all entities for fiscal years, and interim periods within those fiscal years, beginning after December 15, 2019. The Plan has adopted ASU 2018-13 for the Plan year ending March 31, 2022 with no impact on the Plan's net assets or changes in net assets.

NOTE C - Funding Policy:

The Company will pay to the Plan its contribution to the Plan for each Plan year within the time prescribed by the law, including extensions of time, for the filing of the Employer's federal income tax return for the fiscal year.

NOTE D - Plan Termination:

The Plan has been merged with The Oscar W. Larson Company 401(k) Plan. The Company adopted an amendment to terminate/merge the Plan, effective January 10, 2023. As of this date, no further contributions are permitted. All assets have been distributed or transferred by March 31, 2023. As of the date of this audit report, no assets exist in the Plan.

NOTE E - Fair Value Measurements:

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 inputs for the periods presented.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Life Insurance Policies: The fair value of the surrender value of life insurance policies is based on current cash value. Current cash value includes the value of any dividend additions or accumulations and is net of any outstanding policy indebtedness. The policies held with Northwestern Mutual are not actively traded and significant other observable inputs are not available. The fair value is determined by and based on amounts provided by Northwestern Mutual. These amounts would be used by market participants in pricing the asset in a current transaction, including assumptions about risk.

NOTE E - Fair Value Measurements (continued):

The preceding methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value measurement at the reporting date.

NOTE F - Related-Party/ Party-in-Interest Transactions:

Certain Plan investments are shares of mutual funds managed by Fidelity Investments. Fidelity Investments is the custodian as defined by the Plan. Other Plan investments include surrender value of participant life insurance policies offered by Northwestern Mutual. Northwestern Mutual is the custodian as defined by the Plan. Janz & Knight, PLC is the Plan auditor. Transactions with these service providers qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE G - Tax Status:

The pre-approved Plan provider has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated pre-approved Plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The plan administrator timely adopted the pre-approved Plan. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is currently being operated in accordance with the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE H - Risks and Uncertainties:

The Plan provides for various investment options. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I - Plan Amendments During Reporting Period:

Effective January 10, 2023, the Plan was amended to freeze and terminate. A resolution was adopted to merge the Plan with The Oscar W. Larson 401(k) Plan.

With this amendment, the Employer has adopted all relevant interim amendments needed to reflect the Plan qualification requirements effective as of the date of Plan termination.



IRS announces tax relief for taxpayers impacted by severe storms, tornadoes and flooding in Michigan

MI-2024-01, Feb. 16, 2024

WASHINGTON — The Internal Revenue Service announced today tax relief for individuals and businesses in parts of Michigan affected by severe storms, tornadoes and flooding that began on Aug. 24, 2023. These taxpayers now have until June 17, 2024, to file various federal individual and business tax returns and make tax payments.

Following the disaster declaration issued by the Federal Emergency Management Agency (FEMA) [↗](#), individuals and households that reside or have a business in Eaton, Ingham, Ionia, Kent, Livingston, Macomb, Monroe, Oakland, and Wayne counties, qualify for tax relief. The declaration permits the IRS to postpone certain tax-filing and tax-payment deadlines for taxpayers who reside or have a business in the disaster area. For instance, certain deadlines falling on or after Aug. 24, 2023, and before June 17, 2024, are granted additional time to file.

As a result, affected individuals and businesses will have until June 17, 2024, to file returns and pay any taxes that were originally due during this period.

The June 17, 2024, deadline applies to individual income tax returns and payments normally due on April 15, 2024.

The tax relief also applies to quarterly estimated tax payments, normally due on Sept. 15, Jan. 16, and April 15, 2024. Penalties on payroll and excise tax deposits due on or after Aug. 24, 2023, and before Sept. 8, 2023, will be abated as long as the tax deposits are made by Sept. 8, 2023.

The June 17, 2024, deadline also applies to affected businesses:

- Quarterly payroll and excise tax returns normally due on Oct. 31, 2023, Jan. 31, 2024, and April 30, 2024.
- Calendar-year partnership and S corporations that had a valid tax-year 2022 extension that ran out on Sept. 15, 2023, or have a 2023 return normally due on March 15, 2024.
- Calendar-year corporations and fiduciaries that had a valid tax-year 2022 extension that ran out on Oct. 16, 2023, or have a 2023 return and payment normally due on April 15, 2024.
- Calendar-year tax-exempt organizations that had a valid tax-year 2022 extension that ran out on Nov. 15, 2023, or have a 2023 return normally due on May 15, 2024.

The IRS urges anyone who needs an additional tax-filing extension, beyond June 17, 2024, for their 2023 federal income tax return to request it electronically by April 15, 2024. Though a disaster-area taxpayer qualifies to request an extension between April 15, 2024, and June 17, 2024, a request filed during this period can only be submitted on paper. Whether requested electronically or on paper, the taxpayer will then have until Oct. 15, 2024, to file, though payments are still due on June 17, 2024. Visit [IRS.gov/extensions](https://www.irs.gov/extensions) for details.

If an affected taxpayer receives a late filing or late payment penalty notice from the IRS that has an original filing, payment or deposit due date that falls within the postponement period, the taxpayer should call the telephone number on the notice to have the IRS abate the penalty.

The IRS automatically identifies taxpayers located in the covered disaster area and applies filing and payment relief. But affected taxpayers who reside or have a business located outside the covered disaster area should call the IRS disaster hotline at 866-562-5227 to request this tax relief.

Covered disaster area

The Michigan Counties listed above constitutes a covered disaster area for purposes of Treas. Reg. §301.7508A-1(d)(2) and are entitled to the relief detailed below.

Affected taxpayers

Taxpayers considered to be affected taxpayers eligible for the postponement of time to file returns, pay taxes and perform other time-sensitive acts are those taxpayers listed in Treas. Reg. § 301.7508A-1(d)(1), and include individuals who live, and businesses (including tax-exempt organizations) whose principal place of business is located, in the covered disaster area. Taxpayers not in the covered disaster area, but whose records necessary to meet a deadline listed in Treas. Reg. § 301.7508A-1(c) are in the covered disaster area, are also entitled to relief. In addition, all relief workers affiliated with a recognized government or philanthropic organization assisting in the relief activities in the covered disaster area and any individual visiting the covered disaster area who was killed or injured as a result of the disaster are entitled to relief.

Under section 7508A, the IRS gives affected taxpayers until June 17, 2024, to file most tax returns (including individual, corporate, and estate and trust income tax returns; partnership returns, S corporation returns, and trust returns; estate, gift, and generation-skipping transfer tax returns; annual information returns of tax-exempt organizations; and employment and certain excise tax returns), that have either an original or extended due date occurring on or after Aug. 24, 2023, and before June 17, 2024, are granted additional time to file through June 17, 2024

Affected taxpayers that have an estimated income tax payment originally due on or after Aug. 24, 2023, are postponed through June 17, 2024, will not be subject to penalties for failure to pay estimated tax installments as long as such payments are paid on or before June 17, 2024.

The IRS also gives affected taxpayers until June 17, 2024, to perform other time-sensitive actions described in Treas. Reg. § 301.7508A-1(c)(1) and Rev. Proc. 2018-58, 2018-50 IRB 990 (December 10, 2018), that are due to be performed on or after Aug. 24, 2023, and before June 17, 2024, are granted additional time to file through June 17, 2024.

This relief also includes the filing of Form 5500 series returns that were required to be filed on or after Aug. 24, 2023, and before June 17, 2024, are postponed through June 17, 2024, in the manner described in section 8 of Rev. Proc. 2018-58. The relief described in section 17 of Rev. Proc. 2018-58, pertaining to like-kind exchanges of property, also applies to certain taxpayers who are not otherwise affected taxpayers and may include acts required to be performed before or after the period above.

Unless an act is specifically listed in Rev. Proc. 2018-58, the postponement of time to file and pay does not apply to information returns in the W-2, 1094, 1095, 1097, 1098 or 1099 series; to Forms 1042-S, 3921, 3922 or 8027; or to employment and excise tax deposits. However, penalties on deposits due on or after Aug. 24, 2023, and before Sept. 8, 2023, will be abated as long as the tax deposits were made by Sept. 8, 2023.

Casualty Losses

Affected taxpayers in a federally declared disaster area have the option of claiming disaster-related casualty losses on their federal income tax return for either the year in which the event occurred, or the prior year. Taxpayers choosing to claim their losses on their 2023 return have extra time, until Oct. 15, 2024, to make this election. See Publication 547 for details. Individuals may deduct personal property losses that are not covered by insurance or other reimbursements. For details, see Form 4684, Casualties and Thefts [PDF](#) and its instructions [PDF](#). Affected taxpayers claiming the disaster loss on their return should put FEMA disaster declaration number, 4757-DR on any return. See Publication 547 for details.

Other relief

The IRS will waive the usual fees and requests for copies of previously filed tax returns for affected taxpayers. Taxpayers should put the assigned FEMA declaration number (**4757-DR**), in bold letters at the top of Form 4506, Request for Copy of Tax Return [PDF](#), or Form 4506-T, Request for Transcript of Tax Return [PDF](#), as appropriate, and submit it to the IRS.

Qualified disaster relief payments are generally excluded from gross income. This means that affected taxpayers can exclude from their gross income amounts received from a government agency for reasonable and necessary personal, family, living or funeral expenses, as well as for the repair or rehabilitation of their

home, or for the repair or replacement of its contents. See Publication 525 for details.

Additional relief may be available to affected taxpayers who participate in a retirement plan or individual retirement arrangement (IRA). For example, a taxpayer may be eligible to take a special disaster distribution that would not be subject to the additional 10% early distribution tax and allows the taxpayer to spread the income over three years. Taxpayers may also be eligible to make a hardship withdrawal. Each plan or IRA has specific rules and guidance for their participants to follow.

The IRS may provide additional disaster relief in the future.

Affected taxpayers who are contacted by the IRS on a collection or examination matter should explain how the disaster impacts them so that the IRS can provide appropriate consideration to their case. Taxpayers may download forms and publications from the official IRS website, [IRS.gov](https://www.irs.gov).
