### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of H Enterprises 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 27, 2023 (liquidation) and December 31, 2022 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through December 27, 2023 and year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of H Enterprises 401(k) Plan's Financial Statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the period from January 1, 2023 through December 27, 2023 and the year ended December 31, 2022, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the financial statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to benefits provided under the Plan or assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the financial statements section of our report. We are required to be independent of H Enterprises 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements were prepared on the modified cash basis of accounting for the year ended December 31, 2022, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### ***Emphasis of Matter - Termination Plan and Liquidation Basis of Accounting***

As further discussed in Note 1 to the financial statements, the Plan was terminated effective March 17, 2023. As a result, the Plan changed its basis of accounting from going concern basis of accounting used in presenting the 2022 financial statements to the liquidation basis of accounting in presenting the period from January 1, 2023 through December 27, 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about H Enterprises 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## H Enterprises 401(k) Plan Notes to Financial Statements

### NOTE 1 - DESCRIPTION OF PLAN

The following description of the H Enterprises 401(k) Plan (the "Plan") is not a comprehensive description of the Plan and, therefore, does not include all situations and limitations covered by the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General and Eligibility**

The Plan is a defined contribution plan available to develop benefits for eligible employees of H Enterprises International, Inc. ("the Company") and its subsidiary; Manhattan Group, LLC; (together with the Company, the "Participating Employers"), during their working careers to be available to them after their retirement (or for limited purposes, before retirement) or to their beneficiaries at death.

The Plan was established on May 1, 1990. The Plan was last amended effective March 17, 2023, as part of the Plan Termination. This amendment formally adopted provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE"), SECURE 2.0, and the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act").

An employee, subject to a collective bargaining agreement, is eligible to participate in the Plan after completion of one year of service and attaining 1,000 hours. An employee, not subject to a collective bargaining agreement, is eligible to participate in the Plan on their first day of service. Employees are eligible to receive employer fixed contributions beginning January 1, April 1, July 1, or October 1 after completing one year of service and attaining 1,000 hours. Employees must be employed as of the last day of the Plan year to receive employer contributions.

#### **Plan Termination**

During 2023, Plan participants were notified that the Plan would be terminated effective March 17, 2023, and contributions to the Plan would cease and all assets would be distributed as soon as administratively possible, due to the sale of the Company. All participants became fully vested upon termination. Distributions from the Plan, including residual dividends and appreciation occurred through December 27, 2023.

#### **Plan Operations**

The Company functions as the plan sponsor. John Hancock Trust Company LLC was designated as trustee, record keeper, administrator, and asset custodian of the Plan (collectively referred to as the "Trustee").

#### **Contributions**

Eligible employees may elect to contribute up to 75% (up to 25% for highly compensated and up to 75% non-highly compensated participants) of pre-tax compensation, as defined by the Plan, not to exceed the Internal Revenue Service's (IRS) annual limitations. Employees who fail to make a participant deferral election are automatically enrolled in the Plan and shall be considered as having made an election to contribute 6% of eligible compensation. In addition, if the participant's elective deferral is less than 6%, then at the beginning of the subsequent Plan year the deferral will be increased to 6%. If the Participant's elective deferral is less than 12%, at the beginning of the subsequent Plan year the elective deferral will be increased 1%. If the participant's elective deferral is 12% or higher no adjustment will be made.

## **H Enterprises 401(k) Plan Notes to Financial Statements**

### **NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)**

#### **Contributions (Continued)**

Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions under IRS regulations. Participants may also rollover amounts representing distributions from other qualified plans into the Plan.

Participating Employers make a fixed employer contribution equal to the greater of \$26 per week of service, as defined by the Plan, or 4% of eligible compensation. The Participating Employers made required cash contributions during the period from January 1, 2023 through March 17, 2023 and for the year ended December 31, 2022.

The Company may also make a match of participant contributions equal to 50% of the first 6% of each participant's eligible compensation for the Plan year. These contributions are based upon each Participating Employer's financial performance. During the period from January 1, 2023 through March 17, 2023 and the year ended December 31, 2022, the Company made match contributions to the eligible employees of H Enterprises International, Inc.

In addition, the Company may also make a discretionary match of participant contributions up to 80% of the first 6% of each participant's compensation for the Plan year. These contributions are based upon each Participating Employer's financial performance and are at the discretion of the Participating Employers' Board of Directors or managers. During the period from January 1, 2023 through March 17, 2023 and the year ended December 31, 2022, the Company made discretionary match contributions to the eligible employees of H Enterprises International, Inc.

Participant and employer contributions are recorded by the Plan in the period received by the Trustee.

#### **Participant Accounts**

The allocation of participant contributions to the investment fund options is made by the participant in whole percent increments and may be changed at any time. Contributions may be allocated entirely to one fund or a combination of funds. Employer contributions are allocated among the investment funds in the same manner as participant contributions. Each participant's account is credited with the participant's and Participating Employer's contributions and an allocation of Plan earnings. Plan earnings are allocated to participant accounts in the proportion that each participant's account balance bears to the total of all participant accounts by fund. The benefit to which a participant is entitled is subject to vesting provisions.

#### **Investment Options**

All assets of the Plan are participant-directed and are held in various accounts and funds, as defined in the Plan summary. The Plan allows participants to direct their investments and to make transfers between these accounts and funds daily.

## H Enterprises 401(k) Plan Notes to Financial Statements

### NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

#### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Participating Employer's fixed and additional discretionary contributions, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service, based on the following percentages:

If a participant reaches the age of 65, dies, or becomes disabled while still employed by the Participating Employers, their entire plan account balance will become 100% vested.

#### Forfeited Accounts

Forfeitures of non-vested account balances result from participants who withdraw from the Plan before becoming fully vested in employer contributions and earnings thereon. Forfeited non-vested accounts are used to reimburse Plan expenses and reduce future employer contributions. Forfeitures used to reimburse Plan expenses amounted to \$5,473 and \$0 for the period ended December 27, 2023, and the year ended December 31, 2022, respectively. Forfeitures used to offset employer contributions amounted to \$2,543 and \$0 for the period ended December 27, 2023, and the year ended December 31, 2022, respectively. There were \$0 and \$7,921 in forfeitures available for utilization as of December 27, 2023, and December 31, 2022, respectively.

#### Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be repaid in five years or within 20 years if used for the purpose of a primary residence. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus one-half percent. Principal and interest for active participants are repaid through payroll deductions. If note payments by participants are delinquent, they are considered a deemed distribution in the Plan year they are delinquent.

#### Distribution of Benefits

Distributions are generally made upon termination of employment, retirement, or disability. Distributions are based upon the value of participant account balances when benefits are withdrawn and are paid in a lump sum distribution for the entire vested account balance, or a portion of the vested account balance upon participant election. If the vested account is less than \$1,000, the balance is paid in a lump sum distribution as soon as administratively possible. If the vested account balance is greater than \$1,000 but does not exceed \$5,000, incurs an event of maturity, or the participant fails to make an application for distribution in a single lump sum as soon as administratively possible, then the vested total account balance is automatically rolled over into an Individual Retirement Account as soon as administratively possible. The rollover shall be completed in accordance with the regulations issued by the Department of Labor (DOL). Distributions may be made earlier for hardship reasons in accordance with IRS regulations.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### **Basis of Accounting**

The financial statements of the Plan have been prepared under the liquidation basis of accounting for the period ended December 27, 2023, and ongoing basis of accounting for the year ended December 31, 2022.

The Plan's financial statements are presented on a modified cash basis of accounting. Income is reflected in the year received; contributions in the year received; payments and expenses in the year paid. The modified cash basis is a departure from accounting principles generally accepted in the United States of America, but allowed by the DOL.

If the Plan's financial statements were prepared in accordance with accounting principles generally accepted in the United States of America, the Plan's statements of net assets available for benefits would disclose employee contributions receivable of \$0 for the Plan period ending December 27, 2023 and for the year ended December 31, 2022, and employer contributions receivable of \$0 and \$206,773 for the Plan period ending December 27, 2023 and for the year ended December 31, 2022, respectively. For the Plan period ending December 27, 2023 and for the year ended December 31, 2022, the Plan's statements of changes in net assets available for benefits would disclose participant elective deferral contributions of \$0 and \$402,734, and employer contributions of \$0 and \$206,773, respectively.

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### **Investment Valuation and Income (Loss) Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for specific disclosures of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the date received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Net Appreciation (Depreciation) in Fair Value of Investments**

Net appreciation (depreciation) in the fair value of investments represents the net realized gains and losses plus the net unrealized appreciation or depreciation on investments. Realized gains and losses are the difference between the proceeds and either the cost of investments sold determined on an average cost basis, or fair value at the end of the previous year, whichever is applicable. Unrealized appreciation or depreciation is the change in the difference between fair value and the cost of investments or the fair value at the end of the previous year, whichever is applicable.

### NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2022. The Plan assets were \$0 as of December 27, 2023.

#### Benefits Paid to Participants

Benefits are recorded when paid.

#### Funding Policy

Employer contributions are remitted to the Plan generally in March following the end of the Plan year.

#### Plan Expenses

Certain administrative expenses of the Plan are paid by the Company. The Company may receive reimbursement of qualified Plan expenses from forfeited accounts. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participants account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

### NOTE 3 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022. The Plan assets were \$0 as of December 27, 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trusts:* Valued at the NAV as a practical expedient to fair value based on the fair value of the underlying investment at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 3 - FAIR VALUE MEASUREMENTS (CONTINUED)

To assess the reasonableness of the fair value methodology used for the collective trusts, Plan management evaluates a variety of factors including review of the fund's financial statements, economic conditions, industry and market developments, and overall credit ratings.

The following are instances when the redemption of the collective trust's assets may not occur at fair value:

- Material amendments to the Fund's structure or administration.
- Changes to investment options including the elimination of equity wash provisions.
- Complete or partial termination of the collective trust, including a merger with another fund.
- The failure of the collective trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Redemption of all or a portion of the interests in the collective trust by the Plan in conjunction with a group layoff, sale of a business unit, bankruptcy, plan merger or other major restructuring event by the Plan.
- Changes in law, regulation, ruling, administrative or judicial position or accounting standard.
- Communication to participants designed to influence participants to not invest in the collective trust.

Plan management believes the occurrence of events and circumstances that would cause the collective trusts to transact at less than fair value for the Plan is not probable.

### NOTE 4 - CERTIFICATIONS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 27, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2023 through December 27, 2023, and the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company LLC (the trustee of the Plan). The Plan assets were \$0 as of December 27, 2023.

### NOTE 5 - TAX STATUS

The IRS has determined and informed the Company by a letter dated June 20, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

### **NOTE 5 - TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that for the period from January 1, 2023 through December 27, 2023 and for the year ended December 31, 2022, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 6 - RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS**

The Company has been designated as the plan administrator and plan sponsor. Certain employees provide administrative services to the Plan. These services are provided at no cost to the Plan. Notes receivable from participants qualify as party in interest transactions.

### **NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE 8 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through June 13, 2024, the date the financial statements were available to be issued.
