

To whom it may concern, we had received a letter from PayChex informing us that we needed to file our Form 5500 with the U.S. Department of Labor (DOL) back in April 2024. We called Paychex and they helped us with the forms we needed to submit. We went to the U.S. Department of Labor EFAST website and created the forms needed and I thought they were submitted but we got another letter saying that these forms needed to be filed. So after double checking the submittal it showed it was not submitted and there was an error code. We apparently had put the wrong business code of which we have now fixed and are ready to submit with the help of EFAST. There was also another error code which he informed me that there may be a late fee that we may owe.

I am requesting that any late fees, if any, be waived due to our lack of knowledge with the request of Form 5500 that needed to be submitted and also not understanding the EFAST website on how to submit. In all the years we were with Paychex we did not have to submit this Form 5500 because they did it for us, but apparently now that we have canceled business with them we are required to do it ourselves which we were unaware of.
