Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of iPass 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 22, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period then ended December 22, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 22, 2023 and December 31, 2022 and for the period ended December 22, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the iPass 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan was established on April 15, 1997 as a defined contribution plan to provide eligible employees of iPass Inc. (the “Company” or the “Plan Sponsor”) with retirement, death and disability benefits. Effective May 17, 2021, the Pareteum 401(k) Plan (the “Pareteum Plan”) was merged into the Plan. On May 25, 2021, the Pareteum Plan’s assets were transferred to the Plan and were recorded at fair value as of the day of the transfer, as measured by quoted market prices. On September 9, 2022, the Plan was terminated. The Plan’s assets were fully distributed on or before December 22, 2023. See Note 6. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(k) of the Internal Revenue Code (IRC).

Participant Eligibility, Contributions and Vesting - All employees at or over age 19 are eligible to participate in the Plan except the following classes: (a) leased employees and (b) residents of Puerto Rico. Participants may begin deferring a portion of their compensation into the Plan on the first day following eligibility. The Plan also allows participants to designate contributions as Roth 401(k) contributions. Contributions to the Plan are limited to the maximum amount allowable under the provisions of the IRC.

The Plan provides 401(k) matching of participant contributions as approved by the Board of Directors. For the period ended December 22, 2023, the Plan Sponsor did not make matching contributions due to plan termination. See Note 6.

Additionally, the Plan permits discretionary employer contributions allocated to each participant according to the ratio of the participant’s compensation to the ratio of all participants for the Plan year. For the period ended December 22, 2023, the Company did not make profit-sharing contributions due to plan termination. See Note 6.

Prior to the Plan’s termination on September 9, 2022, the Company contributions vest according to the employee’s years of service, as follows:

Participants have become fully vested in their accounts after the Plan was terminated. For the period ended December 22, 2023, \$72,943 of forfeitures were used. As of December 22, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$70,665, respectively.

Investment Options - Participants exercise control over the types of investments made on their behalf, provided that such accounts are invested in investment funds designated by the Plan. Participants may invest in any one or more investment funds and change their investment options at any time.

Payment of Benefits - In the case of normal retirement (age 65), early retirement, retirement due to permanent disability or termination of employment, participants may elect to receive the value of their vested individual account balances, in accordance with the provisions of the Plan, either in lump-sum distribution or in an alternative manner available under the Plan.

Participants who separate from service and have vested account balances of \$1,000 or less are subject to an administrative lump-sum distribution at the discretion of the plan administrator. Participants who separate from service and have vested account balances of \$5,000 or less are subject to an automatic distribution at the discretion of the plan administrator. Mandatory distributions of separated participants' vested balances between \$1,000 and \$5,000 are subject to a direct rollover of their balance into an Individual Retirement Account (IRA) designated by the plan administrator in the name of the separated participant.

Notes Receivable from Participants - Subject to Internal Revenue Service (IRS) regulations and limitations, participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. Such loans bear interest at prime rate plus 1% and are generally repayable in terms of up to 5 years, except for home mortgage loans which are determined by the Plan Sponsor. All loans are secured by the participants' account balances. As of December 22, 2023, all notes receivable have been repaid and there is no outstanding balance receivable.

Participant Accounts - Each participant's account is credited with the employee's payroll contributions, the employer's contributions, and Plan earnings and losses. Allocations to participants' accounts are based on participant compensation or account balances in accordance with the provisions of the Plan.

Administration - The Plan Sponsor is the plan administrator. The Plan's assets are managed by Fidelity Management Trust Company (Fidelity), the trustee of the Plan. The trustee, appointed by the Plan Sponsor, executes investment transactions and holds Plan investment assets. The plan administrator reviews the performance of the various available investments and makes decisions on the addition or deletion of an investment fund.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America. Contributions from participants are recorded when withheld. Benefit payments and expenses are recorded when paid.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for various investment securities. These securities are exposed to various risks such as interest rate, market fluctuations and credit risks. Further, due to the level of risk associated with these securities and the level of uncertainty related to changes in the values of investment securities, it is possible that changes in the various risk factors in the near term would materially affect the participants' account balances and the amounts reported in the accompanying financial statements.

Valuation of Investments - Investments in interest-bearing cash and mutual funds are stated at fair value determined by quoted market prices. The investment in the common/collective trust that invests in a fully benefit-responsive investment contract is valued at contract value. Purchases and sales of investments are recorded on a trade-date basis. Net change in fair value of investments consists of the change in unrealized appreciation or depreciation during the year and the realized gain or loss of sold investments during the year. Acquisition costs are included in the cost of investments and sales are recorded net of selling expenses.

Administrative Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

Subsequent Events - Subsequent events were evaluated through June 6, 2024, the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

Generally accepted accounting principles establish a hierarchy to prioritize the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest ranking to fair values determined using unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest ranking to fair values determined using methodologies and models with unobservable inputs (Level 3). Observable inputs are those that market participants would use in pricing the assets based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan's assumption about the inputs market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The fair value hierarchy is categorized into three levels based on the inputs as follows:

Level 1 – Values are unadjusted quoted prices for identical assets or liabilities in active markets accessible at the measurement date.

Level 2 – Inputs included in quoted prices for similar assets or liabilities in active markets, quoted prices from those willing to trade in markets that are not active, or other inputs that are observable or can be corroborated by market data for the term of the instrument. Such inputs include market interest rates and volatilities, spreads and yield curves.

Level 3 – Certain inputs are unobservable (supported by little or no market activity) and significant to the fair value measurement. Unobservable inputs reflect the Plan's best estimate of what hypothetical market participants would use to determine a transaction price for the asset or liability at the reporting date.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 22, 2023 and December 31, 2022.

Interest-bearing cash: Valued at the closing price at year end.

Mutual funds: Valued at the net asset value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - TAX STATUS

The Plan adopted a prototype non-standardized 401(k) profit sharing plan with cash or deferral arrangement and has received a favorable opinion letter from the IRS, which states that the Plan is designed in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan's tax filings are subject to audit by various taxing authorities.

NOTE 6 - PLAN TERMINATION AND MODIFICATION

The Plan Sponsor had intended to continue the Plan indefinitely for the benefit of its employees, however, pursuant to the terms of the Plan, it reserved the right to terminate and/or modify the Plan at any time by resolution of its Board of Directors and subject to the provision of ERISA. In connection with the Bankruptcy Case (as defined below), the Plan was terminated on September 9, 2022, as described in more detail below.

The Plan Sponsor, along with several of its affiliates, including but not limited to its parent company, Pareteum Corporation (collectively, with the Plan Sponsor, the “Debtors”), filed voluntary petitions under chapter 11 of the United States Bankruptcy Code in the United States Bankruptcy Court for the Southern District of New York (the “Bankruptcy Court”) on May 15, 2022, jointly administered under the caption “In re: Pareteum Corporation, et al.,” under Case No. 22-10615 (LGB) (the “Bankruptcy Case”). On June 30, 2022, the Bankruptcy Court entered an order (the “Sale Order”) approving an asset purchase agreement authorizing the sale of substantially all of the Debtors’ legacy business operations (the “Asset Sale”). The Asset Sale closed on July 11, 2022 (the “Closing Date”), and pursuant to the Asset Sale, (i) the Debtors officially ceased operating as on-going businesses and substantially all assets, certain liabilities, and all of the Debtors’ personnel were transferred to the Buyers (as defined in the Sale Order); (ii) all of the Debtors’ personnel comprising either the legacy “Board of Directors,” “Management,” and “Employees” were terminated or transferred to the Buyers; (iii) Saccullo Business Consulting, LLC (SBC), by and through Mr. Anthony M. Saccullo was appointed to serve as the Wind Down Officer responsible for managing the Bankruptcy Case and the Debtors after the Closing Date. On September 9, 2022, Mr. Saccullo, as the sole remaining director of the board of debtors by written resolution ratified the termination of the Plan. Participants have become fully vested in their accounts. On October 7, 2022, the Bankruptcy Court entered an order (the “Confirmation Order”) confirming the Debtors’ plan of liquidation (the “Liquidation Plan”), which became effective on October 21, 2022 (the “Effective Date”). Pursuant to the Liquidation Plan and the Confirmation Order, the TEUM Liquidating Trust was established and SBC, by and through Mr. Saccullo, was appointed to serve as the Liquidating Trustee of the TEUM Liquidating Trust to oversee the remainder of the Bankruptcy Case, including but not limited to, the wind down and termination of the Plan. The Plan’s assets were fully distributed on or before December 22, 2023.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity, the trustee of the Plan. Any purchases and sales of these funds are performed in the open market at fair value or contract value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

NOTE 9 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan's investment in the Fidelity Advisor Stable Value Fund is fully benefit-responsive. The fully benefit-responsive investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the Fidelity Advisor Stable Value Fund is fully benefit-responsive, contract value is the relevant measurement and presented on the face of the statement of net assets available for benefits. Contract value, as reported to the Plan by Fidelity, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption under ERISA. The Plan administrator has not experienced difficulties related to the Plan's ability to transact at contract value with participants.
