### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Backstop Solutions 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of April 20, 2023 (see Note 1) and December 31, 2022, and the related statement of changes in net assets available for benefits for the period January 1, 2023 through April 20, 2023 and the year ended December 31, 2022, and the related notes to the financial statements.

**Note 1 DESCRIPTION OF PLAN**

The following description of the Backstop Solutions 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of Backstop Solutions Group, LLC (the “Plan Sponsor”), who have completed thirty days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Plan Termination**

In December 2021, the Plan Sponsor was acquired by ION Trading Technologies Limited. In January 2023, the Plan communicated to Principal Financial Group that the plan was being terminated effective January 1, 2023. The assets were transferred from Principal to the new Plan administrator on January 31, 2023 merging into ION Trading, Inc. 401(K) Plan. There was residual activity through April 20, 2023 which is effectively the final period end of the Plan.

**Plan Administration**

The Plan is administered by the Administrative Committee. Principal Trust Company (“Principal” or the “Trustee”) is responsible for the custody, recordkeeping, and management of the Plan’s assets.

**Contributions**

*Participant Contributions*

Eligible employees could contribute up to 100% of pre-tax or post-tax annual compensation in 2022, as defined in the Plan. Contributions were made through payroll deductions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e., rollover contributions). Participants who have attained age 50 before the end of the plan year were eligible to make tax-deferred catch-up contributions.

*Matching Contributions*

Matching contributions, if any, were allocated in proportion to the amount of pay each participant defers, up to 100% of the first 3% of base compensation. Matching contributions were determined each payroll period. Matching contributions were limited to \$5,000 per year. Discretionary contributions and non-elective contributions were not allowed under this Plan.

*Automatic Enrollment*

Employees were automatically enrolled in the Plan at a 5% tax-deferred rate when they became eligible for participation. These contributions were invested in the Plan’s default investment option. The contribution rate was set to automatically increase 1% each plan year until the deferral rate reached 10%. Employees could have elected to opt out of the automatic enrollment, stopped contributions, and modified their contribution rate or investment selections at any time.

**Participant Accounts**

Each participant’s account was funded with the participant’s contributions and allocations of the Plan Sponsor’s contributions, if any, and allocations of Plan earnings or losses. Allocations were based on participant account balances, as defined by the Plan. Participants were entitled to the vested portion of their account.

**Note 1 DESCRIPTION OF PLAN (continued)**

**Vesting**

Participants were immediately vested in their contributions and earnings thereon. Participants were immediately vested in their portion of the Plan Sponsor's matching contributions, plus actual earnings thereon.

**Participant Loans**

Participants could have borrowed from their accounts a minimum of \$500 and a maximum of the lesser of \$50,000 or 50% of their vested account balance. These loans may be used for a maximum of five years. Loans made for a purchase of a primary residence had a term consistent with commercial home loan practices. The loans were secured by the balance in the participant's account and bore interest at 2% above the prime rate, fixed at the time of the loan, as defined. Principal and interest were repaid through payroll deductions.

**Investment Options**

Plan investments were participant directed. Upon enrollment in the Plan, a participant may direct contributions in any of the then available investment fund options. Participants may change or transfer their investment options at any time via telephone or a secure internet website.

**Payment of Benefits**

Vested account balances would be payable upon retirement, death or disability, or termination of employment. In-service distributions were also permitted after meeting certain requirements in accordance with Plan provisions. Distributions could have been made in a lump sum payment, a series of installment payments, or partial payments. If an employee terminates employment, the Plan could make distributions of vested participant accounts below \$5,000.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts were used to reduce future Plan Sponsor contributions or plan expenses. Forfeited amounts at April 20, 2023 and December 31, 2022 totaled \$0 and \$0, respectively. For the period ended April 20, 2023 and the year ended December 31, 2022, matching contributions were reduced by \$0 and \$2,499, respectively, from forfeited non-vested accounts.

**Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The Plan's financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP"). Certain prior year amounts in the financial statements and notes thereto have been reclassified to conform to the current year's presentation.

**Management Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

**Note 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Investment Valuation and Income Recognition**

Investments are reported at fair value (see Note 3). Purchases and sales of securities are recorded on a trade date basis. Interest income and dividends are recorded when received. Net appreciation/(depreciation) includes the Plan's realized gains and losses on investments bought and sold, and held at year-end. Investment contracts held by a defined contribution plan are required to be reported at fair value.

**Benefit Payments and Distributions**

Benefits and distributions are recorded when paid.

**Participant Loans**

Notes receivable from participants are measured at their unpaid principal balance plus accrued interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of April 20, 2023 and December 31, 2022. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

**Operating Expenses**

Certain expenses incurred maintaining the Plan are paid directly by the Plan Sponsor and excluded from these financial statements. Investment-related expenses are included in net investment gain/(loss) of investments. Certain participant services and recordkeeping fees are charged to the participants' account.

**Note 3 FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board ("FASB") Accounting Standards Codification Section ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Note 3 FAIR VALUE MEASUREMENT (continued)**

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques must maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at April 20, 2023 and December 31, 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust Funds:* Valued at the net asset value (“NAV”) of units of a collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the readily determinable fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 4 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are collective investment trusts or a stable value fund managed by Principal. Principal is the custodian and Trustee of the Plan for the period ended April 20, 2023 and year ended December 31, 2022 and, therefore, transactions qualify as party-in-interest transactions. Fees paid by the Plan for loan administration services totaled \$0 and \$825 for the period ended April 20, 2023 and year ended December 31, 2022, respectively. Participant loans also qualify as party-in-interest transactions.

**Note 5 PLAN TERMINATION**

The Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA, which it did as a result of the Plan Sponsor's sale of the company. Participants remained 100% vested in their employer contribution accounts.

**Note 6 TAX STATUS**

The Internal Revenue Service ("IRS") has determined and informed Backstop Solutions Group by a letter dated August 8, 2014, that the Plan and related trust, as then designed, were in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

**Note 7 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
