We are the Court Appointed Accountants to Don Beskrone, Esq., the Chapter 7 Bankruptcy Trustee of JC USA Inc. (the “Debtor”, Bankruptcy Case #23-10585), the Plan Sponsor of the Jenny Craig Employee Health Care Plan. The Debtor filed for protection under Chapter 7 of the United States Bankruptcy Code on May 5, 2023, at which time all operations ceased and Don Beskrone, Esq. was appointed as the Chapter 7 Trustee (“Trustee”).

As a result of the Chapter 7 bankruptcy proceeding, and pursuant to 11 U.S.C. Sect. 704(11), the Trustee is responsible for the liquidation of the Plan Assets of the Jenny Craig Employee Health Care Plan (“the Plan”).

The 2023 annual informational return was prepared by ERISA Comply aka Form 5500 Connect Inc., the Plan’s Consultant (the “Consultant”), from the best information available; that is, prior informational returns, Schedules A and B provided by insurance carriers, and some limited information from the Debtor’s former employees including activity from an account that the self-funded used to pay medical and dental claims. Due to the cessation of business and the filing of bankruptcy, certain key financial records, subsidiary ledgers and documentation supporting various policies, transactions, and other matters that would normally be expected to be present in an operating enterprise, were missing or unavailable. During 2023, the Plan paid the run-off of claims, ran out of funds and ceased providing benefits, and as such there are no longer any Participants in this Plan and this return is being filed as a Final return.

The period on this return through May 5, 2023 predates the appointment of the Trustee and his professionals. Neither the Trustee, nor the Trustee’s Court Appointed Accountants have any direct knowledge of the transactions recorded by the Consultant or the Debtor as reported on this return. In addition, the Trustee and his professionals have no knowledge of the processes used or policies put in place by the Consultant or the Debtor.

The Trustee, by his signature on the face of this informational return, has relied on the Consultant’s expertise in preparing the return from the available records, which were limited due to the entity’s cessation of business and lack of cooperation from the Debtor’s former personnel. However, it is our qualified opinion that this is a complete return based on the financial information available.
