Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 Financial Statements

We have performed an audit of the accompanying financial statements of Advanced Lifeline Services, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits – in liquidation as of March 24, 2023, and the related statement of changes in net assets available for benefits – in liquidation for the period from January 1, 2023 through March 24, 2023, and the related notes to the financial statements ("2023 financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the U.S. Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs to not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from John Hancock Life Insurance Company, a qualified institution, as of and for the period ended March 24, 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion on the 2023 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2023 Financial Statements section-

- the amounts and disclosures in the 2023 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the 2023 financial statements referred to above related to assets held by and certified to by John Hancock Life Insurance Company, the Custodian, agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2023 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2023 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter-Basis of Accounting

As discussed in Note B to the financial statements, the Board of Trustees approved a plan of termination effective December 31, 2022, and management determined liquidation was imminent. As a result, the Plan changed its basis of accounting from the accrual basis of accounting to the liquidation basis used in presenting the financial statements. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the 2023 Financial Statements

Management is responsible for the preparation and fair presentation of the 2023 financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of the 2023 financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the 2023 financial statements.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the 2023 financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2023 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2023 financial statements section of our report, our objectives are to obtain reasonable assurance about whether the 2023 financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the 2023 financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Auditors' Report on the 2022 Financial Statements

The financial statements of the Plan as of and for the year ended December 31, 2022, were audited by Strothman and Company, who merged with LBMC, PC as of November 1, 2023. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the audit did not extend to any statements or information related to assets held for investment of the Plan that were certified by a qualified institution. Their report dated September 26, 2023, indicated that in their opinion (a) the amount and disclosures in the 2022 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with GAAP, and (b) the information in the 2022 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Advanced Lifeline Services, Inc. 401(k) Plan

Note A--Description of Plan

The following brief description of the Advanced Lifeline Services, Inc. (the "Company") 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete description of the Plan's provisions.

Plan Termination--Effective December 31, 2022, the Plan was amended to terminate the Plan due to the closure of the Company. As a result, effective December 31, 2022, the Plan was frozen and the account balances of the Plan participants were liquidated effective March 24, 2023.

General--The Plan was a defined contribution retirement plan covering all full-time employees over the age of twenty-one that had completed three consecutive months of service. The Plan also covered part-time employees over the age of twenty-one that had completed three consecutive months of service and worked a minimum of 1,000 hours in the preceding year of employment. Entry dates for the Plan were January 1 and July 1 of each year. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan Administrator and Board of Trustees oversaw governance of the Plan, including the appropriateness of the Plan's investment offerings, and monitored investment performance.

An ESOP owns the Company. The ESOP participants voted on November 17, 2022, to close the Company, thereby closing the ESOP Plan. The operations of the Company ceased effective December 31, 2022. The ESOP is in the process of obtaining the approval from the Internal Revenue Service ("IRS") and the U.S. Department of Labor ("DOL") to close the ESOP Plan.

Contributions--Each year, participants could contribute up to maximum compensation permissible under the Internal Revenue Code ("IRC") in the form of pre-tax or after-tax Roth contributions to the Plan. Participants who had attained age 50 before the end of the Plan year were eligible to make additional catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan. The Plan offered various pooled separate accounts as investment options for participants. The Company could also make discretionary matching contributions to the Plan. Contributions were subject to certain statutory limitations.

Effective July 1, 2022, the Company discontinued the employer safe harbor matching contribution. Prior to July 1, 2022, the Company made safe harbor matching contributions equal to 100% of the participants' salary deferrals that did not exceed 3% of eligible compensation plus 50% of the salary deferrals between 3% and 5% of the participant's contributions.

Note A--Description of Plan--Continued

Participant Accounts--Each participant's account was credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations were based on participant earnings or account balances, as defined. The benefit to which a participant was entitled is the benefit that could be provided from the participant's vested account.

Vesting--Participants were immediately vested in their contributions, the Company's safe harbor contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contribution portion of their account was based on years of continuous service. A participant was 100% vested after six years of credited service.

Payment of Benefits--On termination of service or attaining normal retirement age, a participant could elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In-service and hardship withdrawals were also allowed as defined in the Plan agreement.

Forfeited Accounts--At March 24, 2023 and December 31, 2022, there were no forfeited nonvested accounts. Forfeited nonvested accounts could be used to offset safe harbor contributions, qualified nonelective contributions and qualified matching contributions. During 2022, employer contributions were reduced by \$14,124 from forfeited nonvested accounts.

Note B--Summary of Significant Accounting Policies

The Plan follows generally accepted accounting principles ("GAAP") as outlined in the Financial Accounting Standards Board's *Accounting Standards Codification*. Significant accounting policies are as follows:

Basis of Accounting--Upon the Company's decision to terminate the Plan and related trust effective December 31, 2022, the Plan changed its basis of accounting to the liquidation basis. This basis is used in presenting the March 24, 2023 and December 31, 2022 financial statements.

Use of Estimates--The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition--Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits--Benefits were recorded when paid.

Administrative Expenses--Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review of Subsequent Events--Subsequent events were evaluated through May 22, 2024, which is the date the financial statements were available to be issued.

Note C--Investments

Unaudited Information Certified by the Plan Custodian

The March 24, 2023 and December 31, 2022, statements of net assets available for benefits – in liquidation, the investment activities included on the statements of changes in net assets available for benefits – in liquidation for the period ended March 24, 2023 and the year ended December 31, 2022, and the accompanying notes to the financial statements were prepared in part or entirely from information certified by the Custodian, John Hancock Life Insurance Company, in accordance with 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The information certified includes total investments of \$0 and \$3,364,869 at March 24, 2023 and December 31, 2022, respectively, and related net appreciation (depreciation) in fair value of investments, including investment income of \$132,906 for the period ended March 24, 2023 and the investment loss of (\$789,271) for the year ended December 31, 2022.

Note D--Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1), and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs would only be used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used when Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 1 or Level 3 inputs for the periods presented.

Level 2 Fair Value Measurements

The Plan holds various pooled separate accounts that are not direct filing entities. A majority of these pooled separate accounts seek to mirror the investment objectives and strategies of the underlying mutual fund for which the pooled separate account is named. Certain other pooled separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocation that become more conservative over time to the specified retirement date. And, others are lifestyle funds which seek returns consistent with the stated investment style.

Gains and losses included in changes in net assets available for benefits for the period ended March 24, 2023 and the year ended December 31, 2022, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers of investments between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the period ended March 24, 2023 and the year ended December 31, 2022, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3.

Note E--Related Party and Party-in-Interest Transactions

Certain Plan investments were shares of pooled separate accounts managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest. During 2023 and 2022, the Custodian was paid directly by the Plan fees of \$7,094 and \$45,116, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note F--Tax Status

The Internal Revenue Service ruled on March 22, 2021 that the Volume Submitter Plan Document (sponsored by Retirement Management Services, LLC and upon which the Plan is based), as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.
