## Notes to Financial Statements

### Note 1: Description of Plan

The following description of the Wilde Automotive Group 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is sponsored by Wilde Automotive Management of Wisconsin and certain affiliates (the Sponsor).

#### Plan Termination

On November 9, 2022, the plan sponsor passed a resolution to terminate the plan. As of December 31, 2022, some participants had not fully withdrawn their account balances. Effective November 30, 2023, the remaining balances have been fully distributed.

#### Eligibility and Participation

Employees of the Sponsor were eligible to participate in the Plan upon the completion of one year of service and having attained age 21 on a qualifying entry date. Following completion of eligibility requirements, eligible employees became participants in the Plan on January 1st, April 1st, July 1st, or October 1st.

#### Contributions

Each year participants could contribute a portion of their total compensation, as defined by the Plan, not to exceed the maximum allowable under the Internal Revenue Service (IRS). Participants could also contribute distributions from other qualified benefit plans (rollovers). Sponsor matching and profit-sharing contributions were not permitted per the Plan.

#### Participant Accounts

Each participant's account was credited with the participant's contributions, allocations of Plan earnings (losses) thereon, and administrative expenses as defined by the Plan. Allocations were based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

#### Vesting

Participants were immediately vested in their voluntary contributions, plus actual earnings (losses) thereon following the terminating plan resolution.

### **Note 1: Description of Plan** (Continued)

#### **Investment Options**

Participants directed how their contributions and account balances were invested among the Plan's investment alternatives.

#### **Life Insurance Contracts**

Prior to January 1, 2001, participants had the option of directing a portion of their contributions to purchase life insurance contracts. Effective January 1, 2001, participants were no longer able to enter into new life insurance contracts.

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant or a designated beneficiary was eligible to receive a lump-sum amount equal to the value of the participant's vested account balance. For balances less than \$5,000, no consent was required for distribution of participant funds. In-service distributions were allowed once a participant reached the age of 59½. Under certain circumstances participants could qualify to receive a hardship distribution, less applicable income taxes, from their vested account balance.

#### **Notes Receivable from Participants**

Participants could receive a loan from their account balance at a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or one-half of a participant's vested account balance. Notes receivable from participants were treated as a separate investment of the participant and all principal and interest payments on notes were credited to the participant account from which the loan was made. Interest rates and repayment schedules for notes receivable from participants were determined by the plan administrator on a case-by-case basis and subject to certain limitations, as stated in the plan document. The notes were secured by the balance in the participant's account. Principal and interest were paid ratably through payroll deductions.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the liquidation basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Investment Valuation and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued, but unpaid interest. No allowance for credit losses has been recorded as of November 30, 2023 and December 31, 2022. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Administrative expenses also include advisory and recordkeeping fees. Certain investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of the accompanying financial statements in conformity with GAAP requires management to make estimates and assumptions that directly affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates and are subject to change in the near term.

#### **Subsequent Events**

Subsequent events have been evaluated through June 19, 2024, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP specifies a three-tier fair value hierarchy, which prioritizes the inputs used in estimating fair value. These tiers include Level 1, defined as observable inputs such as quoted market prices in active markets; Level 2, defined as inputs other than quoted market prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore, requiring an entity to develop its own assumptions. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement, valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. The mutual funds are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/collective trust - Stable Value:* Fair value is estimated using the NAV per unit based on the fair value of the underlying investments held by the common/collective trust.

The objective of the Reliance Trust Company Stable Value Employee Benefit Investment Trust is to seek to preserve principal and maintain a stable crediting rate that is responsive to changes in interest rates. The primary investment underlying the trust is the New York Life Anchor Account Contract issued by the New York Life Insurance Company. Principal and accumulated interest guarantees are provided by New York Life, subject to the terms of the group annuity contract. The crediting rate is subject to change daily. Withdrawals made as a result of a plan sponsor-initiated event, complete or partial plan termination and certain other events are paid out at the lesser of the guaranteed value or the guaranteed value less any fair value deficit allocable to the Plan.

*Common/collective trusts - Other:* Fair value is estimated using the NAV per unit based on the fair value of the underlying investments held by the common/collective trust. The NAV of each collective investment trust is calculated in a manner consistent with GAAP for investment companies and is determinative of their fair value and represents the price at which the Plan would be able to initiate a transaction. All the common/collective trusts invest in collective funds and open-end mutual funds, including equity funds and fixed income funds.

Investments in the stable value funds and other common/collective trusts can be purchased and sold daily. Certain common/collective trusts require a notice of redemption. The Plan has no obligation to buy additional units.

*Life insurance policies:* Valued at net surrender value as determined by the insurance carrier.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 4: Income Tax Status

The Plan adopted the Milliman Inc, Non-Standard Pre-Approved Profit Sharing Plan (Prototype). The Prototype received a favorable opinion letter from the Internal Revenue Code (IRC) indicating it was designed in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the Prototype, however, the plan administrator believes the Plan is qualified and the related trust is tax exempt. Therefore, no provision for income tax has been included in the accompanying Plan's financial statements.

### Note 5: Information Prepared and Certified by Trustee

Certain information related to the Plan's investments disclosed in the accompanying financial statements, including investments held at December 31, 2022, except the cash surrender value of life insurance, interest and dividends and net appreciation (depreciation) in fair value of investments for the period ended November 30, 2023 and for the year ended December 31, 2022, was obtained or derived from information certified as complete and accurate by Charles Schwab Trust Bank for the period ended November 30, 2023 and the year ended December 31, 2022.

### **Note 6: Risks and Uncertainties**

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the values of investments, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

### **Note 7: Party-In-Interest Transactions**

Certain plan investments are managed by the trustee and the third-party administrator. The Plan pays certain investment and custody fees to the trustee and third-party administrator. These transactions and notes receivable from participants qualify as party-in-interest transactions. These transactions are not considered prohibited under ERISA regulations.
