Summary of Significant Accounting Policies

For the Ten-Month Period Ended October 31, 2022 and Year Ended December 31, 2021

Basis of Presentation

The AB May / R.S. Andrews Enterprises, Inc. 401(k) Plan (the Plan) presents its financial statements on the accrual basis of accounting.

Use of Estimates

In preparing financial statements in conformity with accounting principles generally accepted in the United States of America, Plan management was required to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments were stated at fair value. All Plan assets were transferred to the Frontier Service Partners, Inc. 401(k) Plan (Frontier Plan) before the close of business on October 31, 2022. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determined the Plan's valuation policies utilizing information provided by the Plan's trustees. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold during the ten-month period ended October 31, 2022 as well as gains and losses on investments held during the period until they were transferred to the Frontier Plan before the close of business on October 31, 2022.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes were treated as distributions based upon terms of the Plan document. Interest income on notes receivable from participants was recorded on the accrual basis.

Payment of Benefits

Benefits were deducted when paid.

Expenses

Certain expenses of maintaining the Plan were paid directly by AB May Company (the Company) and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits were charged directly to the participants' accounts when incurred and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

For the Ten-Month Period Ended October 31, 2022 and Year Ended December 31, 2021

1. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Merger

Effective October 1, 2022, the Plan was merged into the Frontier Plan and all the Plan's assets were transferred into the Frontier Plan on October 31, 2022.

401(k) Plan

The Plan was a defined contribution plan covering all full-time employees of the Company who had completed six consecutive months of service and were at least 18 years old. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management was responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

Employees could elect to enter the Plan on the first day of each month coincident with or immediately following the date eligibility requirements were met. A participant specified the amount or percentage, not to exceed 20% of eligible compensation or Internal Revenue Service (IRS) limits, to be contributed to the Plan (participant salary deferral contributions). A participant could elect to designate all or any portion of his salary deferral contributions as Roth elective deferral contributions. The Plan allowed for discretionary employer matching contributions. Discretionary employer matching contributions of 100% of the first 1% of participant deferrals of eligible participant compensation, plus 25% of participant deferrals of the next 4% of eligible participant compensation, were made for 2022 and 2021. In order to be eligible to receive matching contributions, participants must have been employed on the last day of the Plan year with a minimum of 1,000 hours of service during the Plan year. These requirements were waived in the event of death, disability, or attainment of normal retirement age, which was age 65 under terms of the Plan. The Plan also allowed for discretionary employer profit sharing contributions. No profit sharing contributions were made in 2022 or 2021. The total of the annual employee and employer contributions on behalf of each participant could not exceed IRS limitations. Participants could also contribute amounts representing distributions from other qualified plans (rollover contributions). Rollover contributions were not subject to contribution limitations.

A participant could direct contributions to any of the available investment options. Contribution amount changes, allocation changes, and fund transfers could be done at any time. Each participant's directed account was credited/charged with an allocation of the directed investment's earnings/losses and credited with the following contributions:

- Participant salary deferral contributions
- Participant rollover contributions
- Discretionary employer matching contributions
- Discretionary employer profit sharing contributions (allocated to participants based on their eligible compensation)

Upon becoming a participant in the Plan, an individual was fully vested in the portion of his account attributable to participant contributions. Upon death, disability, attainment of normal retirement age, or plan termination, a participant also became fully vested in amounts attributable to discretionary employer contributions; otherwise, the participant became fully vested in the employer contribution accounts in accordance with the following schedule:

On termination of service, participants could elect to receive distributions in lump sum or installment payments. If a participant's benefits were \$1,000 or less, benefits were paid in a lump sum if no election was made by the participant. Distributions greater than \$1,000 and less than \$5,000 were automatically rolled over to an Individual Retirement Account if no election was made by the participant.

There were no forfeited nonvested accounts at October 31, 2022 and December 31, 2021. Forfeitures could be used to pay administrative expenses or to reduce future employer contributions. Forfeitures used to reduce employer contributions were approximately \$2,400 for the ten-month period ended October 31, 2022.

Participants could borrow from their accounts up to the lesser of \$50,000 or 50% of their vested balance. New notes were made for a minimum of \$1,000. Note terms ranged from one to five years except notes for the purchase of a primary residence which could be for a longer term and participants were limited to two outstanding notes. The notes were secured by the balance in the participant's accounts. The interest rate charged on notes was equal to the prime rate (as printed in the Wall Street Journal) plus 1%. Principal and interest were paid ratably through payroll deductions.

2. Certified Information

Certain information related to the investments disclosed in the accompanying financial statements was obtained or derived from information supplied to Plan management and certified as complete and accurate by Empower Trust Company, LLC (Empower).

3. **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used to determine the fair value of investments at October 31, 2022 and December 31, 2021. There have been no changes in the methodology used at October 31, 2022 and December 31, 2021:

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding valuation method may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan management believes its valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. There were no transfers for the ten-month period ended October 31, 2022 and year ended December 31, 2021.

4. **Party-in-Interest Transactions**

Fees paid by the Plan to Empower qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. Fees paid to Empower were \$27,390 for the ten-month period ended October 31, 2022.

In addition, notes receivable from participants are also considered parties-in-interest.

5. **Income Taxes**

Effective October 6, 2021 the Plan adopted a prototype plan with Empower, which received an opinion letter dated November 14, 2022, from the IRS stating that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The prototype plan has been amended since receiving the opinion letter; however, the Plan administrator believes the Plan was designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan was qualified and tax-exempt as of the financial statement date and no provision for income taxes has been recorded in the financial statements.

Through October 5, 2021, the Plan operated under a different prototype plan, which had received an opinion letter dated March 31, 2014 from the IRS stating that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan had been amended since receiving the opinion letter; however, the Plan administrator believed the Plan was designed and was being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2022 and December 31, 2021, there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

6. **Risks and Uncertainties**

The Plan allowed participants to invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuation, and credit risk. Due to the transfer of all Plan assets and investments, other than the employer match amount, to the Frontier Plan as of October 31, 2022, these risks were also transferred to the Frontier Plan.

7. **Restatement of Financial Statements**

Financial statements for the years ended October 31, 2023 and December 31, 2021 were previously issued on April 30, 2024. Subsequent to issuing the financial statements, management discovered an error in the Plan name and name of the Plan Sponsor. These financials statements have been restated to correct the error, with no impact to net assets available for Plan benefits or changes in net assets available for Plan benefits.

8. **Subsequent Events**

The Plan has evaluated subsequent events through June 11, 2024, the date the financial statements were available to be issued.
