## Independent Auditor's Report

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Capco, LLC 401(k) & Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of January 31, 2022 and December 31, 2021 and the related statement of changes in net assets available for benefits for the period from January 1, 2022 to January 31, 2022 and the related notes to the financial statements.

### Note 1 - Plan Description and Plan Provisions

The following description of Capco, LLC 401(k) & Profit Sharing Plan (the "Plan") provides only general information. Participants and all others should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan was merged into Santa Ynez Band of Chumash Indians 401(k) Plan effective January 31, 2022. Accordingly, the descriptions below are provisions of the Plan prior to the merger. See Note 7 for additional information.

The Plan is a defined contribution plan established on January 1, 1999. The Plan covers employees 18 years of age or older who have completed 60 days of service working under that agreement. The entry date for eligible participants is the first day of the first month coinciding with or following obtaining eligibility. Excluded employees include union employees, employees covered by a collective bargaining agreement, nonresident aliens with no U.S. income, residents of Puerto Rico or any employee performing services in Puerto Rico, leased employees, or reclassified employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration**

The administrative committee of Capco, LLC (the "Sponsor") administers the Plan. The administrative committee has exclusive authority and responsibility for all matters in conjunction with the operation and administration of the Plan (excluding the authority and responsibility to invest, manage, and control the assets of the Plan specifically allocated to the trustee). Individual accounts are invested in the various investment options at the direction of the participants.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute on a before-tax or after-tax basis up to maximum tax-deferred limitations established by the Internal Revenue Code. This maximum percentage may be reduced by the plan administrator in certain circumstances. The Plan has an automatic salary deferral feature to automatically enroll eligible employees at a deferral rate equal to 3 percent of eligible compensation unless they make an affirmative election not to defer or to defer a different percentage. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Employee contributions to the Plan are made through regular payroll deductions.

The Sponsor may make annual discretionary contributions. The participant's share of this discretionary nonelective contribution is based on the amount of eligible compensation, as defined in the plan document, that the participant received during the plan year in proportion to the total eligible compensation of all participants eligible to receive a share of the discretionary nonelective contribution. Participants who have completed 1,000 hours of service and are employed on the last day of the plan year will be eligible to receive an allocation of the Sponsor's discretionary contribution. During the one-month period ended January 31, 2022, the Sponsor did not elect to make a discretionary nonelective contribution.

#### **Participant Accounts**

Each participant's account is credited or debited with the participant's contributions and withdrawals, as applicable, and an allocation of the Sponsor's contributions, plan earnings or losses, forfeitures, and plan expenses. Allocations are based on participants' compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investment Options**

Participants may direct the investment of their account balances from their elective deferrals, rollovers, or transfers into various investment options offered by the Plan. Participants may elect to transfer balances among investment funds within their accounts at any time.

**Note 1 - Plan Description and Plan Provisions (Continued)**

***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. No more than one note shall be made to a participant in a 12-month period. The notes are secured by the balances in the participants' accounts; bear interest at rates that range from 4.25 percent to 6.00 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at note origination; and mature at various dates through June 2026. Notes have a maximum term of 5 years unless such note is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 15 years from the date of the note origination. Principal and interest are paid ratably through monthly payroll deductions. Participant notes receivable are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Upon termination of a participant from employment, the participant's note shall continue to be payable in accordance with the provisions of the participant's note or be due in full.

***Vesting***

Participants are immediately 100 percent vested in their voluntary contributions and allocated earnings or losses thereon.

Any employer contributions and the earnings or losses thereon not fully vested when contributed will vest as follows:

A participant's account becomes 100 percent vested upon death, attaining normal retirement age (the age of 65), retirement due to disability, or termination of the Plan.

***Benefit Payments***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

The Plan allows for in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the Sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Participants who are granted a hardship withdrawal are not allowed to make contributions for the six months following such withdrawal. Furthermore, the Plan allows for a terminated participant's vested account balance of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan into an individual retirement account for the benefit of the participant.

***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures can be used to pay plan expenses or reduce employer contributions.

***Related Party and Party-in-interest Transactions***

Certain plan assets are in investment funds managed by Charles Schwab Trust Bank or its affiliates. Charles Schwab Trust Bank is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

**Note 2 - Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Investment Valuation***

The Plan's investments are stated at fair value.

The common collective trust fund is valued at net asset value per share (NAV) of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on this investment.

Investments in mutual funds are reported at the last reported sale price at the end of the respective periods using quoted market prices.

See Note 4 for additional information.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks, Uncertainties, and Concentrations***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including November 1, 2022, which is the date the financial statements were available to be issued.

**Note 3 - Assets Certified by the Trustee**

Charles Schwab Trust Bank (the "Trustee") has certified in writing to the plan administrator that the stated amounts for investments at fair value as of January 31, 2022 and December 31, 2021 and the income earned on the investments or losses incurred therein for the one-month period ended January 31, 2022, as reflected in the accompanying financial statements, are complete and accurate.

**Note 3 - Assets Certified by the Trustee (Continued)**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's auditors not to perform any auditing procedures with respect to the investment information certified to by the Trustee except for comparing the information contained therein to information included in the financial statements.

**Note 4 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

**Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

**Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

**Level 3**

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

**Note 5 - Tax Status**

Mr. Matzkin,

My firm represents the Santa Ynez Band of Chumash Indians (the "Tribe"). The Tribe recently became aware that its wholly owned subsidiary Valor Tactical Innovation (formerly known as Capco, LLC) received a penalty assessment from the Department of Labor regarding the 2022 Form 5500 filing for the Capco, LLC 401(k) & Profit Sharing Plan (the "Plan"). The Department's recent correspondence is attached to this message and forwarded below. The Tribe asked us to assist with the Form 5500 penalty matter and our Power of Attorney also is attached to this message.

The Plan was merged into the Tribe's Plan following the Tribe's acquisition of Capco, LLC. The effective date of the Plan merger was January 31, 2022. As a result, the final Form 5500 for the Plan covers a one-month period from January 1, 2022 until January 31, 2022. Over the last week, we have determined that the final Form 5500 filing for the Plan was prepared on a timely basis and the ERISA Section 103(a)(3)(C) audit of the Plan's financial statements for the 2022 Plan year was completed on a timely basis. Records indicate that the Form 5500 and the ERISA audit were complete by November 1, 2022. As the result of turnover in key positions within Capco and other operational difficulties that have impacted the entity since the pandemic, the 2022 Form 5500 was not filed. The current Director of Finance is obtaining their EFAST filing credentials and preparing to complete the filing.

Capco, now Valor, is a defense contractor that manufactures various goods for the federal government under fixed price contracts. As you will recall, the costs for many goods escalated dramatically during the pandemic, which left Capco in the position of manufacturing goods at a loss in order to meet its obligations under the fixed price contracts. The losses incurred under those fixed price contracts have had a lasting impact on the entity's operations, contributing to significant reductions in staffing, turnover in leadership positions and multiple years of heavy operating losses. Valor continues to operate a loss currently, but they have now rebuilt the management team with new people in multiple key leadership positions.

Now that the Form 5500 filing and ERISA audit report have been located, it is clear that the individuals working with the Plan in 2022 intended in good faith to complete the filing obligation and failure to file was simply the result of turnover and transition issues. Current management at Valor is working diligently to address the incomplete filing and the pending penalty. If anything can be done to reduce the penalty assessment at this time, or as soon as the filing is completed, that would be greatly appreciated. Given Valor's ongoing operational and financial struggles, the current penalty assessment is truly burdensome and will require that Valor use resources that could be allocated to additional personnel and other pressing business needs.
