**Note 1 – Description of Plan**

The following description of the Meriwether-Godsey, Inc. Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General**

The Plan was established by Meriwether-Godsey, Inc. (the “Company”) effective June 26, 2003. The Plan was amended and restated effective June 30, 2016. The Plan operates as an Employee Stock Ownership Plan (“ESOP”) and a stock bonus plan, and is designed to comply with Section 4975(e)(7), 401(a), and the regulations thereunder of the Internal Revenue Code. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was terminated effective November 18, 2021 when the Company was sold and all shares were purchased.

**Administration**

The Plan is administered by a Board of Trustees and the Company. The Plan’s assets and Company contributions are held and managed by the Trustees, which invest cash received, interest, and dividend income and make distributions to participants.

Officers or employees of the Company perform certain administrative functions. No such officer or employee receives compensation from the Plan.

**Eligibility**

All employees are eligible to participate in the Plan upon attainment of age 21 and completion of one year of service provided they worked at least 1,000 hours during such plan year. After meeting the eligibility requirements, an employee becomes a member of the Plan on the earliest January 1 or July 1 occurring on or after his/her qualification.

**Contributions**

Contributions are made in both cash and in stock. The employer match is based on the match formula determined by the Plan and the remainder of the total principal and interest payments made are treated as discretionary contributions to the Plan. Additional discretionary contributions are allowed.

**Vesting**

Each participant becomes 100% vested in the his/her discretionary company stock account and other discretionary investment account after six years of service with the Company. Each participant becomes 100% vested in the his/her matching account after four years of service with the Company. Any employee who becomes permanently disabled, dies, or reaches normal retirement (age 65) while in employment of the Company will have a 100% vested interest in his/her account.

All participants are 100% vested effective November 18, 2021 as the Plan was terminated.

**Participant accounts**

Each participant's account is credited with allocations of the Company's contributions and the Plan's earnings and charged with an allocation of administration expenses. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Put Option**

Under Federal income tax regulations, employer stock held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Voting rights**

Under certain conditions, each participant is entitled to exercise voting rights attributable to the shares allocated to his/her account and is notified by the Trustee prior to the time that such rights are to be exercised.

**Payment of benefits**

In the event of a participant's retirement, death or disability, distributions of vested Plan benefits commence in the year following the Plan Year in which the retirement, death or disability occurs. In the event of a participant's termination from service for any other reason, distributions of vested Plan benefits commence no later than the sixth Plan Year following the Plan Year in which the termination from service occurs.

**Diversification**

Diversification was offered to participants nearing retirement so they may have the opportunity to move part of the value of their investment in Employer stock into investments that are more diversified. Participants who are at least age 55 with 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

**Forfeitures**

Plan forfeitures are allocated to each participant's account based on the ratio of the participant's compensation to total compensation for the Plan year. Forfeitures of \$-0- and \$-0- were reallocated to the accounts of active participants during the Plan Year's ending January 31, 2024 and June 30, 2023, respectively.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting**

The financial statements of the Plan are prepared using the liquidation basis of accounting. Liquidation basis of accounting reports assets and liabilities at the fair value upon liquidating the assets and payment of Plan obligations.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure to contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Cash and Cash Equivalents**

Cash equivalents are deposits of cash in money market accounts subject to withdrawal on demand. Both cash and cash equivalents are on deposit with one financial institution. Balances may exceed the FDIC (Federal Deposit Insurance Corporation) limit of \$250,000; however, management does not anticipate a loss on this account.

**Investment valuation and income recognition**

The Plan's investments are recorded at fair value. The investment in sponsor company common stock is based on the value as determined by an independent appraisal.

Income from investments is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes investments bought, sold, and held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Credit risk**

Financial instruments, which potentially subject the Company to credit risk, consist principally of cash and investments. The Company maintains its cash in one financial institution. At times, the Company has balances in excess of the Federal Deposit Insurance Corporation limits. Management does not feel there is a risk of loss. The investments of the Company are subject to market and interest rate risk.

**Note 3 - Fair Value Measurements**

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

**Note 4 – Plan Termination**

The Company reserves the right to terminate the Plan at any time subject to Plan provisions. Upon such termination of the Plan, the participants will become 100% vested in their accounts and the interest of each participant in the Plan will be distributed to such participant or his/her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code. Upon termination of the Plan, the Plan administrator will pay all liabilities and expenses of the Plan.

The governing body of Meriwether-Godsey, Inc. Employee Stock Ownership Plan approved a plan of termination on November 18, 2021 and management determined liquidation is imminent.

**Note 5 – Income Tax Status**

The Internal Revenue Service has determined and informed the Employer by letter dated September 13, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code of 1954, as amended. The Plan has not been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service ("IRS"). The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of January 31, 2024 and June 30, 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to June 30, 2021.

The Plan has filed the standard termination notice with the Internal Revenue Service with a termination date of November 18, 2021. The IRS approved the termination effective February 15, 2023.

**Note 6 – Administrative Expenses**

Plan administrative expenses may be paid by either the Plan or the Employer on a discretionary basis. The period ending January 31, 2024, the expenses paid by the Plan were \$12,990.

**Note 7 – Related Party Transactions**

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee received compensation from the Plan.

A former majority shareholder in the Company participates in the Plan. The party-in-interest assets held by the Plan are less than 1% during the seven months ended January 31, 2024 and year ending June 30, 2023, respectively.

**Note 8 – Plan liquidation process**

The Plan Sponsor has adopted a plan of liquidation to meet ERISA requirements. The sale of stock was paid in cash in 2021 and held in a cash account. The Plan was fully liquidated and paid out as of January 31, 2024.

The Plan has evaluated subsequent events through June 10, 2024, the date the report was made available for issuance, for potential recognition and disclosure in the financial statements.
