INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries
of the H.N. Fernandez, Inc. Employee Health Benefits Trust

Opinion on the 2023 Financial Statements

We have audited the financial statements of H.N. Fernandez, Inc. Employee Health Benefits Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statement of net assets available for benefits (modified cash basis) as of January 31, 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended January 31, 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (modified cash basis) of the Plan as of January 31, 2023, and the changes in net assets available for benefits (modified cash basis) for the year ended January 31, 2023, in accordance with the modified cash basis of accounting described in Note 2.

Basis for Opinion on the 2023 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2023 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the 2023 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Auditors' Responsibilities for the Audit of the 2023 Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN

The following description of H. N. Fernandez, Inc. Employee Health Benefits Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan provides health, dental and death benefits covering substantially all eligible employees of H. N. Fernandez, Inc. (the Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participating employees contribute amounts ranging from \$5 to \$77 per week depending on selected coverage options. The Sponsor contributes an amount equal to the difference between the costs of providing coverage, including administrative costs, less employee contributions.

Employees may contribute specified amounts, determined periodically by the Plan's insurance companies, to extend coverage to eligible dependents. Employee contributions vary based upon the election of benefits for a PPO or HMO and single or family coverage.

Employee contributions from February 1, 2022 through January 31, 2023 were deposited into the general assets of the Sponsor in the amount of \$114,898. As described in Note 2, the financial statements are prepared under the modified cash basis of accounting; therefore, these amounts have not been accrued in the statement of net assets available for benefits and the statement of changes in net assets available for benefits as of and for the year ended January 31, 2023.

Benefits

The Plan provides health benefits (medical, hospital, surgical, major medical, and other health care benefits), dental, and death benefits to full-time employees of the Sponsor (with at least 450 hours of service in each of the previous two quarters) and to their beneficiaries and covered dependents.

Current health claims of active participants and their dependents and beneficiaries are provided under a group insurance contract with BlueCross BlueShield of Louisiana. Death benefits are covered by a group-term policy with Sun Life Assurance Company of Canada. The Plan is self-insured for dental claims. Dental claims are processed by Southern National Life.

Plan Expenses

Expenses attributable to the general Plan administration were paid by the Plan Sponsor. The Plan Sponsor absorbs the costs of substantially all administrative expenses for the Plan.

1. DESCRIPTION OF PLAN (continued)

Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

Eligibility

Employees are eligible to participate in the Plan once they have completed two consecutive months of employment and have worked at least 450 hours in each of the previous two quarters.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting, which is a comprehensive basis of accounting other than U.S. generally accepted accounting principles (GAAP). The modified cash basis of accounting is an acceptable alternative method of reporting under regulations issued by the U.S. Department of Labor. Under the modified cash basis, Sponsor and participant receivables owed at year end and not yet remitted to the Plan are not recorded as assets of the Plan. Under GAAP, these receivables would be considered to be assets of the Plan.

Cash

The Plan maintains cash accounts with various financial institutions. At times, deposits may exceed Federal Deposit Insurance Corporation maximum coverage.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Plan Benefits

Plan benefits are presently limited to health benefits (medical, hospital, surgical, major medical, and other health care benefits), dental, and death benefits to full-time employees of the Sponsor and to their beneficiaries and covered dependents. Plan obligations for dental claims incurred by participants but not yet reported at fiscal year-end are estimated by the Plan's management.

3. BENEFIT OBLIGATIONS

Health costs incurred by participants and their beneficiaries and dependents, and life benefits are covered by insurance contracts maintained by the Plan. It is the present intention of the Sponsor and the Plan to continue obtaining insurance coverage for benefits.

The Plan is self-insured for dental claims, and the Plan had no benefit obligations for dental claims at January 31, 2023 and 2022. The Plan's net assets available for benefits – modified cash basis was sufficient to meet the Plan's total benefit obligations at January 31, 2023 and 2022. The change in the Plan's total benefit obligations for dental claims is as follows:

3. UNCERTAIN TAX POSITIONS

The trust established under the Plan to hold the Plan's net assets is qualified, pursuant to Internal Revenue Code (IRC) Section 501(c)(9), and accordingly, the trust's net investment income is exempt from income taxes. The Plan and trust are required to operate in accordance with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the related trust is tax exempt. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. SUBSEQUENT EVENTS
