Notes to Financial Statements

December 31, 2022 and 2021

(1) Description of Plan

The following description of the Ancillare LP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution plan covering all employees of Ancillare LP and I.S.G. Office Concepts, Inc. (the Company), except collective bargained employees, non-resident alien employees, and leased employees. Employees are eligible to make elective deferrals upon satisfying the eligibility requirements of one hour of service in the first month of employment and 21 years of age. Employees are eligible to receive employer safe harbor contributions, subject to certain additional eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Each year, participants may contribute up to 100% of their annual eligible compensation, as defined by the Plan, subject to the maximum allowable under the Internal Revenue Service (IRS) guidelines. Participants elect to have their deferrals be pre-tax contributions to the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For eligible employees who complete at least 1,000 hours during 12 months of service and are 21 years of age, the Company shall make a safe harbor contribution in the amount of 100% of employee deferrals up to 4% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's safe harbor matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their employee contributions and employer safe harbor contributions, plus actual earnings thereon.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in their account in a lump-sum amount. The Plan allows for in-service distributions if a participant reaches age 59½ or qualifies for hardship distributions, subject to plan provisions. Effective March 31, 2021, the Plan will make an involuntary cash-out of a participant's vested account balance following severance from employment for participants with balances up to a maximum of \$5,000.

Forfeited Accounts

On December 31, 2022 and 2021, forfeited nonvested accounts totaled \$19,187 and \$36,047, respectively. These accounts will be used to pay administrative expenses incurred by the Plan or to reduce future employer contributions. During the year ended December 31, 2022, plan expenses were reduced by \$22,031 from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenue and expenses during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to certain participant transactions are charged directly to the participant's account and included in administrative expenses. Certain investment related expenses are included in the net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through June 24, 2024, the date the financial statements were available to be issued.

(3) Financial Information Certified by a Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments at fair value and cash held at December 31, 2022 and 2021, and net depreciation in fair value of investments and dividend and interest income for the year ended December 31, 2022, was obtained by management and agreed to or derived from the information certified as complete and accurate by Fulton Bank, N.A. (Fulton), a qualified institution.

(4) Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022 and 2021.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There were no significant transfers among investment levels during the year ended December 31, 2022 and 2021.

(5) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments are shares of mutual funds managed by Fulton. Fulton is the custodian of the Plan's assets and the Plan, therefore, these transactions qualify as party-in-interest transactions, which are exempt under the prohibited transaction rules.

(6) Prohibited Transactions

During 2021, participant withholdings in the amount of \$2,447, were not remitted to the Plan. These transactions constitute prohibited transactions as defined by ERISA. The Company made corrective contributions to the Plan during 2024 to compensate affected participants for lost earnings on the delinquent remittances.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(8) Tax Status

Effective March 31, 2021, the Plan adopted a volume submitter document sponsored by Fulton. The IRS has determined and informed Fulton by a letter dated June 30, 2020, that the volume submitter document and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Prior to March 31, 2021, the Plan used a prototype plan document sponsored by Spectra Associates, Inc. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for the tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(10) Plan Corrections

The Company intends on self-correcting certain operational errors related to the application of the Plan's eligible compensation definition used for purposes of calculating employee contributions and employer matching contributions under the Employee Plans Compliance Resolution System. The Company intends on making the corrections in 2024 in accordance with the IRS's Voluntary Fiduciary Correction Program (VFCP) for the prohibited transactions (Note 6). The Company does not expect the VFCP submission to affect the Plan's tax status. Receivables in the amount of \$43,609 have been recorded as it relates to these corrections for the 2021 and 2022 plan years in the accompanying statements of net assets available for benefits as of December 31, 2022.
