INDEPENDENT AUDITOR'S REPORT

To the Audit Committee of

Opinion

We have audited the financial statements of 403(b) Thrift Plan of Covia Affordable Communities, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits in liquidation as of March 25, 2022 and December 31, 2021, and the related statement of changes in net assets available for benefits in liquidation for the period from January 1, 2022 to March 25, 2022, and the related notes to the financial statements in liquidation.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits in liquidation of 403(b) Thrift Plan of Covia Affordable Communities as of March 25, 2022 and December 31, 2021, and the changes in its net assets available for benefits in liquidation from January 1, 2022 to March 25, 2022, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of 403(b) Thrift Plan of Covia Affordable Communities and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Liquidation Basis of Accounting - December 31, 2021, Financial Statements

As discussed in Note 1 to the financial statements, the Board of Directors of 403(b) Thrift Plan of Covia Affordable Communities approved a plan of liquidation effective January 1, 2022, and management determined liquidation was imminent. As a result, 403(b) Thrift Plan of Covia Affordable Communities changed the basis of accounting used to determine the amounts of which assets and liabilities were carried from the going concern basis to the liquidation basis used in presenting the 2021 financial statements. Our opinion was not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting

Prior to January 1, 2021, 403(b) Thrift Plan of Covia Affordable Communities (the “Plan”) prepared the financial statements using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Effective January 1, 2022, a plan of termination was approved by management and termination of the Plan became imminent. Accordingly, the Plan’s basis of accounting was changed to the liquidation basis of accounting (amounts are valued at the amount expected to be collected and paid) effective January 1, 2021, in accordance with accounting principles generally accepted in the United States of America. Any fluctuations in the realizable amount will be recognized in the period in which they occur.

Investment Valuation, Transactions and Income Recognition

General

Investments are carried at fair value, which approximates settlement value and is determined, presented and disclosed in accordance with Financial Accounting Standards Board Accounting Standards Codification (“FASB ASC”) 820, *Fair Value Measurements and Disclosures*. Under FASB ASC 820, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the “exit price”) in an orderly transaction between market participants at the measurement date.

FASB ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are those that market participants would use in pricing the asset or liability based on market data obtained from sources independent of the Plan. Unobservable inputs reflect the Plan’s assumptions about inputs that market participants would use in pricing the investments developed based on the best information available in the circumstances. The fair value hierarchy is categorized into three levels, based on the inputs, as follows:

Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Valuations based on quoted prices in markets that are not active, quoted prices for similar investments in active markets or model-based valuations for which all significant assumptions are observable and can be corroborated by observable market data.

Level 3 - Valuations based on unobservable inputs that are supported by little or no market activity and are significant to the overall fair value measurement. Values are determined using proprietary pricing models, discounted cash flow models that include the investment entities’ own judgments and estimations, or some other pricing method using unobservable inputs.

Inputs and Valuation Methods

In determining fair value, FASB ASC 820 allows various valuation approaches. The specific methods used for each of the Plan’s investment classes are presented below.

Pooled Separate Accounts: Mutual of America Separate Account No. 2 is a pooled separate account composed of 45 distinct mutual funds in 2022 and 2021, which is valued at the reported net asset value. The underlying assets are valued at quoted market prices in the Plan’s pooled separate accounts. The net asset value is being used as a practical expedient to estimate fair value.

General Account

The Mutual of America Interest Accumulation Account is carried at amortized cost, or contract value, which is deemed to be fair value by the insurance company (Level 3).

Valuation Methods, Consistency

The valuation techniques used in the accompanying financial statements have been consistently applied.

Transactions and Income Recognition

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants is measured at the unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Participant notes are not deducted from the participant's account balance as note proceeds come from Mutual of America's general assets. Principal repayments are applied to reduce the amount secured by assets held in the Interest Accumulation Account, and a portion of the interest paid by the participant is retained by Mutual of America as compensation. The interest rate is variable and subject to change at the beginning of each quarter.

Administrative Expenses

Covia Affordable Communities (the "Plan Sponsor", or the "Company"), provides administrative services to the Plan at no charge. Administration expenses are paid by the Plan if, and to the extent that, the Plan Sponsor does not pay such expenses.

Payment of Benefits

Participant withdrawals and termination payments are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in pooled separate accounts and a general account. Such investments are exposed to various risks, such as interest rate, market fluctuations and credit. Due to the level of risk associated with certain investments and the level of uncertainty with respect to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

2. DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

On April 1, 2021, Covia Communities completed affiliation with Front Porch, a California-based not-for-profit senior living and affordable housing provider.

Effective January 1, 2022, the Plan was frozen to new participants and contributions. No new loans are permitted. All participant accounts are 100% vested. Effective January 1, 2022, participants contribute into another 403(b) plan sponsored by Front Porch.

The Plan was established effective January 1, 2009, to provide retirement benefits for eligible employees of the Company. The Plan was financed by contributions from the participants, matching contributions from the Company, and the net earnings of the investments of the Plan. The Plan also accepted rollover contributions from other qualified plans. The Plan is a 403(b) salary deferral plan covering all full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Mutual of America Life Insurance Company acts as the custodian and record keeper of its assets.

Participant Accounts

Prior to termination of the Plan, each participant's account was credited with the participant's contributions plus allocations of Company contributions and Plan earnings and was charged with an allocation of administrative expenses. Allocations were based on participant earnings or account balances, as defined. Participants could direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

All participant account balances became fully vested effective January 1, 2022.

Payment of Benefits

Prior to termination of the Plan, distributions could be made to each participant upon attainment of age 59½, retirement, death or disability, or termination of employment. Payments could be made as a single lump-sum payment or regularly scheduled payments of \$100 or more per month. Hardship withdrawals in the form of a single lump-sum payment were also allowed by the Plan, if certain criteria are met.

3. TAX STATUS

The Plan adopted a non-standardized prototype plan document that received an opinion letter from the Internal Revenue Service dated March 31, 2017, indicating that the prototype plan was designed in accordance with the applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended, the Company and the Plan's administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Plan's administrator has analyzed the tax positions taken by the Plan and has concluded that, as of March 25, 2022 and December 31, 2021, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. GENERAL ACCOUNT IN THE GROUP ANNUITY CONTRACT

The Plan entered into a Group Annuity contract with Mutual of America. Amounts placed in the Interest Accumulation Account of Mutual of America's General Account were credited with interest at a rate determined by Mutual of America. Mutual of America reserved the right to change the interest rates applicable to amounts held in the Interest Accumulation Account, at their discretion.

5. INVESTMENTS AT FAIR VALUE HIERARCHY

There were no investments as of March 25, 2022, due to the termination of the Plan. Assets measured at fair value on a recurring basis, based on their fair value hierarchy at December 31, 2021, are as follows:

There were no unfunded commitments as of March 25, 2022 and December 31, 2021.

These pooled separate accounts invest in:

- {a} A diversified portfolio of fixed income and equities, with an objective of seeking current income and capital appreciation.
- {b} A diverse portfolio of common stock, with an objective to provide investment results that correspond to the performance of market price indexes.
- {c} A diversified portfolio of fixed-income funds, with an objective of seeking current income and a secondary objective of preservation of capital.
- {d} A portfolio of stock of companies that are growing in earnings and revenue, with an objective of seeking long-term growth of capital.
- {e} A portfolio of stock of companies that are outside the United States, with an objective of seeking long-term capital appreciation.
- {f} Other separate account funds in proportions that are balanced to meet the current target of the fund, with an objective of seeking current income and capital appreciation appropriate for the asset allocation associated with its target retirement date.
- {g} A portfolio of value stock issued by companies, with an objective of seeking capital appreciation.

7. PRIORITIES UPON TERMINATION

The Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in all benefits earned to date. The Board of Directors of the Plan approved a plan of liquidation effective January 1, 2022. Effective March 25, 2022, the Plan terminated when all assets to participants were fully distributed on behalf of participants or their beneficiaries.

8. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Mutual of America Life Insurance Company, the Plan's custodian/record keeper. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

9. SUBSEQUENT EVENTS

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after March 25, 2022, for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through June 4, 2024, the date the financial statements were available to be issued, and no items have come to the attention of management that require recognition or disclosure.
