We have performed audits of the financial statements of Nation Pizza Products, LLC Employees' 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through May 31, 2023, and the related notes to the financial statements.

**NOTE A - DESCRIPTION OF PLAN**

The following description of the Nation Pizza Products, LLC Employees' 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***General***

The Plan is a defined contribution plan covering all eligible non-union and non-leased employees of Nation Pizza Products, LLC (the Company or Employer or Plan sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Employees are eligible for participation if they are not covered under a collective bargaining agreement, non-resident aliens, or leased employees. Employees must be at least 18 years of age and have completed six months of service. Eligible employees can enter the Plan on the first day of the month following eligibility requirements being met.

Effective June 27, 2020, the Plan sponsor was acquired by Nestlé USA, Inc. Following the acquisition, Company management, in conjunction with Nestlé management, completed the merger of the Plan into the Nestlé 401(k) Savings Plan (Nestlé Plan). The merger was effective May 31, 2023. Participant balances in the amount of \$28,560,780 were transferred to the Nestlé Plan as part of the merger.

***Contributions***

Participants may elect to make pre-tax and/or after-tax contributions as a percentage of their annual compensation, not to exceed the limits of the Internal Revenue Code (IRC), as defined in the Plan document. Participants direct the investment of their contributions into various investment options offered by the Plan. These deferrals are specifically allocated to the account of the individual participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

Participants are automatically enrolled in the Plan upon meeting the eligibility requirements at an employee deferral contribution pre-tax rate of 5% of eligible compensation. Employee elective deferrals will have an automatic increase of 1% each Plan year (unless a different deferred rate is chosen by the participant), not to exceed 8% of eligible compensation. In general, such automatic enrollment will be effective the first pay period after the participant has met all eligibility requirements, unless the participant elects to participate at a different rate or elects to opt out of participation.

Matching contributions are made by the Employer at an amount equal to 50% of the participant's elective contributions to the Plan, not to exceed \$2,000. The Company may also make an additional contribution to the Plan at the discretion of the 401(k) committee. The Company made no discretionary contributions to the Plan in 2023.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Employer's matching contributions, an allocation of Plan earnings/losses, and Plan expenses. Allocations are based on the participant's account balances as defined in the Plan's provisions.

***Vesting***

Participants are immediately vested in their voluntary contributions, including rollover amounts, plus actual earnings thereon. Vesting in the Employer contributions portion of their account plus earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Vested balances less than \$1,000 are automatically distributed after employment is terminated. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Partial withdrawals are also allowable by the Plan. Participants experiencing financial hardship may withdraw a portion of this account balance as defined by the Plan document.

The Plan allows hardship distributions from all funding sources within a participant's account balance. The Plan also allows in-service distributions to be taken from all funding sources within a participant's account balance upon attainment of age 59½.

***Notes Receivable from Participants***

Participants may borrow from their vested balance a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates on commercial loans. Principal and interest are paid ratably through payroll deductions while the participant is employed by the Employer over a period not to exceed five years, unless the loan qualifies for a home loan it cannot exceed 30 years. A "home loan" is a loan used to acquire a dwelling unit which, within a reasonable time, the Participant will use as a principal residence. A participant may have no more than one loan outstanding at any point in time.

***Forfeited Accounts***

Forfeited non-vested accounts from Employer matching contributions can be used to reduce Employer contributions to the Plan or to pay Plan expenses. Forfeitures of terminated participants' non-vested account balances used to reduce Employer contributions amounted to \$23,754 for the period ended May 31, 2023. At May 31, 2023 and 2022, the outstanding balance of forfeited non-vested accounts totaled \$0 and \$23,481, respectively.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

The significant accounting policies that have been consistently applied in the preparation of the accompanying financial statements follow.

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Use of Estimates***

In preparing financial statements in conformity with U.S. GAAP, management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain Plan administrative expenses are paid by the Plan to the extent they are not paid by the Plan sponsor. Expenses that are paid by the Plan sponsor are excluded from these financial statements. Administrative expenses are expensed when incurred.

**NOTE C - INVESTMENTS**

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE D - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board provides a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2023 and December 31, 2022:

*Mutual funds* - Valued at the net asset value (NAV) of shares held by the Plan at year-end, which is obtained from an active market.

*Collective trust fund* - An investment formed from the pooling of investments by institutional investors. The Plan's interest in the collective trusts is valued by the trustee based on the NAV of shares held by the Plan at year-end as practical expedient fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments of the collective trust fund.

**NOTE E - TAX STATUS**

The Internal Revenue Service (IRS) issued its latest opinion letter for the trustee's prototype plan on June 30, 2020 which stated that the Plan and its underlying trust qualify under the applicable provisions of the IRC and, therefore, are exempt from federal income taxes. In the opinion of the Plan administrator, the Plan and its underlying trust have operated within the terms of the Plan in all material respects and remain qualified under the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of May 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE F - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall become 100% vested in their accounts. Effective May 31, 2023, the Plan was merged into the Nestlé Plan (see Note A).

**NOTE G - INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103 8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), the custodian of the Plan, has certified that the following data included in the financial statements is complete and accurate:

- Interest-bearing cash, investments at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of May 31, 2023 and December 31, 2022.
- Net investment income and interest on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the period ended May 31, 2023.

**NOTE H - RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Reliance. This entity serves as the trustee and custodian, as defined by the Plan and, therefore, any transactions with Reliance qualify as party-in-interest transactions.

The Plan pays certain Plan administrative expenses to Transamerica. Other expenses are paid by the Company. The Plan allows loans to participants. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.
