## **Report of Independent Auditors**

### ***Opinion***

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (in liquidation) of the Plan as of December 29, 2023 and December 31, 2022, the changes in its net assets available for benefits (in liquidation) for the period from January 1, 2023 to December 29, 2023 and for the period from January 18, 2022 to December 31, 2022, and the changes in its net assets available for benefits (ongoing) for the period from January 1, 2022 to January 17, 2022, in accordance with accounting principles generally accepted in the United States of America applied on the bases described in Note 4.

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### ***Basis of Accounting***

As discussed in Note 4 to the financial statements, the Board of Directors of Ingram Industries Inc. approved a plan of liquidation on January 18, 2022, and the Plan determined liquidation was imminent. As a result, the Plan changed its basis of accounting on January 18, 2022 from the going concern basis to a liquidation basis. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.



Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with US GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



***Supplemental Schedule Required by ERISA***

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. Schedule H, line 4j - Schedule of Reportable Transactions for the period from January 1, 2023 to December 29, 2023 ("supplemental schedule") is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### NOTE 1 - DESCRIPTION OF THE PLAN

#### General

The following description of the Ingram Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is a defined benefit plan covering eligible employees of Ingram Industries Inc. (the "Company") and its wholly-owned subsidiaries located in the United States. The Plan is administered by the Retirement Plan Committee, which is appointed by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Investment Committee determines the appropriateness of the Plan's investments, monitors investment performance, and reports to the Retirement Plan Committee. John Hancock Trust Company ("JHTC") serves as trustee, custodian, and record keeper of the Plan assets.

All employees hired by the Company on or after January 1, 2005 were not eligible to participate in the Plan. During 2010, the Company amended the Plan to cease all benefit accruals as of December 31, 2010. As a result, earned benefits did not increase after this date.

#### Plan Termination

On January 18, 2022, the Company's Board of Directors approved a plan to commence the termination of the Plan effective, March 31, 2022. The Plan's termination was also approved by the Retirement Plan Committee on November 9, 2021. The Plan was terminated on December 29, 2023. See Note 4 for additional information.

#### Pension Benefits

Eligible employees with five or more years of vesting service were entitled to annual pension benefits beginning at normal retirement age (65). The normal monthly retirement benefit payable for a life annuity was equal to the sum of:

- (1) 1.0% of the employee's final average monthly earnings multiplied by his or her first five years of credited service;
- (2) 1.3% of the employee's final average monthly earnings multiplied by his or her years of credited service beyond five years; and
- (3) 0.65% of the employee's final average monthly earnings in excess of his or her Social Security maximum wage base average multiplied by his or her years of credited service not in excess of 35 years.

Final average monthly earnings were equal to the employee's average monthly rate of compensation for the five consecutive calendar years out of his or her last ten full calendar years of credited service which produced the highest average. No compensation for calendar years beginning after December 31, 2010 was used for this calculation.

The Plan permitted early retirement with reduced benefits at age 55 or later with five years of vesting service. Employees were able to elect to receive their pension benefits in the form of an annuity or, if the present value is under \$50,000, a lump sum payment.

The Plan paid \$2,352,322 and \$160,933,311 (net of taxes) in 2023 and 2022, respectively, to participants in the form of a lump sum resulting from qualified rollovers, death or termination benefit payments. These amounts are included in Benefits paid to participants on the Statements of Changes in Net Assets Available for Benefits. See Note 4 for additional information.

### **Death and Disability Benefits**

A designated beneficiary was entitled to a death benefit in the event of death of a participant while he or she was actively employed or a vested former participant prior to benefit commencement. The amount due to the beneficiary of a participant who was actively employed or a vested former participant who had attained the earliest retirement date (age 55 and five years of vesting service) would have been the actuarial equivalent of the participant's or former participant's accrued benefit. The amount due to the beneficiary of a vested former participant who had not attained the earliest retirement date would have been the Qualified Pre-retirement Survivor Annuity. The beneficiary's benefit would have commenced the first of the month following the date of death of the participant. If the beneficiary was the spouse of the participant and the present value of the benefits was greater than \$5,000, payment of benefits could have been deferred until the date the participant would have attained his or her normal retirement date.

In the event an active participant suffered a disability, as defined by the Plan, he or she would have become fully vested in his or her accrued benefit. A participant who had five years of vesting service would have continued to earn credited service in one-half year increments for each year after the disability through December 31, 2010 or until attainment of normal retirement age whichever occurred first. At any time after earliest retirement age, the disabled participant could have elected to cease further accruals of credited service and begin receiving retirement benefits.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The accompanying financial statements of the Plan as of and for the period January 1, 2022 to January 17, 2022 are prepared in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") using the going concern ("Ongoing") basis of accounting. As discussed in Note 1, on January 18, 2022, the Company's Board of Directors approved the termination of the Plan. The Plan's termination was also approved by the Retirement Plan Committee on November 9, 2021. As a result, the Plan changed its basis of accounting as of December 31, 2022 and for the period subsequent to January 17, 2022 to liquidation basis ("In Liquidation") in accordance with U.S. GAAP. The accompanying financial statements of the Plan for the period January 1 to December 29, 2023 were prepared using the liquidation basis of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities and the actuarial present value of accumulated benefits at the date of the financial statements. Actual results could differ from those estimates.

### **Risks and Uncertainties**

Investment securities are exposed to various risks including, but not limited to, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

### **Investment Valuation and Income Recognition**

The Plan had no investments at December 29, 2023. Investments are reported at liquidation value at December 31, 2022 (In Liquidation). Under the Liquidation basis of accounting, investments are carried at the amount of cash that the Plan reasonably expects to receive upon liquidation. Liquidation value approximates fair value. Under the Ongoing basis of accounting the Plan utilizes prescribed guidance related to fair value measurements. This guidance stipulates a methodology to measure fair value for certain assets and liabilities recorded or disclosed in the Plan's Statements of Net Assets Available for Benefits. Fair value measurements consist of quoted prices in active markets for identical assets and liabilities (Level 1), significant other observable inputs including quoted prices for similar assets in active or inactive markets (Level 2), and significant unobservable inputs (Level 3). The Plan recognizes any transfers of assets and liabilities between levels at the end of each reporting period. There were no transfers between levels during the periods from January 1, 2023 to December 29, 2023 (In Liquidation), January 18, 2022 to December 31, 2022 (In Liquidation) or January 1, 2022 to January 17, 2022 (Ongoing).

The Plan also utilizes prescribed guidance related to disclosure requirements of investments in certain entities that calculate net asset value per share. In instances where fair market value is not easily determinable, this guidance allows fair value measurements based on the unadjusted net asset value per share or its equivalent. This guidance also requires additional disclosures about the nature and risks of investments including restrictions on an investor's ability to redeem its investments, any unfunded commitments, and the investment strategies of the underlying investments. The guidance also removes the requirement to disclose the investment strategies of investments whose fair market value measurement is based on the unadjusted fair market value per share of its equivalent as a practical expedient if that investment is in a fund that files a U.S. Department of Labor Form 5500 as a direct filing entity. Additionally, the Plan utilizes prescribed guidance which removes the requirement to categorize within the fair value hierarchy certain investments whose fair value measurement is based on the unadjusted fair market value per share or its equivalent as a practical expedient. Accordingly, such investments have not been classified in the fair value hierarchy. The fair value amount presented in the

fair value hierarchy tables (see Note 7) allow for the reconciliation of the fair value hierarchy to the Plan's Statements of Net Assets Available for Benefits.

Investments in securities (government debt securities) traded on a national securities exchange are valued at the last reported sales price on the last business day of the period or year. Registered investment company funds and corporate bond funds are valued at quoted market prices. The realized gains or losses on security transactions are recorded as the difference between proceeds received and cost. Cost is determined on the moving average basis. Purchases and sales of securities are recorded on a trade date basis. Interest income and capital gain distributions are accrued when earned. Dividend income is recorded on the ex-dividend date.

Listed securities for which no sale was reported on the last business day of the period or year are valued at the average of the last reported bid and asked prices. These investments are generally available for redemption.

Hedge funds are valued based on the proportionate interest in the underlying fund's net asset value, obtained from audited financial statements where the underlying net assets are stated at fair value. Hedge funds include multi-strategy funds (46% in 2022), hedged equity funds (45% in 2022), and international equity funds (9% in 2022). Multi-strategy funds focus on value, non-directional investments not correlated to broader markets, hedging, distressed securities, arbitrage, special purpose vehicles and other non-traditional investment opportunities. All of the multi-strategy funds are subject to quarterly redemption restrictions and specified notice periods. Hedged equity funds seek to maximize risk-adjusted total returns through long and short investments in domestic and /or international publicly traded equities. All of the hedged equity funds are subject to quarterly redemption restrictions following initial lock-up periods of up to three years from the initial closing date or up to two years following the final closing date certain of the underlying funds during which time no redemptions are permitted. International equity funds invest in high quality, attractively valued, non-U.S. growth companies of all market capitalizations. This fund is subject to bi-annual redemption restrictions, following initial lock-up periods of up to two years from the initial closing date of the underlying funds during which time no redemptions are permitted.

There were no unfunded commitments as of December 29, 2023 or December 31, 2022.

The methods described above may produce a fair value calculation that may not be indicative of net realized value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different value measurement at the reporting date.

### **Expenses**

Certain fees incurred by the Plan for investment management services are included in Net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than direct payment. JHTC participates in certain of these revenue sharing transactions. Other investment management service fees are paid through direct payment by the Plan. Such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan incurred administrative and investment management fees with parties-in-interest of \$276,419 (of which \$130,199 was included in the administrative expenses payable in liquidation on the Statement of Net Assets Available for Benefits at December 31, 2022) and \$177,620 for the period ended December 29, 2023 (In Liquidation) and for the period January 18, 2022 to December 31, 2022 (In Liquidation), respectively, which were not covered by revenue sharing arrangements. The Plan incurred no administrative and investment management fees with parties-in-interest for the period January 1, 2022 to January 17, 2022 (Ongoing).

### **Reclassifications**

Certain prior period amounts have been reclassified in order to conform to the 2023 financial statement presentation.

### **NOTE 3 - FUNDING POLICY**

The Company contributes such amounts as are necessary on an actuarial basis to provide the Plan with assets sufficient to meet the benefits to be paid to Plan participants. The Company's contributions for 2023 and 2022 exceeded the minimum funding requirements of ERISA (see Note 6).

### **NOTE 4 – PLAN TERMINATION**

As discussed in Note 1, the Company's Board of Directors approved a plan on January 18, 2022 to commence termination of the Plan, effective March 31, 2022. The Plan's termination was also approved by the Retirement Plan Committee on November 9, 2021. The Company communicated its intent to terminate the Plan to affected participants in January 2022. The Plan was amended to reflect the termination. The Company, Retirement Plan Committee and the plan administrator determined that the likelihood that either the Internal Revenue Service ("IRS") or the Pension Benefit Guaranty Corporation ("PBGC") would block the termination to be remote and liquidation was deemed imminent upon the approval to terminate the Plan by Company's Board of Directors and the Retirement Plan Committee.

The net assets of the Plan were allocated, as prescribed by the terms and provisions of the Plan, in accordance with ERISA and its regulations, generally, to provide the Plan benefits, subject to any required approval from the IRS. The Plan received approval for the termination from the IRS on December 16, 2022 (see Note 8).

The net assets were allocated to provide the following benefits in the order indicated:

- (1) Annuity benefits that former participants and beneficiaries have been receiving for at least three years prior to the termination of the Plan, or that participants would have received on such date had the participants retired on or before such date.
- (2) All other vested benefits.
- (3) All other benefits payable under the Plan.

Certain benefits under the Plan are insured by the PBGC as a result of the Plan termination. Generally, the PBGC guarantees most vested normal retirement age benefits, early retirement benefits and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. However, there is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees. For plan terminations occurring during 2022, the ceiling is approximately \$6,205 per month for participants aged 65 at the plan termination date who elect to receive their benefits in the form of a straight-life annuity. The ceiling is actuarially adjusted upward or downward for older or younger participants.

Accrued benefits were distributed from the Plan during 2023 at which point the PBGC guarantee was no longer applicable to the Plan participants.

In connection with the termination of the Plan, participants were offered the option between September 6, 2022 and November 1, 2022 to receive payment of their accrued benefit in form of a one-time lump sum payment to be paid in December 2022. From December 16, 2022 to December 30, 2022, \$160,266,357 was paid to participants who elected lump sum payments in the form of qualified rollovers and termination benefit payments. This amount is included in Benefits paid to participants on the Statements of Changes in Net Assets Available for Benefits.

In connection with the termination of the Plan, participants who chose not to take the one-time lump sum payment noted above had an annuity purchased on their behalf during 2023. On March 30, 2023, the Company entered into an agreement with Pacific Life Insurance Company ("Pacific Life") to issue a non-participating single premium buy-out group annuity separate account contract covering the benefits for certain Plan participants in the amount of \$162,102,849. This annuity purchase is included within the benefits paid to participants on the Statements of Changes in Net Assets Available for Benefits. The funds were transferred from the Plan to Pacific Life on April 3, 2023. Under the terms of the contract, Pacific Life assumed the liability for payment of benefits, investment and mortality risk. Pacific Life's responsibility for all future benefit annuity payments to Plan participants commence on June 1, 2023.

A cash contribution of \$11,100,000 was made by the Company on March 30, 2023 to affect the transaction of termination of the Plan and the purchase of the annuity contract. These contributions are included within the adjustments to the Statements of Changes in Net Assets Available for Benefits described in Note 6 upon the conversion to liquidation basis accounting on January 18, 2022. The termination activity of the Plan was completed on December 29, 2023 at which time excess Plan assets of \$3,330,836 reverted to the Company and the Trust was closed. The reversion of these excess Plan assets are included in the Statement of Changes in Plan Assets Available for Benefits for the period January 1, 2023 to December 29, 2023.

### NOTE 5 - ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are the future periodic payments that are attributable to the service employees have rendered. The present value of accumulated plan benefits as of January 1, 2023 (In Liquidation) is presented below.

### NOTE 7 - INVESTMENTS

The fair values of the Plan's investments as of December 31, 2022 (In Liquidation) are not presented in the fair value hierarchy as those investments are presented on a liquidation basis.

### NOTE 8 - TAX STATUS OF THE PLAN

On December 16, 2022 the Plan received a favorable determination from the IRS which found that the termination of the Plan does not affect the Plan's tax exempt status.

The Plan adopted guidance related to accounting for uncertainty in tax positions. There are no uncertain tax positions identified that would require recognition or disclosure in the Plan's financial statements. The Plan does not have any ongoing examinations. The Company believes the Plan is no longer subject to income tax examinations for years prior to 2020.

### NOTE 9 – ANNUITY CONTRACTS

In addition to assets available for benefits, the Plan purchased annuity contracts from insurance companies to provide benefit payments for certain members of the Plan. Under the terms of these contracts, the insurance companies have assumed the liability for payment of those benefits and all investment and mortality risk. Accordingly, no valuation is assigned to these contracts in the Statements

of Net Assets Available for Benefits and the related benefits are excluded from the actuarially determined value of vested benefits.

Annuity contracts of \$162,150,141, \$1,111,911 and \$177,876 were purchased during the period January 1, 2023 to December 29, 2023 (In Liquidation) and the periods of January 18, 2022 to December 31, 2022 (In Liquidation), January 1, 2022 to January 17, 2022 (Ongoing), respectively, and were included with Benefits paid to participants on the Statement of Changes in Net Assets Available for Benefits.
