Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed the audits of the accompanying financial statements of Washington-Idaho Operating Engineers and Employers Health and Security Trust Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of July 31, 2022 and December 31, 2021, and the related statements of changes in net assets available for benefits for the six-month period and year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the July 31, 2022 and December 31, 2021, financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the six-month period ended July 31, 2022 and year ended December 31, 2021, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1 – Description of the Plan

The following description of the Washington-Idaho Operating Engineers and Employers Health and Security Trust Fund (the Plan) provides only general information. Participants should refer to the plan document for a comprehensive description of the Plan’s provisions.

- a. **General** – The Plan and related trust were established on August 1, 1986, by a merger of the Engineers –A.G.C. Health and Security Trust Fund and the Idaho Branch, Inc. A.G.C. – Engineers Trust Fund. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Effective August 1, 2022, the Plan merged into Locals 302 and 612 of the International Union of Operating Engineers Construction Industry Health and Security Plan. Upon the merger, the Washington-Idaho Operating Engineers and Employers Health and Security Trust Fund was formally terminated.
- b. **Eligibility** – The Plan covers persons employed under a collective bargaining agreement between an employer and Local Union No. 370. Nonbargaining unit employees of contributing employers may also participate in the Plan. A contributing employer is an employer that is signatory to a collective bargaining agreement which requires contributions to the Plan. An employee initially becomes eligible for the Plan on the first date of the second calendar month following the calendar month in which they accumulate 200 reported and paid hours. Once the minimum eligibility requirement has been established, the employee will continue to be covered as long as they have 200 hours or more in their hour bank.
- c. **Contributions** – Contributions to the Plan are made by employers for each compensable hour worked by employees in accordance with the terms of respective collective bargaining agreements. All contributions are deposited directly by employers with the depository bank.

The costs of providing postretirement benefits are shared by the Plan’s participating employers and retirees. In addition to deductibles and copayments, retiree contributions were as follows:

Participant Group	2021 Retiree Contribution
Pre-65 Retirees	Retirees contribute 48% of estimated annual cost of providing their postretirement benefits
Post-65 Retirees	Retirees contribute 79% of estimated annual cost of providing their postretirement benefits

Note 1 – Description of the Plan (Continued)

- d. **Benefits** – The Plan provides health benefits (accident, weekly indemnity, major medical, prescription drug, dental, vision, and auditory) covering certain active and retired members and their dependents who have accumulated in the current year or prior years credit amounts (expressed in hours) in excess of hours required for current coverage. There were no changes in benefits. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).
- e. **Insured benefits** – The Plan fully insures the life insurance benefits, accidental death and disability benefits, and certain vision and dental benefits. The Plan purchases annual insurance contracts for these insured benefits.
- f. **Experience-rated contracts** – Certain insurance contracts are subject to experience-rating adjustments. Experience ratings (calculated as the difference between premiums paid and the total of claims paid, and fees charged by the insurance company) are determined by the insurance company in the following year and may result in a premium surplus or deficit.
- g. **Stop-loss coverage** – The Plan entered into stop-loss insurance arrangements in an effort to limit its exposure for self-insured benefits. The arrangement covers claims over a specific dollar amount set at \$375,000 for the six-month period ended July 31, 2022 and year ended December 31, 2021, respectively. The Plan utilized the HCC Life Insurance Company for stop-loss coverage.
- h. **Self-insured benefits** – All remaining benefits are self-insured. The claims for self-insured benefits are processed by the Plan’s third-party claims processors under administrative services only arrangements. The claims processors pay claims directly to or on behalf of participants. Despite the Plan’s utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.
- i. **Refunds** – The Plan utilizes a pharmacy benefit manager which periodically makes refunds to the Plan based on the Plan’s actual utilization pattern of specific drugs.
- j. **Administration** – The Plan is administered by a Board of Trustees that is assisted by a contract administration organization. Administrative expenses are borne by the Plan.

Note 2 – Summary of Significant Accounting Policies

A summary of the Plan’s significant accounting policies applied in the preparation of the accompanying financial statements follows:

- a. **Basis of accounting** – The accounting records of the Plan are prepared on the accrual basis of accounting.

Note 2 – Summary of Significant Accounting Policies (Continued)

- b. **Investment valuation and income recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Board of Trustees determines the Plan’s valuation policies utilizing information provided by the investment advisers, and custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

- c. **Employer contributions receivable** – As of July 31, 2022, employers were liable for contributions based upon time worked from January 1, 2022 to July 31, 2022. As of December 31, 2021, employers were liable for contributions based upon time worked from January 1, 2021 to December 31, 2021. Estimated contributions have been recorded as a receivable.
- d. **Payment of benefits** – Claim payments are recorded when paid by the third-party claims processors. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as payable to claims administrators in the accompanying statements of net assets available for benefits.

Premiums paid by the Plan are recorded as premium payments in the accompanying statements of changes in net assets available for benefits.

- e. **Claims incurred but not reported** – The Plan self-insures all medical and drug benefits. The Plan is covered under a stop-loss agreement with an insurance company for individual or aggregated medical claims in excess of a specific amount. The reserve for claims incurred but not reported (IBNR) has been estimated; such amounts were \$2,117,241, and \$3,877,300 as of July 31, 2022 and December 31, 2021, respectively. The IBNR was estimated using Plan provisions, the number of eligible participants, and the actual lag patterns of the Plan. These amounts are paid by the Plan only if claims are submitted and approved for payment.
- f. **Accumulated eligibility credits** – The Plan is required to provide benefits to employees if they have accumulated, in current or prior years, credit amounts (expressed in hours) in excess of the 200 hours required for eligibility. Once the minimum eligibility requirement has been established, 130 hours are deducted from the employee’s account for each month the employee is insured. A maximum of 850 hours may be accumulated by an employee. The liability for such benefits is adjusted at year end based on the bank hour credits estimated at that date multiplied by the current insurance premium rate. The estimated amount of these benefits has been provided for in the financial statements.
- g. **Stop-loss** – Premiums for stop-loss insurance are included in insurance premiums paid in the accompanying statements of changes in net assets available for benefits. Stop-loss refunds totaling \$-0- have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the six-month period ended July 31, 2022 and year ended December 31, 2021.

Note 2 – Summary of Significant Accounting Policies (Continued)

- h. **Refunds** – Refunds are recorded when earned. Refunds due as of the financial statement date are reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates were \$192,270, and \$1,505,379 for the six-month period ended July 31, 2022 and year ended December 31, 2021, respectively.
- i. **Use of estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.
- j. **Subsequent events** – Subsequent events were evaluated through April 30, 2024, which is the date the financial statements were available to be issued. Effective August 1, 2022, the Plan merged into Locals 302 and 612 of the International Union of Operating Engineers Construction Industry Health and Security Plan.

Note 3 – Information Certified by the Plan Trustee

As permitted by Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the plan administrator has elected that information certified by U.S. Bank, N.A., the custodian of the Plan, not be subject to any auditing procedures except for comparing such information to the related information contained in the accompanying financial statements and supplemental schedule. The following information has been certified by U.S. Bank, N.A., as complete and accurate:

- a) Investments as indicated on the statements of net assets available for benefits;
- b) Net depreciation in fair value of investments as indicated on the statements of changes in net assets available for benefits; and
- c) Supplemental schedule – assets held for investment.

Note 4 – Benefit Obligations

The Plan’s benefit obligations include claims incurred but not reported, accumulated eligibility credits, and postretirement benefit obligations, which represent the actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents, and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee’s full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee’s service in the industry rendered to the valuation date.

Note 4 – Benefit Obligations (Continued)

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

In the December 31, 2021 and 2020, valuations, for measurement purposes for pre-65 retirees, a 6.4% annual trend rate of increase in the per capita cost of covered medical benefits was assumed in year one with the rate gradually decreasing to 4.2% by year 80, and for post-65 retirees, a 6.1% annual trend rate of increase in the per capita cost of covered medical benefits was assumed in year one with the rate gradually decreasing to 4.5% by year 80.

The following were other significant assumptions used in the valuations as of December 31, 2021:

The change in assumptions that resulted in a decrease of \$32,425,000 in the Plan's postretirement benefit obligations for the year ended December 31, 2021, was due to increasing the discount rate used to value the Plan's benefit obligations, changes in claims costs, retiree contributions and future trends, the decrease in the active coverage election assumption from 65% to 50% at retirement and a change in the mortality assumptions.

The change in assumptions that resulted in an increase of \$5,263,000 in the Plan's postretirement benefit obligations for the year ended December 31, 2021, was due to decreasing the discount rate used to value the Plan's benefit obligations.

The weighted-average health care cost-trend rate assumption has a significant effect on the amounts reported for postretirement benefit obligations. If the assumed rate increased by one percentage point, it would increase the obligation as of December 31, 2021, by approximately \$2,519,000.

Note 5 – Fair Value Measurements

The Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at July 31, 2022 and December 31, 2021.

Level 1 – Interest-bearing cash or money market funds are valued at the closing price reported on the active market. The mutual funds are valued at the net asset value of shares held by the Plan at period and year end.

Level 2 – The Plan has no investments that are classified as Level 2 for the six-month period ended July 31, 2022 or year ended December 31, 2021.

Level 3 – The Plan has no investments that are classified as Level 3 for the six-month period ended July 31, 2022 or year ended December 31, 2021.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7 – Related-Party Transactions

Welfare Pension Administration Services, Inc., is a participating employer of the Plan in addition to providing services as a third-party administrator. All plan benefits and obligations relating to Welfare Pension Administration Services, Inc., are administered in accordance with the plan document. Administrative fees paid in 2022 and 2021 were \$101,719 and \$154,449, respectively.

The Plan has two related organizations with common trustees: Engineers – A.G.C. Pension Plan of the Inland Empire and Western States Operating Engineers Institute of Training – Apprenticeship and Training Trust Fund. Fees were paid and allocated to the related organizations in accordance with agreements authorized by the Board of Trustees.

Note 8 – Party-in-Interest Transactions

Certain transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 9 – Concentration of Risk

The Plan maintains several accounts at one financial institution which, at July 31, 2022, are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, the Plan's cash balances may exceed the FDIC insurance limit. Market value of securities is dependent on the ability of the issuer to honor its contractual commitments and the investments are subject to changes in market values.

Note 10 – Tax Status

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC) and, accordingly, the trust's net investment income is exempt from income taxes. The trust obtained an exemption letter on March 8, 1989, in which the Internal Revenue Service (IRS) stated that the trust, as then designed, was in compliance with the applicable requirements of the IRC. The plan administrator believes that the trust, as amended, continues to qualify and to operate in accordance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has analyzed the tax positions taken by the Plan and has concluded that as of July 31, 2022 and December 31, 2021, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 11 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

The liability for claims incurred but not reported and the actuarial present value of the Plan's benefit obligations are estimates. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 12 – Plan Termination

The trust agreement shall continue in existence until such time as it is terminated by one of the following means: (a) action of the signatory parties, or (b) the termination of all collective bargaining agreements and special agreements requiring contributions to this trust provided, however, a collective bargaining agreement shall not be terminated, in a strike or lockout situation, unless said strike or lockout continues for more than six months. In the event the Plan terminates, assets remaining after payment of all expenses shall be used for the continuance of benefits until such assets have been depleted. If the assets are insufficient to pay all accrued benefits and liabilities, distribution of the assets shall be made in accordance with Plan termination provisions of ERISA and applicable government regulations.

Note 13 – Plan Merger

Effective August 5, 2022, the Plan merged into Locals 302 and 612 of the International Union of Operating Engineers Construction Industry Health and Security Plan. Upon the merger, the Washington-Idaho Operating Engineers and Employers Health and Security Trust Fund was formally terminated.


