Independent Auditors' Report

To the Participants and Trustees of

Opinion

We have audited the accompanying financial statements of the C&E Sales, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits in liquidation as of March 20, 2024 (short plan year) and September 30, 2023, and the related statement of changes in net assets available for benefits in liquidation for the period ended March 20, 2024, and the related notes to the financial statements in liquidation.

In our opinion, the financial statements referred to in the first paragraph present fairly, in all material respects, the net assets available for benefits in liquidation of the C&E Sales, Inc. Profit Sharing Plan as of March 20, 2024 and September 30, 2023, and the changes in its net assets available for benefits in liquidation for the period ended March 20, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the C&E Sales, Inc. Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Emphasis of Matter - Basis of Accounting

As described in Note A to the financial statements, the governing body of C&E Sales, Inc. Profit Sharing Plan approved a plan of liquidation on June 29, 2021, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting to the liquidation basis. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the plan's transactions that are presented and disclosed in the financial statements in liquidation are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. NOTE A - DESCRIPTION OF THE PLAN

The following description of the C&E Sales, Inc. Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of C&E Sales, Inc. (the Company, Employer and Plan Sponsor) upon hire. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Termination and Liquidation

The governing body of the Plan approved the termination of the Plan effective June 29, 2021. Plan Management determined liquidation to be imminent upon the decision to terminate the Plan. Final distributions were made in March 2024 based on all participants being 100% vested.

Eligibility

Prior to the termination of the Plan, all eligible employees were eligible to participate in the 401(k) elective deferrals. For participants to receive a discretionary profit sharing contribution they had to be 21 years of age or older and had to have completed at least one year of service during the Plan Year (1,000 hours). The allowable profit sharing entry date was October 1 of the Plan Year after eligibility requirements were met.

Contributions

- (a) *Participant's voluntary salary reductions and rollover contributions.* Each year, participants could have contributed to the Plan a percentage of their compensation which was not to exceed Internal Revenue Service limitations. Participants could have also contributed amounts representing distributions from other qualified defined benefit or contribution plans.

- (b) *Discretionary profit sharing contributions.* The Company may have, in its sole discretion, made discretionary profit sharing contributions to the Plan on behalf of each participant who was employed by the Company on the last day of the Plan Year. Discretionary contributions were to be allocated in an amount designated by the Company's board of directors to be allocated to two groups. Group One consisted of the four owners of the Plan Sponsor; Group Two consisted of all participants who were not members of Group One. Contributions to Groups One and Two were allocated among group members in the ratio that each such participant's compensation bore to the compensation of all members of the group who were eligible to receive allocations of discretionary company contributions. There were no discretionary contributions paid or accrued for the period ended March 20, 2024.
- (c) *Non-elective contribution.* The Plan Sponsor could have elect to make a non-elective contribution for purposes of complying with the Safe Harbor requirement, as stated in the Plan provisions. There were no non-elective Safe Harbor contributions for the period ended March 20, 2024. There was no age or year of service requirement for participating employees to receive these contributions.

Participant Accounts

Prior to the termination of the Plan, each participant's account was credited or charged with the above contributions, transfers, plan earnings, forfeitures, and plan expenses. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account balance. As a result of the termination of the Plan, no further contributions are required by the Company, and no participants shall accrue additional benefits under the Plan, other than on account of the allocations of subsequent investment gains or losses with respect to the participant's account.

Notes Receivable from Participants

Prior to the termination of the Plan, participants could borrow from the vested portion of their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years or up to ten years for the purchase of a primary residence. The loans were secured by the participant's account balance and bore interest at a rate commensurate with prevailing rates. Principal and interest were paid ratably through monthly payroll deductions.

Vesting

Prior to the termination of the Plan, participants were 100% vested in employee and rollover contributions and employer non-elective contributions. In addition, a participant became fully vested upon attainment of normal retirement age or upon death or disability while an employee of the Plan Sponsor. The employer contributions vested according to the following schedule:

As a result of the termination of the Plan, each participant with an undistributed account balance as of June 29, 2021, that had not previously been forfeited in accordance with the terms of the Plan became 100% vested in such account balance.

Forfeited Accounts

Prior to termination of the Plan, amounts forfeited from a participant's account were periodically used to reduce employer discretionary profit sharing contributions or were reallocated to participants. Forfeitures of \$765 were used to pay plan expenses during the Plan period ended March 20, 2024.

Payment of Benefits

Prior to the termination of the Plan, upon termination of service for any reason, a participant received either the value of the participant's vested interest in his or her account in the form of a joint and survivor annuity or a lump sum amount equal to the value of the participant's vested interest in his or her account. Benefits are recorded when paid.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

As a result of the termination of the Plan, the accompanying financial statements have been prepared in accordance with the liquidation basis of accounting.

The liquidation basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement value. The estimated net realizable cash value for investments would be equivalent to fair value and no adjustment to carrying amounts was necessary.

Investment Valuation and Income Recognition

As a result of the termination of the Plan, the Plan's investments are stated at liquidation value, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Capital gain distributions are included in interest and dividend income.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Investment advisory fees were paid out of the Plan's assets. Prior to the Plan termination date, all other expenses of the Plan were paid by the Plan Sponsor. Effective as of the Plan termination date of June 29, 2021, all expenses of the Plan are to be paid out of the Plan's assets.

Amendments

Effective June 29, 2021, the Plan was amended to terminate the Plan. As a result, as of June 29, 2021, (a) no individual shall be eligible to become a participant or otherwise enter the Plan; (b) no further contributions to the Trust shall be required by the Company; (c) no participant shall accrue additional benefits under the Plan, other than on account of the allocations of subsequent investment gains or losses with respect to the participant's cash account; (d) each participant with an undistributed account balance as of June 29, 2021, that has not previously been forfeited in accordance with the terms of the Plan shall become 100% vested in such account balance; and (e) participant accounts shall be distributed as soon as administratively feasible.

NOTE C - CONCENTRATION OF CREDIT RISK

The Plan maintains its cash balances in various money market funds. At various times during the year, some or all of these funds may be uninsured or exceed insurance limits.

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820-10, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 - Inputs to the valuation methodologies are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodologies include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodologies are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at March 20, 2024 and September 30, 2023.

Money market funds - Valued at the net asset value (NAV) of shares held by the Plan at year-end, as reported to the Plan by the trustee. A fund's NAV reflects an exit price, is the same for all holders of the fund, and provides the basis for current transactions.

Alternative funds - Valued based on the NAV per share, without further adjustment. NAV is based upon the fair value of the underlying investments, such as collective funds, hedge funds, and other types of private investments with underlying investment holdings. The NAV is used as a practical expedient to estimated fair value and is not readily determinable.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments were managed by Morgan Stanley. Morgan Stanley was the trustee of the Plan and, therefore, these transactions qualified as party-in-interest. Fees paid by the Plan for the investment management services provided by Morgan Stanley amounted to \$1,096 for the period ended March 20, 2024.

NOTE F - INCOME TAX STATUS

Effective September 30, 2015, the Plan Sponsor adopted a Sungard Business Systems, LLC prototype plan dated March 30, 2012. Sungard Business Systems, LLC obtained an Advisory Letter on March 31, 2014, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended and restated since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, no income taxes have been provided for in the financial statements.

Accounting principles generally accepted in the United States of America require Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 20, 2024, there are no uncertain positions taken that would require recognition of a liability (asset) or disclosure in the financial statements. Although terminated, the Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

NOTE G - PLAN TERMINATION

The governing body of the Plan approved the termination of the Plan effective June 29, 2021. All participant balances were distributed as of March 20, 2024.

NOTE H - NON-COMPLIANCE

After the governing body of the Plan approved the termination of the Plan effective June 29, 2021, and Plan Management determined liquidation to be imminent, the Plan's ERISA bond was not renewed and, therefore, there was no bond in place for the short period ending March 20, 2024 or the Plan year ending September 30, 2023.

NOTE I - SUBSEQUENT EVENTS

Subsequent events were evaluated through June 27, 2024, which is the date the financial statements were available to be issued.
