## **Independent Auditor's Report**

To the Trustees  
Alpine Special Treatment Center 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Alpine Special Treatment Center 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets in liquidation as of November 30, 2023 and December 31, 2022 and the related statement of changes in net assets in liquidation for the period January 1, 2023 to November 30, 2023 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Alpine Special Treatment Center 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of November 30, 2023 and for the period January 1, 2023 to November 30, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Alpine Special Treatment Center 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Emphasis of Matter - Basis of Accounting**

As discussed in Note 7 to the financial statements, the Plan sponsor elected during 2022 to terminate the Plan, and management determined liquidation is imminent. As a result, the Plan's 2023 and 2022 financial statements are prepared on the liquidation basis of accounting. Also, as described in Note 7, the net assets of the Plan were fully distributed as of November 30, 2023. Our opinion is not modified with respect to these matters.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. **Note 1 - Description of Plan:**

The following brief description of Alpine Special Treatment Center 401(k) Plan (the “Plan”) is provided for general information purposes only. For additional information concerning the Plan’s provisions, participants should refer to the Plan Agreement and Summary Plan Description.

**General**

The Plan is a defined contribution plan covering eligible employees of Alpine Special Treatment Center (the “Company” and “Employer”) who are at least 18 years of age and who elect to participate in the Plan. An employee can become a participant in the Plan and begin making elective deferrals and are eligible for employer matching or safe harbor contributions on their hire date. Employees are also eligible for employer profit sharing contributions on their hire date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company has appointed Lincoln National Life Insurance Company as the Custodian of the Plan assets with authority over management and investment of Plan assets and has adopted The Retirement Advantage Non-Standardized Pre-Approved Profit Sharing Plan with CODA. The Employer has amended and restated the Plan, which was originally adopted January 1, 1999. The effective date of this amended Plan is August 1, 2019. The Plan was restated effective January 1, 2021.

**Contributions**

Each year participants may contribute up to the maximum dollar amount established by the Internal Revenue Code (IRC) of pretax annual compensation, as defined in the Plan in the form of pre-tax elective deferrals. Participants age 50 and older may make catch-up contributions to a maximum dollar amount established by the IRC. Participants may also contribute amounts representing distributions from other tax-qualified plans (rollovers). The Company makes a safe harbor matching contribution equal to 100% of participant contributions less-than-or-equal-to 3% and 50% of participant contributions greater than 3%, but less-than-or-equal-to 5%.

The Company may also make discretionary profit-sharing contributions on an annual basis to eligible participants. The Company contributed 0% of eligible compensation as a discretionary profit sharing contribution to employees employed on the last day of the Plan year for the period January 1 through November 30, 2023 and for the year ended December 31, 2022.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution, allocation of the participant’s share of the Company’s matching contributions (including discretionary contributions, if any), and the participant’s share of the Plan’s earnings and losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers a variety of pooled separate accounts and a guaranteed-interest account (“GIA”).

**Note 1 - Description of Plan: (Continued)**

**Forfeitures**

Forfeitures are used to reduce the Company contributions for the Plan year in which the forfeiture occurs. Forfeited balances totaled \$-0- and \$10,350 at November 30, 2023 and December 31, 2022.

**Vesting**

Participants are immediately 100% vested in their contributions, the Company's matching contributions and the Company's discretionary profit-sharing contributions.

**Notes Receivable from Participants**

Participants may borrow from their vested accounts up to a maximum of \$50,000 (reduced by the amount, if any, of the highest outstanding balance of loans from the Plan during the preceding one-year period ending on the day before the date on which the loan is made) or 50% of their vested account balance, whichever is less, subject to certain restrictions, in accordance with borrowing procedures established by the Company. The loans are secured by up to one-half of the vested account balance in the participant's account, and such other security as the Company may require under certain circumstances. Loans bear interest at the prime rate plus 1%. Interest rates on loans were 5.25% to 6.50%, at December 31, 2022. There were no loans at November 30, 2023.

**Payment of Benefits**

Upon termination of service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants with vested benefits of \$1,000 or less will receive a lump-sum distribution. Participants with vested benefits of greater than \$1,000 may elect to delay their distributions, but distributions are required to begin no later than April 1st following the end of the year in which the Participant reaches age 72.

The Plan permits hardship withdrawals in certain circumstances. Following a hardship withdrawal, a participant must wait six months before resuming their contributions to the Plan.

**Note 2 - Significant Accounting Policies:**

**Accounting Method**

Due to the decision to terminate the Plan during 2022, the Plan's financial statements have been prepared using the liquidation basis of accounting.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Fair Value Measurements**

Fair value accounting standards define fair value, establish a framework for measuring fair value, outline a fair value hierarchy based on inputs used to measure fair value and enhance disclosure requirements for fair value measurements. The fair value hierarchy distinguishes between market participant assumptions based on market data obtained from sources independent of the reporting entity (observable inputs that are classified within Level 1 or 2 of the hierarchy) and the reporting entity's own assumptions about market participant assumptions (unobservable inputs classified within Level 3 of the hierarchy).

- Level 1 inputs are quoted prices in active markets for identical investments that the Plan has the ability to access at the measurement date.
- Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the investment, either directly or indirectly.
- Level 3 inputs are unobservable inputs for the investment.

The Plan's statements of net assets available for benefits includes the following financial instruments that are required to be measured at fair value on a recurring basis:

- Pooled separate accounts ("PSA") represent units held in pooled separate accounts that are valued using the net asset value ("NAV") of the fund. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. The NAV of a PSA is calculated based on a compilation of primarily observable market information. The number of units of the fund that are outstanding on the calculation date is derived from observable purchase and redemption activity in the fund.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants**

Participant loans are reported at their unpaid principal balances plus any accrued and unpaid interest.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Expenses of the Plan, including legal, audit, administrative, and trustee expenses, are generally paid by the Company, with the exception of certain administrative expenses which are paid for by the Plan and charged to participants' accounts. The Plan incurred \$42,007 of administrative expenses for the period January 1, 2023 to November 30, 2023. Participants with loan balances pay an origination fee for loan administration from their respective Plan accounts.

**Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term, and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through June 19, 2024, the date the financial statements were available to be issued.

**Note 3 - Fair Value Measurements:**

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of November 30, 2023 and December 31, 2022. There are no participant redemptions restrictions for these investments; the redemption notice period is applicable only to the Plan.

**Note 4 - Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to the Plan's investments disclosed in the accompanying financial statements, including investments held at November 30, 2023, net appreciation in fair value of investments, interest and dividend income and notes receivable for the period January 1, 2023 to November 30, 2023, was obtained or derived from information certified as complete and accurate by Lincoln National Life Insurance Company, the Custodian of the Plan.

**Note 5 - Guaranteed Interest Contract:**

The Plan has a fully benefit-responsive guaranteed investment contract with Lincoln National Life Insurance Company ("Lincoln") totaling \$-0- and \$103,307 at December 31, 2023 and 2022, respectively. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal, and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria, and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes, or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; (4) a material amendment to the agreement without the consent of the issuer.

**Note 6 - Party-In-Interest Transaction:**

Fees paid by the Plan for investment management services are included in net appreciation in fair values of investments. Plan investments consist of pooled separate accounts managed by Lincoln National Life Insurance Company, the Custodian, as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan totaled \$42,007 for the period January 1, 2023 to November 30, 2023.

**Note 7 - Plan Termination:**

The Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Effective November 30, 2023 the Plan was terminated. As of August 2022, employee and employer contributions into the Plan ceased. Participant investment accounts continued to earn interest and dividends and appreciate in value until the participants' account balances were distributed.

**Note 8 - Tax Status:**

The Company has adopted The Retirement Advantage Non-Standardized Pre-Approved Profit Sharing Plan with CODA. This Plan received a favorable opinion letter from the Internal Revenue Service based on its submission dated December 31, 2018, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan believes that it has appropriate support for any tax position taken, and, as such, does not have any uncertain tax positions that are material to the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examination for years prior to 2019.
