INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Von Housens' Motors, a California Corp 401(k) Shared Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1: Description of Plan

The following description of the Von Housen Motors 401(k) Shared Savings Plan provides only general information. Participants should refer to the Plan's Adoption Agreement and Summary Plan Description for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering all full-time employees of the participating Companies except collective bargaining employees, Porters, and nonresident aliens who do not receive United States source income, who have 3 months of service and are age 21 or older. It is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA). The participating companies ("The Company") are Mercedes Benz of El Dorado Hills, Mercedes Benz of Rocklin, Mercedes Benz of Sacramento, and Von Housen Management Company.

Administration: Under the terms of the Plan, certain corporate officers of the sponsor are designated as plan trustee. The Plan has contracted with John Hancock Life Insurance Company USA ("John Hancock"), to act as custodian, and Associated Pension Consultants ("APC") as the third-party administrator to manage certain operations of the plan and to process and maintain certain participant records.

Contributions - Each year, participants may contribute from 1% to 100% of included compensation, as defined in the Plan, and subject to IRS annual limits. Participants may also contribute amounts representing distributions from other qualified plans. The Company may make matching contributions equal to a discretionary percentage, to be determined by Employer, of the Participant's elective deferral. For the plan year ending December 31, 2023, there were no employee or employer contributions as the plan was terminated in December 2022.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contribution, if any, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expense. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants should refer to the mutual funds' prospectuses and the Plan's fee disclosure for details of these fees and investment expenses for each mutual fund.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is one hundred percent vested after six years of service.

Forfeitures - The total non-vested portion of terminated participants' account balances are used by the plan sponsor to pay plan expenses or allocated to participants as additional employer matching contributions. During the plan year ended October 13, 2023, there were \$0 of forfeitures generated, \$34,121 was used to pay fees. As of October 13, 2023 there is a balance of \$0 in unused forfeitures available to reduce future employer contributions, cover plan expenses, or be allocated to participants as an additional employer contribution.

Payment of Benefits - Upon termination of employment, retirement, disability, or death, a participant or their beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account as a lump sum distribution. In service distributions may also be made due to financial hardship as defined by the Plan. All investments available in the plan with John Hancock allow for daily redemptions with no redemption notice period required, with the exception of the Stable Value Fund which may delay redemptions up to 30 days under certain circumstances (see note 8).

Notes Receivable from Participant - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant notes fund. Loan balances may be paid over a reasonable period of time not to exceed five years, except in the case that the proceeds of the loan are used to acquire a dwelling to be used as the Participants principal residence. The loans are secured by the balance in the participant's account and bear a commercially reasonable rate of interest established by the Plan Administrator.

Note 1: Description of Plan (continued)

Investment Options - Upon enrollment in the Plan, a participant may direct employee contributions in various increments to the investments administered by John Hancock. Participants may change their investments daily and choose from a variety of mutual fund investments or the John Hancock Stable Value CIT.

Amendments - There were no amendments to the Plan during the 2023 plan year.

Note 2: Summary of Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting. Assets and liabilities are stated at liquidation value as of October 13, 2023 and December 31, 2022, which is substantially equivalent to fair value for the assets held in the Plan. There are no accrued costs or income related to the Plan's liquidation.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that effect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation - The Plan's investments consist of pooled separate accounts that are stated at fair value, and the Stable Value fund that is stated at contract value, as reported by John Hancock USA.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Risks and Uncertainties - The Plan provides for various investment options which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is possible that changes in the values of investments will occur in the near term and would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Purchases and sales of securities - Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits - Benefits are recorded when paid.

Subsequent Events - Plan management has evaluated subsequent events through May 1, 2024, the date the financial statements were available to be issued.

Note 3: Information Certified by Custodian

John Hancock USA, the Custodian of the Plan, has certified as to the completeness and accuracy of all investments, cash, and participant notes receivable reflected on the accompanying Statements of Net Assets Available for Benefits as of October 13, 2023 and December 31, 2022, the investment activities and interest on participant notes reflected on the Statement of Changes in Net Assets Available for Benefits for the period from January 1, 2023 to October 13, 2023, and all investment information reflected in the supplemental Schedule Of Assets (Held At End Of Year) as of October 13, 2023, in accordance with 29 CFR 2520.103-8(c) of the Department of Labor's Rules and Regulation for Reporting and Disclosure under the Employee Retirement

Note 4: Plan Termination

On December 22, 2022, the plan sponsor terminated the plan effective December 31, 2022. The Company's assets were sold to another company. As a result of the plan's termination, all participants became 100% vested in any employer contributions to the plan. Subsequent to year end, in the first ten months of the 2023 plan year, all plan assets were either distributed to terminating participants, or transferred to the acquiring company's 401(k) plan for participants remaining with the acquiring company.

Note 5: Tax Status

The Plan uses the prototype plan document Associated Pension Consultants Defined Contribution Pre-Approved Plan, sponsored by Associated Pension Consultants who received an opinion letter from the IRS dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administration has analyzed the tax positions taken by the plan, and has concluded that as of October 13, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 6: Administrative and Investment Fees

The record keeper, John Hancock, and the Plan's third party administrator, APC, received \$40,308 and \$7,147, respectively, in direct fees paid from plan assets during 2023. \$25,923 was paid to the plan sponsor to pay professional fees. John Hancock receives direct record keeping compensation of .45% of total invested assets and certain participant transaction fees. John Hancock does not receive indirect fees from the underlying mutual fund investments. Total mutual fund expenses, range from .05% to .76%, dependent on funds selected.

Note 7: Fair Value Measurements

Financial Accounting Standards Board ASC 820-10 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 13, 2023 and December 31, 2022.

Pooled Separate Accounts: Valued at fair value as determined by John Hancock, based on the number of units held and quoted market prices of the underlying mutual fund investments.

Note 8: John Hancock Stable Value Fund

Contributions to the John Hancock Stable Value Fund are invested solely in shares of the John Hancock Stable Value Fund Collective Trust, a trust managed by John Hancock. The John Hancock Stable Value Fund Collective Trust seeks to preserve principal and provide book value liquidity on a daily basis for plan-permitted, participant-directed withdrawals while maintaining a competitive rate of interest. There is no guaranteed minimum crediting rate. The investment is considered fully benefit responsive and normal participant withdrawals and transfers from the Stable Value Fund are processed at contract value. If the Plan were to request a liquidation, surrender charges and/or market value adjustments may apply. The Trustee of the underlying John Hancock Stable Value Fund Collective Trust has the right to delay any participant-initiated withdrawal for up to 30 days if it determines that immediate withdrawal may have and adverse impact on the Trust. In addition, the Trust has the right to delay, for up to 12 months, any other withdrawal, including the withdrawal of all or a portion of the Plan's investment in the fund. The Stable Value Fund is stated at contract value as determined by John Hancock as follows:

Note 9: Party-In-Interest Transactions

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Some of the plan investments are pooled separate accounts issued by John Hancock, the trustee. John Hancock receives fees from these pooled separate accounts, and therefore, these transactions qualify as party-in-interest transactions. John Hancock receives direct compensation in the form of a .45% asset charge to participant accounts. Notes receivable from participants also reflect party-in-interest transactions.
