Independent Auditor's Report

To the Trustees and Plan Administrator
ESAM Inc. 401K Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of ESAM Inc. 401K Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2022 and 2021, and the related statement of changes in net assets available for benefits for the year ended December 31, 2022, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2022 and 2021 and for the year ended December 31, 2022 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

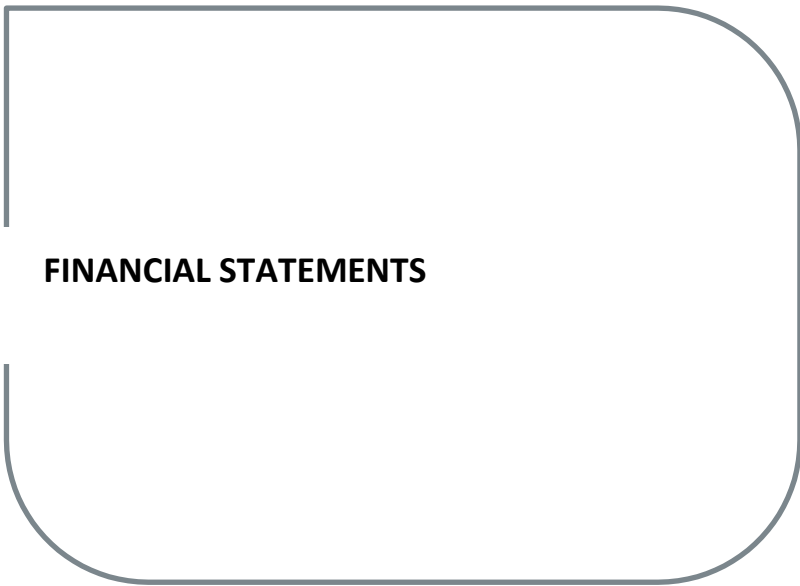

NOTE 1 - DESCRIPTION OF PLAN

The following description of the ESAM Inc. 401K Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, with an effective date of January 1, 2019, is a defined contribution plan covering all eligible employees, who are not non-resident aliens or residents of Puerto Rico of ESAM Inc. and effective January 1, 2021, Bay Computer Associates (BCA) (the “Employer”). Participants of the Plan can elect to make tax-deferred contributions that may be partially matched by the employers. Employees become eligible to participate in the salary deferral portion of the plan after attaining age twenty-one and completion of twelve consecutive months of service (with a minimum of 1,000 hours). Employees become eligible to participate in the employer matching portion of the plan after becoming eligible for salary deferrals described above and being an active employee during the Allocation Period. Entry dates are the first day of the month coinciding, or next following date, eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

On January 6, 2019, Bay Computer Associates (BCA) was acquired by ESAM Holding Company, Inc., the parent company of ESAM Inc. This acquisition created a Controlled Group which made the employees of Bay Company Associates eligible to join ESAM Inc.’s existing 401K retirement plan effective January 1, 2021. It was further agreed that all BCA employees hired prior to the effective date would have immediate participation eligibility and have full vesting of any previous employer contributions.

Plan Merger

Effective December 31, 2022, the Plan, including all assets (merger assets) and liabilities, were merged into and with the Impact Electronics Solutions 401(k) Plan (new Plan) with the participants of the Plan becoming participants in the Impact Electronics Solutions 401(k) Plan. The actual transfer date of the Plan investments was February 1, 2023 and totaled \$1,170,199. The merger assets will be increased (decreased) in the new Plan for the investment gains (loss) and expenses incurred from the merger effective date to the actual transfer date are recorded.

Contributions

Each year, Participants may contribute to the Plan through salary deferrals on up to 90% of earned compensation. A participant may defer an amount up to the Elective Deferral Dollar Limit under Internal Revenue Service (IRS) Code §402 and the IRS Code §415 Limitation during any calendar year. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also make rollover contributions representing distributions from other qualified plans and Roth contributions on an after-tax basis up to the annual limitations prescribed by the IRS. The Employer may make discretionary matching contributions, as defined by the Plan. The Employer made a discretionary match of \$174,267 for the year ended December 31, 2022. Contributions are subject to certain IRS limitations.

Other Employer Contributions

During the year ended December 31, 2022, the Plan recorded a qualified non-elective contribution (QNEC) of \$13,791 to provide for certain participants that had their ROTH deferral withheld based on the wrong definition of compensation. The contributions were made in accordance with IRS regulations and do not affect the tax status of the Plan and are reflected as other employer contributions on the statement of changes in net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, employer contributions, and plan earnings or losses. Allocations are based on participant earnings/losses, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Changes in a participant's deferral percent for future contributions and reallocation of participant investment accounts among the investment options may be made at any time during the Plan year.

Vesting

The Plan provides that participants are always fully vested in their salary deferral accounts, plus actual earnings thereon. Vesting for the employer matching contributions are vested at 20% per year after the first year and participants are fully vested after six years of service. The portion of an individual's account that is not vested at the time an employee terminates employment is forfeited. Participants vest in the Company's contributions based on the following schedule:

Notes Receivable from Participants

Participants may borrow a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance, whichever is less. The loans are issued by the Plan and secured by the balance in the participant's account. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case the loan must be repaid within a reasonable period of time not to exceed 30 years. Under the terms of the Plan agreement, Plan loans will bear a reasonable rate of interest determined by the Plan administrator, which is Prime plus two percent. Principal and interest are paid ratably through payroll deductions. Participants are limited to one outstanding loan at anytime.

Payment of Benefits

The benefit to which a participant is entitled is the vested balance in their accounts. Upon reaching normal retirement age of 65, becoming disabled or upon a participant's death, the participant becomes 100% vested in their account.

Participants with balances below \$5,000 who terminate employment for reasons other than retirement, death, or disability will receive their vested account balance as soon as administratively feasible.

Participants with balances greater than \$5,000 must consent to the distribution before it may be made.

The payment of benefits shall be made according to the election of the participant in the form of a lump sum or installment payments as prescribed by the Plan.

Hardship distributions are permitted from the participant's elective deferral account only.

Forfeited Accounts

Forfeiture of nonvested accounts are used to pay reasonable Plan expenses or to reduce amounts otherwise be contributed to the Plan. At December 31, 2022, prior to the transfer to the Impact Electronics Solutions 401(k) Plan, forfeited unvested accounts were \$4,215. At December 31, 2021 forfeited unvested accounts totaled \$2,385. In 2022, the Plan used forfeitures of \$2,011 to offset Employer matching contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of the financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement Date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. The net appreciation (depreciation) in fair value of investments consists of both the realized gains and losses on investments bought and sold and as well as the change in unrealized appreciation (depreciation) of those investments.

Participant Direction of Investments

Subject to the provisions of the Plan, a participant has the right to direct the investment of the balance in their accounts in specific investment funds made available by the plan administrator. At December 31, 2022 and 2021, all investments were participant directed.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Code (IRC) are reported as a liability with a corresponding reduction to contributions. The Plan distributed the 2022 excess contributions to the applicable participants prior to March 15, 2023.

Payment of Benefits

Benefits are recorded when paid. At December 31, 2022, there were no participants who had elected to withdraw from the Plan but had not yet been paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in administrative expenses.

Notes Receivable From Participants

Notes receivable from participants are valued at amortized cost which approximates fair value. Amortized cost represents unpaid loan principal plus accrued interest at year end. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2022 and 2021. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, based on the fair market value prior to the merger effective date for December 31, 2022 and as shown at December 31, 2021 on the statement of net assets available for benefits.
- Net investment income and interest income on note receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2022.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at 2022 and 2021.

Mutual funds: The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

Common/collective trusts: Common/collective trusts (CCT) are measured using the NAV practical expedient of the CCT as reported by the CCT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CCT, less its liabilities, and divided by the number of units outstanding. There were no significant unfunded commitments or restrictions on participant redemptions related to the CCT as of December 31, 2022 and 2021. The Plan is subject to a 12-month redemption period notice. The CCT can be redeemed daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS

ADP is a provider of participant recordkeeping, plan administration, marketing support services and supplemental solutions for 401(k) and other types of retirement plans. Reliance Trust Company is the custodian as defined by the Plan. Fees paid by the Plan for investment management services amounted to \$5,454 for the year ended December 31, 2022.

NOTE 6 - TAX STATUS

The Plan adopted a non-standardized/pre-approved profit sharing/money purchase/CODA of ADP, LLC which received a favorable opinion letter dated October 8, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan trustee and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2022 and 2021, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
