### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed an audit of the financial statements of M&M Refrigeration, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ## **Notes to Financial Statements December 31, 2023 and 2022**

---

### **Note 1: Description of the Plan**

The following description of the M&M Refrigeration 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan, restated, amended, and effective December 1, 2018, covering substantially all employees of M&M Refrigeration, LLC (the Plan Sponsor or the Company). Employees are eligible to participate in the Plan once they attain at least eighteen years of age. Employees are permitted to enter the Plan the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan was terminated June 21, 2023 (Note 8) and each participant received a distribution that could be rolled into another qualified plan or into an individual retirement account or kept as a distribution taxable under Internal Revenue Service (IRS) guidelines.

#### **Administration**

The Company serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits. The Plan Administrator uses HowardSimon, Inc. as their third-party administrator. One employee of the Company serves as the Trustee of the Plan.

The Plan's custodian is Voya Institutional Trust Company (Voya or Custodian). Voya receives all contributions made under the Plan, holds Plan assets, pays benefits to participants and executes investment transactions as directed by the Plan Administrator. Additionally, Voya manages certain investments of the Plan (Notes 5 and 7).

#### **Contributions**

Participants may make pre-tax and/or Roth contributions through payroll deductions in any amount up to 100% of the participant's compensation, as defined in the Plan Document, subject to statutory limitations under the Internal Revenue Code (IRC). The statutory limit for 2023 was \$22,500. Participants who have attained at least age fifty are eligible to defer additional amounts (catch-up contributions). The maximum catch-up contribution in 2023 was \$7,500. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan Sponsor may also make discretionary matching contributions, as determined by the Plan Sponsor, to participants once they are permitted to enter the Plan. During 2023, the Plan Sponsor elected to make discretionary matching contributions of 25% up to 8% of each participants compensation totaling \$92,460 at December 31, 2023.

The Plan Sponsor may also make discretionary profit-sharing contributions, as determined by the Plan Sponsor, to participants once they are permitted to enter the Plan. During 2023, the Plan Sponsor elected not to make any discretionary profit-sharing contributions.

The Plan also permits rollover contributions from other qualified plans and individual retirement accounts. Rollover contributions are placed in the participant's account and are subject to the rules for investment established by the Plan Administrator.

### **Participants' Accounts**

Each participant's account is credited with the participant's voluntary and rollover contributions, an allocation of the Plan Sponsor's discretionary matching contributions, an allocation of any discretionary profit-sharing contributions and actual Plan earnings thereon. The participant's account is also charged with withdrawals, applicable allocations of investment gains/losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

### **Vesting**

Participants are immediately vested in their voluntary and rollover contributions and actual Plan earnings thereon. Vesting in the Plan Sponsor's discretionary matching and discretionary profit-sharing contributions plus earnings thereon, is based on years of continuous service. The vesting percentages are as follows:

3	100%

Participants also become 100% vested upon termination of the Plan or upon reaching normal retirement age (65), disability or death while an employee of the Plan Sponsor.

### **Investment Options**

Participants are required to make participant-directed allocations of their accounts in increments totaling 100% among various investment options selected by the Plan Administrator, including options for which the Custodian or its affiliate serves as investment advisors (Notes 5 and 7).

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to one outstanding note at a time, secured by the participant's vested account balance. The loan repayment period must not exceed five years, unless the loan is taken for the purchase of a primary residence, which may exceed five years, as determined by the Plan Administrator. The interest rate on notes receivable from participants is determined by the Plan Administrator based on prevailing rates at the time of the note. Principal and interest are paid ratably through bi-weekly payroll deductions.

### **Payment of Benefits**

Benefits are payable according to the vested interest in the account that the participant is entitled to upon normal retirement, termination of employment, disability or death. Benefits are distributed to the participant as a lump sum payment, as defined in the Plan Document.

Participants withdrawing from the Plan due to termination of employment, other than due to normal retirement, death or disability, may receive the value of their vested account by transfer to another qualified plan or individual retirement account, through a lump sum distribution of a portion of the account balance. The Plan may, upon termination of service of a participant for any reason, automatically distribute the benefits owed if the account balance is \$1,000 or less.

In general, a participant may withdraw up to 100% of their vested account balance in the event of a participant's financial hardship, as defined in the Plan Document. Hardship distributions may not exceed the amount of the participant's financial hardship and may not be repaid by the participant. If a participant makes a hardship withdrawal, the right to make pretax contributions will be suspended for six months.

Distributions from the Plan will normally be subject to income taxes and, in certain circumstances, may also be subject to IRS penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

### **Forfeitures**

Non-vested account balances of terminated employees are forfeited upon the earlier of complete distribution of the vested portion of their account or after five breaks in service, subject to reinstatement before the end of five breaks in service, as defined in the Plan Document. Forfeitures of terminated employees' non-vested accounts may be used to pay Plan expenses and reduce Plan Sponsor contributions, as defined in the Plan Document. At December 31, 2023 and 2022, forfeited non-vested accounts totaled \$0 and \$3,760, respectively. Forfeitures utilized during 2023 were nominal.

## **Note 2: Summary of Accounting Policies**

### **Basis of Accounting**

The financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Use of Estimates in Financial Statements**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

### **Investment Valuation**

Investments are reported at fair value, except for the Voya Fixed Account that is fully benefit-responsive investment contract, which is reported at contract value (Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Purchases and sales of investments, including gains or losses, are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

## Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to the changes in value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant account balances and the amounts reported in the accompanying statements of net assets available for benefits and the statement of changes in net assets available for benefits.

## Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

## Payment of Benefits

Benefit payments are recorded when paid by the Plan.

## Administrative Expenses

Certain expenses of the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. These expenses include, but are not limited to, legal, accounting and recordkeeping fees. However, individual transaction fees for participant directed transactions including, but not limited to, distributions and notes receivable from participants are charged to the participants and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## Note 3: Information Certified by the Custodian (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the amounts for investment assets and transactions in those assets included in the accompanying financial statements and supplemental information as outlined below as of December 31, 2023 and 2022, and for the year ended December 31, 2023, have been compiled from statements certified as complete and accurate by the Custodian in accordance with DOL regulations. As permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Custodian, except for comparing such information to information included in the Plan's financial statements and supplemental information:

#### **Note 4: Fair Value Measurements**

The accounting standard for fair value measurements provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar instruments in active markets;
- Quoted prices for identical or similar assets or liabilities in non-active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023 and 2022.

*Pooled separate accounts* - Investments in the pooled separate accounts are composed primarily of investments in mutual funds and are valued by the Custodian at the net asset value (NAV) of the shares held by the Plan at the end of the Plan year. NAV is based on the value of the underlying assets owned by the investment, minus any liabilities, and then divided by the number of shares outstanding. The Plan has concluded that the NAVs reported by the Custodian are used as a practical expedient to approximate the fair value of the investments and is not classified in the fair value hierarchy. The practical expedient would not be used for the investment if it is determined to be probable that the investment will sell for an amount different from the reported NAV. Participant-directed transactions (purchases and sales) may occur daily. There are currently no unfunded commitments on these investments. The fair values of pooled separate accounts totaled \$0 and \$8,546,869 as of December 31, 2023 and 2022, respectively, and are reported as investments at fair value on the statements of net assets available for benefits.

Net appreciation/depreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or a reflection of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **Note 5: Fully Benefit-Responsive Investment Contract**

The Voya Fixed Account is a traditional investment contract. This contract meets the benefit-responsive investment contract criteria and therefore is reported at contract value. In accordance with Accounting Standards Update (ASU) 2015-12, contract value is the only relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The contract value of the Voya Fixed Account represents contributions plus earnings, less participant withdrawals and administrative expenses. The contract issuer, Voya, is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract value of investment contract accounts totaled \$0 and \$307,473 as of December 31, 2023 and 2022, respectively, and is reported as investment at contract value on the statement of net assets available for benefits.

The Voya Fixed Account guarantees principal and a minimum guaranteed interest rate for the life of the product as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period - currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events such as plan termination or a plan merger initiated by the Plan Sponsor may limit the ability of the Plan to transact at contract value. The Plan Sponsor does not believe that any events that may limit the ability of the Plan to transact at contract value are probable.

## **Note 6: Tax Status**

The Plan Sponsor has adopted the FIS Business Systems, LLC Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA plan (the Prototype Plan). The Prototype Plan received a favorable opinion letter from the IRS dated June 30, 2020, which stated that the Prototype Plan and related trust were designed in accordance with the applicable sections of the IRC.

The Plan has been amended since the receipt of the favorable opinion letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize the tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to examinations for years prior to 2020.

## **Note 7: Party-in-Interest Transactions**

Voya, its affiliates, and certain service providers performs services for, sells products to, and manages and maintains certain investments of the Plan for which fees are charged to the Plan. In addition, the Plan incurs expenses for services provided by parties-in-interest related to investment consulting, accounting, legal and plan administration. Party-in-interest transactions also include notes receivable from participants. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**Note 8: Plan Termination**

The Plan Sponsor amended the Plan to terminate effective June 21, 2023, subject to the provisions of ERISA. Participants are 100% vested in their accounts as of the termination date. As a result of the Plan termination, the Plan Sponsor has authorized Voya to liquidate and transfer all assets in the Plan to the participants.

**Note 9: Subsequent Events**

The Plan Sponsor has evaluated for subsequent events between the date of the statement of net assets available for benefits as of December 31, 2023, and the report date, which is the date these financial statements were available for issuance. Management has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
