Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 26, 2023 and December 31, 2022, and for the period ended December 26, 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting***

As described in Note 1 to the financial statements, the Retirement Committee of the Plan's sponsor voted to terminate the plan and management determined liquidation is imminent. The assets of the Plan were fully distributed by December 26, 2023. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2022 financial statements, to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Note 1. Description of Plan**

The following description of The University Hospital of Augusta, Georgia Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

***General***

University Hospital of Augusta, Georgia (the “Organization”) established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Organization, as defined in accordance with the universal availability standards, are eligible to enroll on their date of hire. Deferrals begin immediately upon commencement of employment. Transamerica Retirement Solutions Corporation (“Transamerica”) as agent for State Street Bank and Trust Company and AIG Retirement Services (“AIG”) serve as the custodians of the Plan (collectively, the “Custodians”). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Plan Termination***

On June 30, 2023, the Plan was amended to terminate the Plan effective June 30, 2023. Final distributions were based on all active participants being 100% vested, and were made as soon as administratively possible after the election. As of December 26, 2023, there were no plan assets remaining. In accordance with accounting principles generally accepted in the United States of America, the Plan has changed its basis of accounting used to value plan assets from the ongoing plan basis to a liquidation basis for the period ended December 26, 2023.

***Contributions***

Each year, participants may contribute a portion of their compensation, as defined in the plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Prior to July 1, 2018, the Organization contributed 50% on the first 6% of the mandatory and elective salary deferral compensation. After July 1, 2018 and prior to July 26, 2020, the Organization contributed 50% on the first 6% of the pre-tax or Roth salary deferral contributions up to a maximum of 3% of compensation. Effective July 26, 2020 the plan was amended to remove matching contributions. Effective July 1, 2021 the Plan was amended to reinstate matching contributions equal to 50% on the first 6% of the pre-tax or Roth salary deferral contributions up to a maximum of 3% of compensation. Contributions are subject to certain limitations. There were no significant employee contributions made in the Plan for the period ended December 26, 2023.

***Nonelective Contributions***

The Organization may make a discretionary nonelective contribution. Prior to July 1, 2018, if a contribution was made, the nonelective contribution was 4% of eligible employee compensation with 2-9 years of service, 5% of eligible employee compensation with 10-15 years of service, and 6% of eligible employee compensation with more than 15 years of service. If a participant is an HCE, the contribution is 1.2% of eligible employee compensation. After July 1, 2018, the amount will be in the same ratio that the salary bears to the total salary of all participants in the Plan.

***Participant Accounts***

Each participant’s account is credited with the participant’s contribution and allocations of the Organization’s contributions and plan earnings, and charged with benefit payments and allocations of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting***

As of the termination date, all participants were 100% vested in their accounts. Prior to termination of the Plan, participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service for matching, nonelective, and minimum contributions.

***Collateral for Loans to Participants and Notes Receivable from Participants***

Participants may borrow from AIG a minimum of \$1,000 up to the lesser of a maximum \$50,000 or 50 percent of their vested account balance. The loans are secured by collateral in the amount of the loan which is transferred from the participant account into a collateral fund. An additional amount equal to one quarter of interest plus all applicable surrender charges is transferred from the participant's account and held in escrow until the loan is repaid. Both these amounts are invested in fixed income accounts and bear interest at rates ranging from 2.5% to 4.5%. Principal and interest on the loan are paid directly by the participant to AIG over a period not to exceed five years, unless the loan proceeds are applied to the purchase of the principal residence of the participant. In such case, the term of the loan may be repaid within twenty years. In the case of default, the note and collateral are not foreclosed on until the occurrence of a distributable event. As of December 26, 2023 and December 31, 2022, \$0 and \$468,872 of AIG loans were collateralized by plan assets.

Participants may also borrow from their Transamerica fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. At December 26, 2023, there were no outstanding loans.

***Payment of Benefits Prior to Plan Termination***

Prior to Plan Termination, for termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Amounts contributed on a before-tax basis may be withdrawn only upon disability, death or severance from employment.

The Plan was amended effective June 1, 2017 giving the plan the right to make involuntary cash-out distributions of account balances of terminated vested participants of \$1,000 or less. Amounts that are above \$1,000 but not more than \$5,000, will be subject to the applicable automatic IRA rollover requirements of Code section 401(a)(31)(B).

The Plan was restated effective July 1, 2018. Rollovers may be withdrawn at any time. After age 59 ½ or older all vested balances may be withdrawn. The plan now allows hardship withdrawals based on "immediate and heavy financial needs" stated in the plan document.

***Forfeitures***

Forfeitures can be used to reduce employer contributions or pay plan expenses. During the period ended December 26, 2023, forfeitures of \$24,925 were used to offset employer contributions.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements have been prepared on the liquidation basis of accounting, consistent with terminated plans, as of and for the period ended December 26, 2023, in conformity with accounting principles generally accepted in the United States of America ("GAAP"). There were no material differences between the liquidation basis of accounting and the ongoing basis of accounting.

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodians. See Note 3 for discussion of fair value measurements and Note 4 for discussion of fully benefit-responsive investment contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Organization, as provided by the plan document. Certain administrative functions are performed by employees of the Organization. No such employee receives compensation from the Plan.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1: Observable inputs such as quoted prices in active markets.
- Level 2: Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3: Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 26, 2023 and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded. These investments are classified within Level 1 of the valuation hierarchy.

Collateral for Loans to Participants

Loan escrow and collateral funds are invested in group fixed annuity contracts and act as security for policy loans made between the participant and AIG. As such, these accounts are valued based on the estimated demand value of the underlying group fixed annuity contracts and are classified within Level 3 of the valuation hierarchy. Disclosure of unobservable inputs to fair value measurement has not been included for the group fixed annuity contracts because quantitative unobservable inputs are not developed by the Plan when measuring fair value and have not been made available to the Plan by issuers of the contracts.

The Plan recognizes transfers between the levels as of the actual date of the event or change in circumstances that caused the transfer. There were no gross transfers between the levels for the period ended December 26, 2023.

(a) Represents collateral for loans made between the participant and AIG. The value of these accounts is based on loan principal owed plus any interest earned by the participant on these investments. Interest earned is based on the contract minimum guarantee and the original effective date of the loan. As the principal is paid down, AIG moves money out of the collateral account and back into regular funds. If a participant stops making payments on a loan, it is deemed a distribution after 3 months. However, the collateral and escrow balances remain in the participant's account until a distributable event occurs.

Level 3 assets are measured at fair value on a recurring basis for the period ended December 26, 2023. There were no issuances and no transfers in and out of Level 3 assets for the period ended December 26, 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4. Full Benefit-Responsive Investment Contracts**

The Plan holds guaranteed investment contracts (“GICs”) with AIG. These GICs meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. As described in Note 2, contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by AIG, represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The following represents the disaggregation of contract value between types of investment contracts held by the Plan.

AIG maintains the contributions in a general account and the accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers, but it may not be less than 3.0%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan’s ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) premature termination of the contracts, (4) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (5) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

Participants should refer to the individual investment contracts for complete terms as the description provides only a summary of the contract provisions.

**Note 6. Exempt-Party-In-Interest Transactions**

Certain plan investments are shares of mutual funds and fixed income accounts managed by AIG and Transamerica Retirement Solutions Corporation, the custodians, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid to the Custodians by the Plan for administrative services were \$91,450 for the period ended December 26, 2023.

**Note 7. Plan Termination**

The Plan terminated effective June 30, 2023 as a standard termination. All participants became 100% vested in their accounts at the date of termination. As such, benefits were paid in full from July 2023 to December 2023 based on participant account balances. As noted in Note 2, the Plan changed its basis of accounting used to value Plan assets from the ongoing basis to the liquidation basis of accounting for the period ended December 26, 2023.

**Note 8. Tax Status**

The Plan's terms have been drafted in reliance on the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007-71. The plan administrator intends to apply for a determination letter on the Plan when the government opens such program. The Plan is required to operate in conformity with the Internal Revenue Code ("IRC") to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 26, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
