We have performed audits of the accompanying financial statements of **KSS Enterprises 401(k) Plan** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 30, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period ended September 30, 2023 and year ended December 31, 2022, and the related notes to the financial statements.


- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

### Note 1 – Description of the Plan

The following description of the KSS Enterprises 401(k) Plan (the “Plan”) provides only general information and pertains to the period prior to September 30, 2023 when the Plan’s assets were transferred to the Envoy Solutions Retirement Savings Plan (the “Envoy Plan”). See further discussion at Note 8. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan established February 14, 1994 and restated effective January 1, 2021. The Plan is sponsored by Kalamazoo Sanitary Supply, Inc. and related employers include Energyst Solutions, Inc., Star Flooring, Inc., Emack Manufacturing Acquisitions, LLC, RSS Acquisition, LLC and Thayer, Inc. (collectively, the ‘Company’). The Plan covers substantially all employees for participant contributions. To be eligible to receive the Company discretionary contributions, an employee must have reached one year of service and be at least 21 years of age. An employee must also be employed on the last day of the Plan year in order to be eligible to receive the Company discretionary profit-sharing contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may elect to contribute up to the maximum amount allowed by law. Participants may designate these deferrals to be pre-tax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Company may make discretionary matching contributions and discretionary profit-sharing contributions as determined by the Company. All contributions are participant directed and are directed into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company discretionary contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Note 1 – Description of the Plan (Continued)

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution and discretionary contribution portion of their accounts is based on continuous service. The Company's contributions begin to vest after one year of service at a rate of 20% per year and are fully vested after 5 years of service. Participant accounts become fully vested in the event of death, total disability, early retirement and normal retirement while still employed.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance in the event of certain financial conditions. The loans are secured by the balance in the participant's account and bear an interest rate of 1% over the prime interest rate at the date of each note. Principal and interest are repaid ratably through payroll deductions over a period of five years or less, unless for the purchase of a principal residence, in which case the loan terms may exceed five years.

#### Payment of Benefits

On termination of service due to death, disability, separation, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions, as defined by the Plan, are allowed from all types of contributions, except rollover contributions. Hardship withdrawals, as defined by the Plan, are only allowed from participant pre-tax or Roth contributions.

#### Forfeited Accounts

During September 2023, forfeited non-vested accounts were transferred to the Envoy Plan. At December 31, 2022, forfeited non-vested accounts totaled \$39. These accounts may be used to reduce Company matching contributions. For the year ended December 31, 2022, \$1,869 of forfeited accounts were used to reduce the Company matching contribution. For the period ended September 30, 2023, no forfeited accounts were used to reduce the Company matching contribution.

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### Note 2 – Summary of Accounting Policies

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

---

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan, of notes receivable from participants, and of benefit payments are charged directly to the participant's account and are included in administrative expenses. Total administrative expenses paid by the Plan for the period ended September 30, 2023 and the year ended December 31, 2022 was approximately \$35,200. Investment related expenses are included in net appreciation or depreciation of fair value of investments.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of September 30, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution is recorded.

#### **Payments of Benefits**

Benefits are recorded when paid.

### Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, other inputs that are observable, or can be corroborated by observable market data.

Level 3 – Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2022.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

For the period ended September 30, 2023 and the year ended December 31, 2022, the Plan made a direct payment to M Holdings Securities, Inc. of approximately \$4,300 and \$5,000, to Empower Advisory Group, LLC of approximately \$1,400 and \$1,200 and to Empower Annuity Insurance Company of approximately \$17,100 and \$16,300, respectively.

### Note 5 – Related Party and Party-In-Interest Transactions (Continued)

Beene Garter LLP and Doeren Mayhew PLLC are the contract administrators, M Holdings Securities, Inc. is the investment advisor, Empower Annuity Insurance is the recordkeeper, and Empower Advisory Group, LLC provides investment management services, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for additional investment management services are included in net appreciation or depreciation in fair value of the investment. The Company pays directly any other fees related to the Plan's operations. Notes receivable from participants also qualify as party-in-interest transactions.

### Note 6 – Income Tax Status

The IRS has determined and informed Beene Garter LLP, the contract administrator of the Plan, by a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA (the prototype plan upon which the Plan is based) is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the opinion letter, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRS and, therefore, believes the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 8 – Transfer of Assets

Effective October 2, 2023, the Plan merged into the Envoy Plan. All assets of the Plan were transferred to the Envoy Plan by September 30, 2023 and participant vesting was not affected by this transfer of assets.
