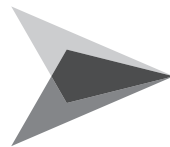

### **Scope and Nature of the ERISA Section 103(a)(3)(c) Audit**

We have performed audits of the financial statements of Brownell's, Inc. Employee Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) (ERISA Section 103(a)(3)(c) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Brownell's, Inc. Employee Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(c), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(c).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **Note 1 - Description of Plan**

The following description of the Brownell’s, Inc. (“Company”) Employee Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

*General* - The Plan is a defined contribution plan covering all employees of the Company who have three consecutive months of service and are age eighteen or older. Once employees are eligible, employees can enter the Plan at the beginning of the next quarter. Employees not eligible for the Plan include union employees, nonresident aliens, leased employees, and temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours of service. The Plan was amended effective January 1, 2004 to become what is referred to as a “safe harbor 401(k) plan.” It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions* - Each year, participants may contribute an amount not to exceed a specific dollar amount determined by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2021, newly eligible employees are automatically enrolled in the Plan with a 5% deferral rate. The Plan currently offers various mutual funds and insured investment contracts as investment options to participants. Effective January 1, 2015, the Company contributed 100% of the participant’s elective deferrals that did not exceed 5% of the participant’s compensation. The matching Company contribution is invested into various investment options offered by the Plan and is referred to as an enhanced matching contribution. Additional amounts may be contributed at the option of the Company's board of directors and are invested in the same investment options as mentioned above for participant and Company matching contributions.

*Participant Accounts* - Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

*Vesting* - Participants are immediately vested in their contributions and the enhanced matching contribution, plus actual earnings thereon. Vesting in the Company’s discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are fully vested after six years of service.

*Notes Receivable from Participants* - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through monthly payroll deductions.

*Payment of Benefits* - Active participants may take a withdrawal from the Plan in the event of a financial hardship. A hardship withdrawal will result in a six-month suspension of contributions to the Plan. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over a period not to exceed the life expectancy of the participant or survivor. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan will make a mandatory distribution following severance from employment for balances less than \$1,000. Amounts due to participants who have elected to withdraw from the Plan at December 31, 2023 and 2022 totaled \$0 and \$0, respectively.

*Forfeited Accounts* - At both December 31, 2023 and 2022, forfeited nonvested accounts totaled \$0. These accounts, when there are balances, will be used to reduce the earliest Company contribution made after the forfeitures are determined.

**Note 2 - Summary of Accounting Policies**

*Basis of Accounting* - Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Changes in fair value of investments are recognized when the investments appreciate or depreciate in value.

*Investment Valuation and Income Recognition* – Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* - Benefits are recorded when paid.

*Use of Estimates* - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses have been recorded as of December 31, 2023 and 2022.

*Date of Management Review* - Management has evaluated subsequent events through July 1, 2024, the date which the financial statements were available to be issued.

**Note 3 - Fair Value Measurement**

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

*Mutual funds:* Mutual funds are reported at fair value based on the quoted market price of the fund, which represents the net asset value of shares held by the Plan at year end. The fair values of mutual funds are classified within Level 1 of the hierarchy.

*Common collective trusts:* Common collective trust funds are composed of investment contracts that are valued at the net asset value of units of the common collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probably that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur immediately.

The following tables present by level, within the fair value hierarchy, the plan investment assets at fair value, as of December 31, 2023 and 2022. Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

The common collective trust fund contract allows it to achieve a total rate of return to match the return the index it was set up to mirror and allow for its principal value to remain stable regardless of the volatility of the financial markets. Investments in this category can be redeemed daily at the current net asset value per share based on the fair value of the underlying assets.

**Note 4 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

**Note 5 - Tax Status**

The Internal Revenue Service has determined and informed the Company by an advisory letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the advisory letter. However, the plan administrator and the Plan's tax advisory counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 6 - Administrative Expenses**

Substantially all administrative expenses associated with the Plan are paid directly by the Company.

**Note 7 - Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

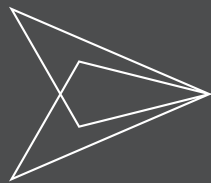
