NOTES TO FINANCIAL STATEMENTS**SEPTEMBER 25, 2023 AND DECEMBER 31, 2022*****NOTE A - DESCRIPTION OF THE PLAN***

The following description of Lilker Associates (the Company) 401(k) Profit Sharing Plan (the Plan) provides only general information. The Plan covers employees of Lilker Associates and Lilker EMO Energy Solutions, LLC. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Also, see Note K - Plan Merger.

General

The Plan is a defined contribution plan that covers substantially all full-time employees of the Company who meet the eligibility requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established effective January 1, 1989, and was restated, most recently, on April 1, 2022.

Contributions

Each year, participants may elect to defer a percentage of eligible compensation up to applicable IRS limits, as defined in the Plan. The Company may make a discretionary matching contribution. The Company also may make a discretionary employer profit sharing contribution. Participants may also contribute amounts representing distributions from other qualified plans.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings (losses). Allocations of earnings (losses) and expenses are based on participant account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after five years of credited service. Vesting in the Company's profit sharing contribution portion of their accounts, plus actual earnings thereon, is also based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow, from their fund accounts, up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund to (from) the participant notes fund. Each loan is secured by the balance in the participant's account.

NOTES TO FINANCIAL STATEMENTS

SEPTEMBER 25, 2023 AND DECEMBER 31, 2022

NOTE A - DESCRIPTION OF THE PLAN (Continued)***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump-sum in a non-rollover or direct rollover distribution, or any combination thereof.

Forfeited Accounts

At September 25, 2023, the forfeiture account balance was \$0. Amounts forfeited by terminated participants are available to reduce employer contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Participant notes receivable are valued at cost, which approximates fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of September 25, 2023 or December 31, 2022.

Benefits are recorded when paid.

Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodology used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

The respective fair values of these investments are determined by reference to the trusts' underlying assets, which are principally guaranteed investment contracts and short-term investments. Units held in common/collective trusts are valued at the unit value as reported by the investment managers.

Subsequent Events

Management has evaluated the effect of subsequent events on these financial statements through June 26, 2024, the date the financial statements were available to be issued. See Note I - Risks and Uncertainties.

NOTE D - FULLY BENEFIT - RESPONSIVE CONTRACT

The Plan holds a portfolio of investment contracts in the amounts of \$0 and \$1,258,883 at September 25, 2023 and December 31, 2022, respectively, that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment. The contract issuer, Empower Life & Annuity Insurance Company of New York, is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a monthly basis for resetting. The average yield and crediting interest rate was approximately 1.18% for 2022.

NOTE D - FULLY BENEFIT - RESPONSIVE CONTRACT (Continued)

The Plan's ability to receive amounts due in accordance with fully responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with Empower Life & Annuity Insurance Company of New York. Examples of such events include the following:

1. Plan termination or merger.
2. Plan amendments or operation of the Plan in a manner which is unacceptable to issuer.
3. The Plan fails to qualify or becomes disqualified under Code Section 401(a).
4. Total amount of contributions received in the preceding 12 months is less than \$25,000.
5. The sum of all Participant Annuity Account Values falls below \$25,000.
6. Premature termination of the contract.

The Plan considers that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE E - TAX STATUS

The Internal Revenue Service has determined and informed the Plan sponsor by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt. The Plan's Form 5500 information returns are subject to examination by the Department of Labor generally for three years after filing. Management has evaluated the tax positions taken and there are no uncertain tax positions that qualify for either recognition or disclosure in the financial statements.

NOTE F - ADMINISTRATIVE EXPENSES

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to those participants' accounts and are included in the administrative expenses. Investment related expenses are included in the net appreciation (depreciation) of fair value of investments.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at September 25, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended September 25, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (the trustees of the Plan).

NOTE H - PLAN TERMINATION

The Plan was terminated on May 1, 2023, and all the assets were merged into the IMEG 401(k) Plan by a trustee-to-trustee transfer as disclosed in Note K.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. See Subsequent Events - Note B and Plan Merger - Note K.

NOTE J - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC are the trustees of the Plan assets as defined by the Plan and, therefore, administrative fees provided to Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC, qualify as party-in-interest transactions. Fees paid by the Plan for such services totaled \$24,578 and \$29,520 for the period ended September 25, 2023 and year ended December 31, 2022, respectively.

Members of management of the Plan sponsor are participating in the Plan. However, there were no transactions with these individuals other than their participation in the Plan. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE K - PLAN MERGER

As of May 1, 2023, Lilker Associates was bought by IMEG Consultants Corporation. The Lilker Associates 401(k) Profit Sharing Plan was merged into the IMEG 401(k) Plan as of September 25, 2023. As of September 25, 2023, the Lilker Associates 401(k) Profit Sharing Plan had zero plan assets.
