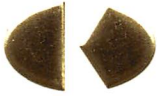

**Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting**

As further discussed in Note 6 to the financial statements, The Administrative Committee of Cal Worthington 401(k) Employee Savings and Retirement Plan approved a plan of liquidation upon the sale of the franchise on February 28, 2023, and management determined liquidation was imminent. As a result, Cal Worthington 401(k) Employee Savings and Retirement Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting used in presenting the 2022 and 2023 financial statements. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

**1. Description of the plan:**

The following description of the Cal Worthington 401(k) Employee Savings and Retirement Plan (the "Plan") provides general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:**

The Plan was a defined contribution plan initiated on October 1, 1996, set up to cover all employees of the employer group, except employees covered by a collective bargaining agreement and nonresident aliens who have received no earned income from the employer group. The employer group consisted of Worthington Oil & Gas Corporation and Worthington Ford, Inc. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversaw governance of the Plan. The Plan's Investment Committee determined the appropriateness of the Plan's investment offerings, monitored investment performance, and reported to the Plan's Board of Trustees.

As mentioned in Note 6, the Board of Trustees of the Company elected to terminate the Plan due to the sale of the Company's assets on February 28, 2023. The Plan was terminated and all funds were distributed from the Plan on September 6, 2023.

**Eligibility:**

Nonexcluded employees who reached twenty-one (21) years of age and completed one year of service were eligible to participate in the Plan. One thousand (1,000) hours of service were required to constitute a year of eligibility service. Participants were allowed to enroll in the Plan on the first day of the Plan Year or first day of the seventh month of the Plan Year following date the requirements were met.

**Contributions:**

Participants were allowed to elect, by submitting a written request to the Plan administrator, to have their wage compensation reduced by up to the lesser of the dollar amount allowable under the limitations of the IRC Sections 415, 401(k) and 402(g) or 25% of compensation. Roth after-tax contributions were allowed by the Plan. For the Plan year ended September 6, 2023, elective deferral amount allowed under IRC Code Section 402(g) was \$22,500, and catch-up contribution allowed for participants age 50 or older, under IRC Code Section 414(v) was \$7,500. This deferred amount flowed directly to the Plan. The employer elected not to make discretionary matching contributions for the current year.

**Contributions (continued):**

Maximum annual addition to each participant's account is subject to the limitation set by IRC Code Section 415(c)(1)(A), which was the lesser of \$66,000 or 100% of the participant's compensation for the year ended.

**Participant accounts:**

Each participant's account was credited with the participant's contribution and Company discretionary matching contribution, if applicable, and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Participants with a TD Ameritrade self-directed account were charged applicable fees directly by TD Ameritrade. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account.

**Vesting:**

Participants were immediately vested in their contributions plus actual earnings thereon. Vesting in the Companies' contribution portion of their accounts was based on years of continuous service. A participant was 100% vested in Company matching after three years of credited service. As a result of the Plan's imminent termination due to the sale of the Company, affected participants became 100% vested in their respective employer match accounts after February 28, 2023.

**Notes receivable from participants:**

Loans to participants were not allowed by the Plan.

**1. Description of the plan (continued):**

**Payment of benefits:**

On termination of service, including severance from employment due to death, disability or retirement, a participant can elect to receive their vested plan balance less any early withdrawal fees. Participants were also allowed to request an in-service withdrawal after attaining the age of 59 1/2 or upon proof of financial hardship. Each participant may elect to receive a lump sum or to roll his or her contributions over into another qualified profit sharing plan or IRA. Participants were advised of the tax consequences and appropriate taxes were withheld. For termination of service for other reasons, a participant can receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeitures:**

Forfeiture amounts available as of September 6, 2023 and December 31, 2022 were \$0 and \$1,202, respectively. Forfeitures are used to pay administrative expenses or reduce future discretionary employer matching contributions. In 2023, \$1,243 in forfeitures were used to pay administrative fees.

**Plan expense:**

The employer elected to absorb part of the Plan's operating and administrative expenses. Certain administrative expenses are paid from Plan assets.

**2. Summary of accounting policies:**

**Basis of accounting:**

The financial statements of the Plan were prepared on the liquidation basis of accounting, consistent with terminated plans, as of September 6, 2023 and December 31, 2022. There were no material differences between the liquidation basis of accounting and the ongoing basis of accounting.

**2. Summary of accounting policies (continued):**

**Use of estimates:**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ('GAAP') requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from these estimates.

**Investment valuation and income recognition:**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits:**

Benefits were recorded when paid.

**Expenses:**

Certain expenses of maintaining the Plan are paid directly by the Company and were excluded from these financial statements. Some account management fees were absorbed by applicable participants as administrative fees and are disclosed as such on the statement of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

**Excess contributions payable:**

Amounts payable to participants amounting to \$17,543 for contributions in excess of amounts allowed by the IRS were recorded as a liability in 2022. The Plan distributed the 2022 excess contributions on July 13, 2023.

**Date of management's review:**

The Plan administrator has evaluated subsequent events through June 28, 2024, the date the financial statements were available to be issued.

**3. Information prepared and certified by Ascensus Trust Company:**

Other than the information related to self-directed participant brokerage accounts held by TD Ameritrade, certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2022, and net appreciation in fair value of investments, interest and dividends for the Plan year ended September 6, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company. **4. Fair value measurements:**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The 3 levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1            Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There are no plan assets requiring the use of Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at September 6, 2023 and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

*Level 1 fair value measurements:*

The self-directed participant brokerage accounts with TD Ameritrade are invested in stocks and mutual funds that are actively traded. The investments are valued at the closing price reported on the active market on which the individual securities are traded.

*Level 2 fair value measurements:*

The funds classified as mutual funds invest solely in shares of a mutual fund which are actively traded. The trustees have determined that Level 2 is the correct designation for these investments.

The American Funds U.S. Government Money Market Fund classified as interest-bearing cash is a money-market fund investing in short-term money-market instruments, including US Treasury securities and other securities issued by U.S. federal agencies. The underlying investments are not actively traded. However, due to the highly liquid nature of these investments, the trustees have determined that Level 2 is the proper designation.

**5. Related party and party-in-interest transactions:**

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services.

**5. Related party and party-in-interest transactions (continued):**

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, which were not covered by revenue sharing. The Plan also made direct payments to service providers which were not covered by revenue sharing.

**6. Plan termination:**

In conjunction with the sale of the Company's auto franchise on February 28, 2023, the Board of Directors elected to terminate the Plan. Management determined that liquidation was imminent and participants became 100% vested in their accounts. As of the date of this report, the Plan has distributed all funds based on participant requests.

**7. Tax status:**

The Company adopted the Ascensus, LLC non-standardized pre-approved profit sharing plan. The IRS has determined and informed the Company by a letter dated June 30, 2020, that this Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan may have been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risk and uncertainties:**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.
