As discussed in Note 1 to the financial statements, the governing body of the Plan approved a plan of liquidation on February 7, 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting for the period ended June 23, 2023 from the going concern basis to a liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement,

whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS**

NOTE 1 – DESCRIPTION OF PLAN

General – The following description of the Within Unlimited, Inc. 401(k) Plan (the Plan) provides general information about the Plan’s provisions. Participants should refer to the plan document and summary plan description for a more complete description of the Plan’s provisions, a copy of which is available from Within Unlimited, Inc. (the Company).

Plan Termination – The Plan was a defined contribution plan effective January 1, 2016 and was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Company has the right, at any time, to terminate the Plan. Upon termination, Participants become immediately and fully vested in their accounts. Effective February 8, 2023, Meta Platforms , Inc. (Meta) acquired the Company. Effective February 7, 2023, the Company terminated the Plan and contributions to the Plan ceased. Participants could choose a distribution of their account balance, a direct rollover to another qualified plan or to an individual retirement account. The Company completed its liquidation, and final assets were distributed on June 23, 2023.

Administration – The Within Retirement Plan Committee (the Committee) was responsible for the general administration of the Plan. Ascensus Trust Company acted as trustee of the Plan, and The Vanguard Group, Inc. (VGI), through Vanguard Retirement Plan Access acted as recordkeeper of the Plan. VGI contracted with Ascensus, Inc. to provide the recordkeeping services for the Plan on behalf of VGI.

Eligibility – Employees of the Company (other than leased employees, independent contractors, or members of collectively bargained units) became eligible to participate in the Plan on the first day of the month after date of hire, as defined by the Plan.

Contributions – A participant could defer any dollar amount or percentage of their eligible compensation on a pre-tax basis or as Roth contributions on an after-tax basis, subject to certain limits prescribed by law. Participants age 50 and over as of year-end were eligible to make catch-up contributions to the extent permissible under laws and regulations. Participants could also contribute rollover amounts representing distributions from other qualified plans.

The Company, at its discretion, could elect to make a profit sharing contribution to the Plan that would be allocated to all participants who were employed on the last day of the plan year. No discretionary contributions were made to the Plan since inception. **However, the Company did make a Qualified Non-Elective Contribution (QNEC) in 2022 to correct compliance testing that occurred during the 2021 plan year which was permitted under the terms of the Plan.**

Participants directed their elective contributions into various investment options offered by the Plan and could change their investment options on a daily basis. In the event investment instructions were not received from the participant, the investment of contributions was allocated to the Plan’s qualified default investment option, one of the Vanguard Target Retirement Funds, which was determined based upon the year the participant attained age 65.

Vesting – Participants were immediately vested, in their contributions plus actual earnings thereon.

Participant Accounts – Each participant’s account was credited with the participant’s contributions and allocations of Plan earnings, and was charged with an allocation of administrative expenses. Plan earnings were allocated based on the participant’s share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses were based on the participant’s account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Administrative Expenses – The Plan’s administrative expenses were paid by either the Plan or the Company, as provided by the Plan’s provisions. Administrative expenses paid by the Plan included recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan’s investments were charged to the particular investment fund to which the expenses related. All other administrative expenses of the Plan were paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Benefit Payments – The Plan provided benefits for eligible participants upon retirement, death, termination, or permanent disability, according to the form of payment elected by the participant within the limitations defined in the Plan. Distributions were made in the form of a lump sum or non-recurring partial payments. Withdrawals of employee contributions for financial hardship were also permitted, subject to qualifications under the Internal Revenue Code of 1986, as amended (the IRC). Upon termination of employment for any reason, if a participant’s account was less than or equal to \$1,000, the account balance was automatically be distributed to the participant.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (US GAAP). Benefit payments are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with US GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.investments

NOTE 3 – INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule at June 23, 2023, December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments and investment income for the period January 1, 2023 through June 23, 2023, and the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC as agent for Ascensus Trust Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

Mutual funds and money market funds are valued at the daily closing price as reported by the fund’s issuer. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

NOTE 5 - INCOME TAX STATUS

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the IRC, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Company has evaluated subsequent events for the Plan through March 15, 2024, the date the financial statements were available to be issued, and there were no subsequent events requiring adjustments.

No discretionary contributions were made to the Plan since inception. **However, the Company did make a Qualified Non-Elective Contribution (QNEC) in 2022 to correct compliance testing that occurred during the 2021 plan year which was permitted under the terms of the Plan.**

Participants directed their elective contributions into various investment options offered by the Plan and could change their investment options on a daily basis. In the event investment instructions were not received from the participant, the investment of contributions was allocated to the Plan’s qualified default investment option, one of the Vanguard Target Retirement Funds, which was determined based upon the year the participant attained age 65.

Vesting – Participants were immediately vested, in their contributions plus actual earnings thereon.

Participant Accounts – Each participant’s account was credited with the participant’s contributions and allocations of Plan earnings, and was charged with an allocation of administrative expenses. Plan earnings were allocated based on the participant’s share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses were based on the participant’s account balances, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant’s vested account.

Administrative Expenses – The Plan’s administrative expenses were paid by either the Plan or the Company, as provided by the Plan’s provisions. Administrative expenses paid by the Plan included recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan’s investments were charged to the particular investment fund to which the expenses related. All other administrative expenses of the Plan were paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Benefit Payments – The Plan provided benefits for eligible participants upon retirement, death, termination, or permanent disability, according to the form of payment elected by the participant within the limitations defined in the Plan. Distributions were made in the form of a lump sum or non-recurring partial payments. Withdrawals of employee contributions for financial hardship were also permitted, subject to qualifications under the Internal Revenue Code of 1986, as amended (the IRC). Upon termination of employment for any reason, if a participant’s account was less than or equal to \$1,000, the account balance was automatically be distributed to the participant.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of accounting – The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (US GAAP). Benefit payments are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with US GAAP requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment valuation and income recognition – Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.investments

NOTE 3 – INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental schedule at June 23, 2023, December 31, 2022 and 2021, and net appreciation (depreciation) in fair value of investments and investment income for the period January 1, 2023 through June 23, 2023, and the year ended December 31, 2022, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC as agent for Ascensus Trust Company, the trustee of the Plan.

NOTE 4 – FAIR VALUE MEASUREMENTS

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below.

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3 – Significant unobservable inputs for the asset or liability (i.e., supported by little or no market activity).

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan.

Mutual funds and money market funds are valued at the daily closing price as reported by the fund’s issuer. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded and are classified within Level 1 of the valuation hierarchy.

NOTE 5 - INCOME TAX STATUS

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the IRC, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – RELATED-PARTY TRANSACTIONS

Certain investments of the Plan are managed by VGI. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

NOTE 7 - SUBSEQUENT EVENTS

The Company has evaluated subsequent events for the Plan through March 15, 2024, the date the financial statements were available to be issued, and there were no subsequent events requiring adjustments.
