SUMMARY ANNUAL REPORT FOR FIRST LINE DEFENSE, LLC 401(K) PLAN

This is a summary of the Form 5500-SF Annual Return/Report of Small Employee Benefit Plan for the First Line Defense, LLC 401(k) Plan, EIN 27-1706279, Plan 002, for period January 1, 2024 through April 30, 2024. The Form 5500-SF annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA). Your plan is a defined contribution, age/service weighted or new comparability, profit-sharing, ERISA section 404(c), total participant-directed account, Code section 401(k), Code section 401(m), default investment account, covered self-employed individuals, pre-approved, single employer type of plan.

Basic Financial Statement

Benefits under the plan are provided through insurance and through a trust fund. Plan expenses were \$74,857. These expenses included \$254 in administrative expenses and \$74,603 in benefits paid to participants and beneficiaries. A total of 0 persons were participants in or beneficiaries of the plan at the end of the plan year.

The value of plan assets, after subtracting liabilities of the plan, was \$0 as of April 30, 2024, compared to \$73,667 as of January 1, 2024. During the plan year, the plan experienced a decrease in its net assets of (\$73,667). This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$1,190, including earnings from investments of \$1,190.
