We have performed audits of the financial statements of The Lutheran Home 401(k) Thrift Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of September 29, 2023 and September 30, 2022, and the related statement of changes in net assets available for benefits for the period ended September 29, 2023 and the related notes to the financial statements.

### Note 1: Description of Plan

The following description of the The Lutheran Home 401(k) Thrift Plan (the "Plan") is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

Effective September 29, 2023, the plan assets related to the Plan were transferred to MyPath To Retire PEP by The Lutheran Home 401(k) Plan.

The Plan is a defined contribution plan sponsored by The Lutheran Home Association (the "Company"). An employee is eligible to participate in the Plan upon attaining age 21 and having completed 60 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In March 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act was enacted and signed into law. The CARES Act includes various provisions that temporarily ease rules around distributions and loans in 2020 for eligible plan participants in reaction to the economic conditions during the COVID-19 pandemic. Certain design changes were made to the Plan during 2020 as permitted pursuant to the CARES Act.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. The Company has the option to make discretionary matching contributions up to a maximum of 3% of a participant's compensation and an additional discretionary profit sharing contribution. The matching contribution percentage is set by the Board of Directors prior to the plan year-end. The Company made a 2% discretionary matching contribution to the Plan for the period ended September 29, 2023. The Company did not make any additional discretionary profit sharing contributions to the Plan for the period ended September 29, 2023. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's discretionary matching contributions (if applicable) as well as allocations of the Company's discretionary profit sharing contribution (if applicable) and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's contribution portion of a participant's account plus actual earnings thereon is based on years of service. Participants vest at a rate of 20% per year beginning with the first year of service. A participant is 100% vested in employer contributions after five years of service or upon death, disability, or retirement.

#### Notes Receivable From Participants

A participant may borrow from his or her fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging of 4.25% - 6.50% during the period ended September 29, 2023. The interest rate is based on the rates available for similar loans from commercial lending institutions, as described in the plan document. A loan must be repaid over a period not to exceed five years, unless used to purchase a participant's principal residence. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

The Plan provides for payment of the entire balance in the participant's account upon retirement, death, disability, termination of participant, or termination of the Plan. The participants account will be distributed by whichever of the following methods is elected by the employee:

- (1) Purchase and distribution of an annuity contract
- (2) Lump sum
- (3) Equal or unequal installments

The Plan has an automatic distribution provision that requires a mandatory distribution to a participant without the participant's consent if the participant terminates and does not elect a direct rollover if the account balance is less than \$1,000. If their account balance is between \$1,000 and \$5,000, the account balance will be automatically rolled over to an IRA designated by the plan administrator. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

#### **Payment of Benefits** (Continued)

Effective January 1, 2020, the new IRS hardship distribution regulations were implemented to allow participants to have access to earnings on the deferral portion of their account, to include federal disasters as a hardship category, to eliminate the suspension period subsequent to receiving a hardship distribution, and to eliminate the requirement to exhaust plan loans. Written amendments to the Plan to reflect these operational changes were adopted on March 4, 2021.

#### **Forfeitures**

Forfeited nonvested accounts were \$0 and \$6,464 at September 29, 2023 and September 30, 2022, respectively. These accounts were to be used to reduce future Company contributions or to pay administrative expenses of the Plan in accordance with the plan document. During the period ended September 29, 2023 forfeitures of \$48,754 were used to reduce Company contributions and \$15,800 were used to pay the Plan's administrative expenses.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of September 29, 2023 or September 30, 2022. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Expenses directly related to the general administration and recordkeeping of the Plan are charged monthly to each participant's account based on the percentage of assets held. Investment management fees and other expenses that apply to specific investments are charged pro rata to all participants who are invested in such funds and are included in net appreciation in fair value of investments. Certain fees are paid by participants on a "per use" basis. These fees include loan administration fees, withdrawal and distribution processing fees, and other fees specifically related to an individual participant and are included in administrative expenses.

#### Subsequent Events

The Company has evaluated subsequent events through July 10, 2024, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.

- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of September 30, 2022.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Mutual funds held in pooled separate accounts:* Fair value is estimated using the NAV per unit by the issuer of the pooled separate account. Fair value is based on the fair value of underlying investments held by the pooled separate accounts.

*Collective investment trusts:* Fair value is estimated using the NAV per unit by the issuer of the collective investment trusts. Fair value is based on the fair value of underlying investments held by the collective investment trusts.

The following tables set forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of September 30, 2022. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

### **Note 4: Information Prepared and Certified by the Trustee**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements, including investments and notes receivable from participants held at September 30, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period ended September 29, 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, (the Trustee of the Plan).

### **Note 5: Related Party Transactions and Party-in-Interest Transactions**

The Plan invests in accounts managed by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, who serves as Trustee for investments in the Plan, and therefore, these transactions qualify as party-in-interest transactions. Principal Life Insurance Company is the record-keeper, as defined by the Plan and also qualifies as a party-in-interest which is exempt from the prohibited transaction rules. Fees incurred and paid by the Plan for asset-based investment and administrative services were \$48,352 for the period ended September 29, 2023. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Plan Termination**

Although it has not expressed the intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

Effective September 29, 2023, the plan assets related to the Plan were transferred to MyPath To Retire PEP by The Lutheran Home 401(k) Plan.

### **Note 7: Income Tax Status**

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
