Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Industry Products Company Employees' 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 11, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the short plan year ended December 11, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Industry Products Company Employees' 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note #1 – Significant Accounting Policies

Basis of Accounting:

The accompanying financial statements of the Industry Products Company Employees' 401(k) Plan (the Plan) are prepared on the accrual basis of accounting for 2022 and the liquidation basis of accounting for 2023.

Use of Estimates:

Management used estimates and assumptions in preparing these financial statements in accordance with accounting principles generally accepted in the United States of America. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and the reported additions and deductions of net assets. Actual results could vary from those estimates that were used.

Investment Valuation and Income Recognition:

The Plan's mutual fund investments are stated at fair value using a daily valuation system. Based on quoted market prices, the collective investment fund is carried at contract value and applies the provisions of FASB ASC Sections 946-210-45 and 946-210-50 for stable value investment funds accounting for fully benefit – responsive investment contracts. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Net realized/unrealized gain (loss) includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan uses an average cost basis for shares in the calculation of realized gains (losses).

Participant Notes Receivable:

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual method. Participant notes receivable are considered in default if any scheduled repayments are unpaid at the end of the calendar quarter following the quarter the loan becomes past due. Loans are immediately due upon separation of service.

Payment of Benefits:

Benefits are recorded when paid.

Subsequent Events:

The Plan has evaluated subsequent events through the date of the report of these financial statements, which is the date the financial statements were available to be issued.

Note #2 – Description of the Plan

The Plan, established effective January 1, 1992, is a defined contribution plan covering substantially all employees of Industry Products Company (the Company). The Plan was terminated effective July 3, 2023, due to the Plan sponsor being acquired by another entity. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Certain administrative expenses of the Plan are paid for by the Company. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Note #2 – Description of the Plan (Continued)

Eligibility Requirements – Employees became eligible to make employee deferrals and receive employer matching and qualified non-elective contributions on the entry date coincident with or next following age 21 and the completion of three months of service. Entry dates were the beginning of each month for employee deferrals and employer match. Entry dates were January 1 and July 1 for non-elective contributions. Employees were auto enrolled at a 3% deferral rate with a 1% increase annually up to 6%.

Contributions – Participants may elect to defer up to 100% of their salary. These salary deferrals can be pre-tax 401(k) deferrals or Roth 401(k) deferrals. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans. A discretionary employer matching contribution may be made equal to a percentage of the Participant's salary reductions, excluding catch up deferrals. The discretionary employer matching contribution was 50% of the first 8% of employee salary deferrals for 2023. A discretionary non-elective employer contribution may be made and allocated to all eligible participants in the ratio that the participants eligible compensation bears to the total eligible compensation paid to all eligible participants. There was no discretionary non-elective employer contribution in 2023. In addition, the employer may designate all or a portion of any non-elective contributions for a plan year as qualified non-elective contributions (QNEC) and allocate them to certain non-highly compensated employees to help the Plan pass one or more annually required non-discrimination tests. Participants must have 1 year of service (with 1,000 hours) and be employed at year end to be eligible for the discretionary non-elective employer contribution. However, a participant will be eligible for the discretionary non-elective employer contribution even if they do not satisfy the last day or annual service requirements due to retirement, death, or disability. Contributions are subject to certain limitations.

Participant Accounts – Each participant's account is credited with contributions, as described above, and an allocation of Plan earnings and expenses. Earnings and expenses are allocated based on the investment account and the participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant Loans – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loans must be repaid in less than 5 years, unless it is for the purchase of a principal residence. The loans are secured by the balance in the participants account and bear interest at a rate commensurate with local prevailing rates. The interest rate on loans are fixed at the date of inception. Interest rates on outstanding loan balances are 4.25% to 8.00% on December 31, 2022. Principal and interest are paid ratably through payroll deductions.

Benefit Payments – Benefit payments are available upon normal retirement at age 65, death, disability or termination of employment. Payments are made in the form of a lump-sum payment or installment payments with payments to begin no later than the end of the Plan year in which the participant attains age 72. If the vested account balance does not exceed a certain threshold, the payment is automatically distributed in the form of a lump-sum payment (\$1,000 or less) or direct rollover to an IRA (\$5,000 or less). Prior to termination of employment, a participant may elect to withdraw all or a portion of his or her deferral account balance upon incurring a hardship, as defined by the Plan. In addition, the Plan allows for in-service withdrawals of all vested account balances upon attaining the age of 59½.

Note #2 – Description of the Plan (Continued)

Vesting & Forfeitures – Vesting applies to participants upon termination for any reason other than death, disability or retirement. Participants are immediately vested in their voluntary deferral plus actual earnings thereon. Vesting in employer matching contributions and nonelective employer contributions is based on years of continuous service using a graded vesting schedule. A participant is 20% vested after two years of service with an additional 20% vesting after each additional year of service. After six years of service, the participant is fully vested. Vesting in employer profit sharing contributions is 100% for active participants employed as of December 31, 1999; and for those hired subsequent to December 31, 1999, employees are subject to the graded vesting schedule. Forfeitures may be used to pay Plan expenses and then can be used to reduce future employer contributions. In 2023, \$17,963 of forfeited non-vested accounts were used to offset employer contributions and \$17,221 were used to pay administrative fees. There were \$3,320 of forfeited non-vested accounts at December 31, 2022.

Note #3 – Certification and Related Party

All of the Plan's investments and investment transactions were recorded by Fidelity Management Trust Company (Fidelity), the trustee. Therefore, the accompanying financial statements have been prepared from the information supplied and certified by the trustee, including investment assets, transactions, and earnings. Fidelity provided certain administration services to the Plan amounting to \$3,269 and \$2,870 in administrative expenses for recordkeeping and loan administration in 2023 and 2022, respectively.

Note #4 – Investments

The Plan's mutual funds are reported at fair value in the accompanying statement of net assets available for benefits. Fair value measurements are as follows at year end:

Accounting Standards Codification (ASC) 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 consist of unobservable inputs with the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Note #4 – Investments (Continued)

The collective investment fund (Fund) is a Galliard stable value fund invested in a collective trust fund established by Allspring Collective Trust. The Fund does not invest directly in fully benefit-responsive contracts. The Fund is valued as a practical expedient utilizing the net asset valuation as fair value, exclusive of the adjustment to contract value. The use of NAV as fair value is deemed appropriate as the Fund does not have a finite life, unfunded commitments, or significant restrictions on redemptions. If the Plan were to initiate a full redemption, the issuer reserves the right to require 12 months' notification.

The yield earned by the Fund for 2023 and 2022 was 4.92% and 4.94%, respectively. This represents the annualized earnings of all investments in the Fund divided by the fair value of all investments in the Fund at December 11, 2023 and December 31, 2022. The yield earned by the Fund with an adjustment to reflect the actual interest rate credited to participants in the Fund in 2023 and 2022 was 2.93% and 2.52%, respectively. This represents the annualized earnings credited to participants in the Fund divided by the fair value of all investments in the Fund at December 11, 2023 and December 31, 2022.

Note #5 – Income Tax Status

The Plan is designed in accordance with a standardized prototype by Fidelity Management & Research Co., which received a favorable tax opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the form of the plan prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan prototype has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable and requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Note #6 – Plan Termination

The Plan sponsor was sold in July 2023, therefore, the Plan terminated subject to the provisions of ERISA. Participants became 100% vested in their accounts, and had the option to rollover their account to another plan or an IRA. As of December 11, 2023, all funds were paid out of trust.
