Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Colorado OB/GYN Partners, PLLC 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

(1) Description Of The Plan

The following brief description of Colorado OB/GYN Partners, PLLC 401(k) Profit Sharing Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan available to all eligible employees. All employees of the participant groups who have completed one year of service, are age twenty-one or older, and who are not members of a collective bargaining agreement, as defined in the Plan agreement are eligible to participate. All participating employers are collectively known as the (“Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan’s Trustees are responsible for oversight of the Plan.

During the nine month period ending September 30, 2023, the Plan was composed of the following groups: Women’s Health Group, Dr. Patricia Giuffre, Dr. Kristine Eule, and Dr. Kate Tate.

Effective June 6, 2020, Dr. Kathleen Tate’s group terminated from Colorado OBGYN. This event affected only two participants in the Plan. Effective July 1, 2020, both Dr. Patricia Giuffre and Dr. Kristine Eule’s groups merged with the Women’s Health Group. Effective October 1, 2020, SCP Women’s Health Partners, LLP joined the group.

Effective September 30, 2018, Pueblo Associates in Obstetrics & Gynecology, and Exceptional Care for Women terminated their membership with Colorado OBGYN, but as of December 31, 2021, some participants from these groups had undistributed funds in the Plan. This event was considered a partial plan termination and all affected participants became immediately vested.

Effective June 30, 2023 the Plan officially terminated and all assets were liquidated as of September 30, 2023, accordingly, the financials are on the liquidation basis of accounting.

Contributions

Each year, participants may contribute a combination of pre-tax and after-tax contributions up to 100% of their annual compensation, as defined in the Plan In addition, employees make after tax ROTH contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

COLORADO OB/GYN PARTNERS, PLLC 401(K) PROFIT SHARING PLAN

The Plan has a safe harbor provision, in which all eligible employees will receive a special contribution of 3% of their eligible compensation which will be deposited into a special safe harbor account and is considered 100% vested.

The Employer may also make a discretionary match, which amount, if any, will be determined as a percentage of the employee salary deferral or as a uniform dollar amount. The discretionary matching contribution is limited to up to 6% of the eligible employees compensation. These discretionary contributions are subject to a six year vesting schedule.

In addition, the employer may make a special matching contribution (QMAC), which will be considered 100% vested. These are contributions which will be made to employees considered nonhighly compensated. Finally, if the Plan is deemed to be top-heavy, the employer will make a minimum contribution of 3% of all non-key employees or the highest percentage provided to any key employees.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

For all employer safe harbor contributions, employees are 100% vested. For employer contributions subject to the vesting schedule.

Vesting in profit sharing and discretionary matching contributions is as follows:

Employees reaching retirement age during employment are automatically 100% vested in all employer contributions. Additionally, at the Plan's termination date all participants became 100% vested.

As of September 30, 2023, and December 31, 2022, the Plan held funds of \$0 and \$18,249 of forfeiture funds respectively. During the nine month period ending September 30, 2023 and year ended December 31, 2022, forfeitures were utilized to pay for administrative expenses.

Payment of Benefits

On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive a lump-sum cash distribution, installment payments, a direct rollover to another qualified retirement plan or an annuity, as defined by the Plan, in an amount equal to the value of the participant's account balance.

The Plan has a buy back provision which allows for employees who are terminated from the Plan to buy back, the forfeited portion of the employer contributions if re-hired within a five year period of termination.

Notes Receivable From Participants

Effective July 1, 2015, loan and hardship withdrawal provisions were allowed under the Plan. Participants may borrow from their fund amounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest rates between 5.25% and 7%, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions. Interest incurred on loans and loan payments are credited to the participant's account.

Administrative Expenses

The Plan is administered by the Company. The Plan assets are invested in funds held at Principal Life Insurance Company and Principal Life Insurance Trust. The Plan pays for investment and trustee fees which are deducted directly from investment earnings and netted against individual participant accounts. The Plan paid administrative expenses of \$85,777 and \$95,559 for the nine month period ended September 30, 2023, and the year ended December 31, 2022, respectively.

CARES Act

On March 27, 2020 the Coronavirus Aid, Relief and Economic Security Act (CARES Act) was signed into law. The CARES Act allowed retirement plans to provide participants who are impacted by the coronavirus (as defined in the CARES Act) with greater access to their savings. As permitted by the CARES Act, the Plan opted in to implement the following provisions.

Through December 31, 2020, qualified individuals were permitted to take a distribution in an amount up to \$100,000 from the Plan. Any such distributions were not subject to the 10% early distribution penalty or the mandatory 20% federal income tax withholding rate. Participants who took a qualified distribution had the option to have the distribution taxed over a three-year period, with the ability to recontribute up to the full amount of the distribution within three years and not be subject to the federal income tax as a result.

(2) **Summary of Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared using the liquidation basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of the Plan's financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions Receivable

Employee contributions receivable arise from employee contributions that are withheld from employee's salary, but have yet to be remitted to the Plan by the Employer. Employer contributions receivable arise from discretionary matching or profit sharing contributions that are to be remitted to the Plan by the Employer for wages that have been previously paid to employees. The Plan charges off uncollectible receivables when future receipts are deemed improbable.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are

charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of September 30, 2023 and December 31, 2022, no allowance for credit losses has been recorded. If a participant does not make loan payments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based upon the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by an investment advisor, the custodian and insurance company.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and

-
- inputs that are derived principally from or corroborated by observable market data by correlations or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used as of September 30, 2023, and December 31, 2022.

Pooled separate accounts: Fair value was determined based on the value of the underlying assets and securities, the majority of which have observable Level 1 pricing inputs, including publicly quoted prices and quoted prices for similar assets in active or non-active markets.

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at their price. The mutual funds held by the Plan are considered to be actively traded.

Common/collective trust funds: the Target Retirement Trusts managed by Principal Financial Group are organized as collective Interment Trusts ("CITs"). Prices of these pooled groups of assets are based on the NAV (as a practical expedient) calculated by the underlying registered investment companies in which they are invested. The prices of the CITs are provided and updated daily on Principal's website. Purchases and sales are generally only transacted with the CITs themselves through Principal with few to no restrictions. Each Trust invests in Principal registered investment companies using an assets allocation strategy designed for investors planning to retire and leave the workforce with a few years fo the target year. The Plan measures fair values of these investments using the NAV provided by Principle.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect the investment balances and the amounts reported in the statements of net assets available for benefits.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan Sponsor evaluated subsequent events through July 11, 2024, the date the financial statements were made available to be issued.

(3) Investment Contracts With Insurance Company

The Plan entered into one fully benefit-responsive contracts with Principal Life Insurance Company which are fixed income option annuity contracts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuers are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contracts are presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal Life Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contracts as of September 30, 2023 and December 31, 2022, was \$0 and \$121,006 and crediting interest rate was 0% and 1.55%, respectively.

Certain events limit the Plan's ability to transact at contract value with Principal Life Insurance Company. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, plan sponsor events that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify

for exemption from federal income taxes or other required prohibited transactions exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from the contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan's administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

(4) Investments

As of September 30, 2023, there were no assets held in the Plan.

Gains and losses included in changes in net assets available for benefits for the nine month period ended September 30, 2023 and the year ended December 31, 2022, are reported in net appreciation in fair value of investments and relate to investments measured by quoted prices in an active market.

(5) **Financial Data Certified By The Investment Company Administered Trust Fund**

The plan administrator has elected the method of compliance permitted by Section CFR 29 2520.103-5 (c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA for the nine month period ended ended September 30, 2023, and year ended December 31, 2022. Accordingly, as permitted under such election, Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company and Principal Life Insurance Trust Company have certified all financial data relative to the investment assets, transactions, and income, and the schedules of investments and reportable transactions.

(6) **Related-party Transactions**

Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the custodian as define by the Plan. Principal Life Insurance Company provides record keeping and operational services. Therefore, these transactions qualify as party-in-interest transactions. All these transactions are exempt from the prohibited transaction rules of ERISA.

(7) **Plan Termination**

Effective June 30, 2023 the Plan officially terminated and all assets liquidated as of September 30, 2023. All participant contributions are non-forfeitable.

(8) **Tax Status**

The Plan is an adoption of a regional prototype plan under Principal Life Insurance Company the Defined Contribution Volume Submitter Profit Plan and Trust Basic Plan Document #04, which has received a notification letter from the Key District Director having jurisdiction with the Plan. The Internal Revenue Service permits the employer to rely on the notification letter. Therefore, the employer will not submit the Plan to the Internal Revenue Service for an advance determination as to whether the Plan meets the qualification requirements of section 401 of the Internal Revenue Code of 1986 with respect to the Plan's initial qualification.

The Plan follows *Accounting for Uncertainty in Income Taxes* accounting standard which requires the Plan to determine whether a tax position (and the related tax benefit) is more likely than not to be sustained upon examination by the applicable taxing authority, based solely on the technical merits of the position. The tax benefit to be recognized is measured as the largest amount of benefit that is greater than fifty percent likely of being realized upon settlement, presuming that the tax position is examined by the appropriate taxing authority that has full

knowledge of all relevant information. During the nine month period ended September 30, 2023, and year ended December 31, 2022, the Plan evaluated its tax positions to determine the existence of uncertainties, and did not note any matters that would require recognition or which may have an affect on its tax status.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress. The Plan's Form 5500's filed are subject to U.S. federal tax audits by taxing authorities for years ending prior to December 31, 2020. The years subsequent to this year contain matters that could be subject to differing interpretations of applicable tax laws and regulations. Although the outcome of tax audits is uncertain, the Plan believes no material issues would arise.

(9) **Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with certain investment securities, and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statement of net assets available for benefits.
