Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of the Lowell General Hospital Corp. Inc. 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 29, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the period January 1, 2023 through September 29, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 29, 2023 and December 31, 2022, and for the period January 1, 2023 through September 29, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audits.

Notes to Financial Statements

Note 1 - Description of the Plan

The following description of the Lowell General Hospital Corp. Inc. 403(b) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General and Plan Merger and Termination

The Plan was a defined contribution plan covering substantially all employees of Lowell General Hospital Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Substantially all of the investments are participant-directed.

The Tufts Medicine, Inc. Retirement Plan Oversight Committee authorized the merger of all assets of the Lowell General Hospital Corp. Inc. 403(b) Retirement Plan to the Tufts Medicine 403(b) Plan (“Tufts 403(b)”) with an effective date of September 29, 2023, and accordingly, all plan assets were transferred to the Tufts 403(b) Plan on September 29, 2023. As a result of the merger, the Plan was terminated.

Eligibility

All employees employed by a Participating Employer were eligible to participate immediately in the Plan upon completion of a salary reduction agreement, regardless of age, with the exception of certain leased employees, independent contractors not entitled to benefits under the Plan, certain nonresident aliens and employees who are residents of Puerto Rico.

Participant Contributions

Upon meeting eligibility requirements participants were able to contribute up to 100% of their plan compensation on a pre-tax basis, subject to Internal Revenue Code (“IRC”) limitations. Participants who were at least age 50 were able to make an additional “catch-up” contribution subject to IRC limitations. Participants could also contribute funds from another qualified plan (“rollover contributions”), subject to certain requirements.

Employer Contributions

Each year, the Company could make a discretionary matching contribution to the Plan. In order to share in the Employer matching contributions, participants must have obtained one year of service, as defined. For the period ended September 29, 2023, the Company matched 50% of each participant’s deferral contributions up to 6% of the participant’s compensation, for a maximum match of 3% of compensation, calculated each pay period.

Note 1 - Description of the Plan (Continued)

Participant Accounts

Each participant's account was credited or charged with contributions, investment income/losses, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses were allocated to participants' accounts based on each participant's account balance within each fund. Participants were able to change their investment options as set forth in the plan document. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit provided from the participant's vested account.

Vesting

Participants became fully vested in that portion of their account which represents their contributions and the income earned thereon. Participants became 100% vested in the Company's contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age. Otherwise, a participant's interest in the Company's contributions and earnings thereon vests according to the following schedule:

Forfeitures

When certain terminations of participation in the Plan occurred, the nonvested portion of the participant's account represented a forfeiture, as defined by the Plan. Forfeited balances were first used to restore re-employed participants' accounts and any remaining amounts were able to be first used to pay plan expenses or to reduce Company contributions. No forfeitures were utilized during the period ended September 29, 2023 and \$977 of unallocated forfeitures were transferred to the Tufts 403(b) Plan. Unallocated forfeitures at December 31, 2022 were \$114.

Withdrawals and Distributions

Benefits were able to be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan were able to be made in lump sums, installment payments, partial withdrawals or annuities.

A participant was able to request a withdrawal upon attainment of age 59 ½ or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document. Participants were able to request a distribution of their rollover funds at any time.

Notes Receivable from Participants

Participants were able to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. Loans bore interest at a rate equal to the prime rate plus 1%. All loans must have been repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period was allowed. No more than one loan was able to be outstanding at any time. Principal and interest was generally repaid at least quarterly by participants directly to the plan custodian.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan were prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Investments, Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. No allowance for credit losses has been recorded as of September 29, 2023 or December 31, 2022.

Benefits Paid

Benefits were recorded when paid.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan Expenses

Certain recordkeeping fees and participant transaction fees incurred by the Plan were paid through the Plan. All other expenses incurred by the Plan are paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. Investment related expenses were included in net depreciation in fair value of investments.

Subsequent Events

The Employer has evaluated subsequent events through July 12, 2024, the date that the financial statements were available to be issued. There were no subsequent events.

Note 3 - Information Certified by Custodian

Plan investments were held by the Plan's custodian, Fidelity Management Trust Company ("Fidelity"). The fair value of investments as of December 31, 2022, and all investment transactions for the period January 1, 2023 to September 29, 2023, including interest and dividends and net appreciation in fair values were reported to the Plan and certified as complete and accurate by the custodian. The Plan offered investment choices to allow Participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants in the Plan could direct contributions to a variety of investment options.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022.

Mutual funds (Including mutual funds and cash reserves in Self-directed brokerage accounts): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Risks and Uncertainties

The Plan provided for various investment options in registered investment companies and self-directed funds which hold investment securities. Market risks include global events such as an international conflict which could impact the value of investment securities. Due to the level of risk associated with certain investment securities through December 31, 2022, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6 - Related-Party Transactions and Exempt Party-In-Interest Transactions

ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provided services to the Plan or an Employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the custodian through December 31, 2022 were considered party-in-interest transactions. During the period ended September 29, 2023, \$166,966 was paid by the Plan for vendor and administrative services.

During the period ended September 29, 2023, the Plan received revenue credits of \$37,500 from Fidelity. The revenue credits are reported as other income on the Statements of Changes in Net Assets Available for Benefits. The credits are used to offset Plan expenses.

Note 7 - Tax Status

The Plan was initially designed to comply with the provisions of Section 403(b) of the IRC and had been amended and restated effective January 1, 2021. The Plan has not obtained a tax determination letter from the Internal Revenue Service ("IRS"). However, the Plan administrator believes that the Plan and related trust was designed and operated in compliance with plan terms and the applicable requirements of the IRC and is, therefore, exempt from federal income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
