## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the HMH 401(k) Savings Plan – HUMC & PMC Grandfathered Participants

### **Opinion on the 2023 Financial Statements**

We have audited the accompanying financial statements of the HMH 401(k) Savings Plan – HUMC & PMC Grandfathered Participants, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), which comprise the statement of net assets available for benefits as of January 1, 2023 and the related statement of changes in net assets available for benefits for the one day ended January 1, 2023, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the HMH 401(k) Savings Plan – HUMC & PMC Grandfathered Participants as of January 1, 2023, and the changes in its net assets available for benefits for the one day ended January 1, 2023, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion on the 2023 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the 2023 Financial Statements* section of our report. #### **1. Description of Plan**

The following description of the HMH 401(k) Savings Plan – HUMC & PMC Grandfathered Participants (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

##### **General**

The Plan, which was created and became effective January 1, 2019, is a defined contribution plan operating under Section 401(k) of the Internal Revenue Code (“IRC”) and sponsored by Hackensack Meridian Health, Inc. (“HMH” or the “Network”). The Plan is subject to the provisions of ERISA, as amended.

During 2023, HMH formalized the merger of the Plan with and into the HMH 401(k) Savings Plan. As a result, net plan assets of \$43,920,381 were transferred from the Plan to the HMH 401(k) Savings Plan on January 1, 2023.

For Form 5500 purposes, all assets, liabilities and participants also ceased to be part of the Plan as of January 1, 2023 and such amounts are reported as zero on the 2023 Form 5500.

##### **Eligibility**

The Plan excluded employees who were not grandfathered in the Hackensack University Medical Center (“HUMC”) Retirement Income Plan or in the Palisades Medical Center Pension Plan.

##### **Contributions**

Each year, participants could contribute a minimum of 1% up to a maximum of 70% of their pretax compensation, as defined in the Plan document. Participants could also designate contributions as Roth contributions. The Plan provided for an automatic enrollment provision of 3% of compensation. Participants who had attained the age of 50 before the end of the Plan year were eligible to make additional “catch-up contributions”. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants directed the investment of their contributions into various investment options offered by the Plan.

Network fixed tiered matching contributions were equal to a uniform percentage of each tier of each participant’s elective deferrals. Each tier represented the amount of the participant’s applicable contributions that equaled the specified percentage of the participant’s compensation as follows: (i) the first tier matching percentage was 100% of elective deferrals equal to 2%, and (ii) the second tier matching percentage was 50% of elective deferrals equal to 3%. The employer match was made each pay period for full-time and part-time team members scheduled to work more than twenty hours per week, and for per diem team members.

The Plan provided for a 1.5% nonelective contribution that was calculated and contributed annually and also provided additional annual transition credits for eligible employees. To receive nonelective contributions and transition credits, unless they retired, became disabled, or died during the Plan year, participants must have been employed on the last day of the Plan year and worked 1,000 hours during the Plan year.

##### **Participant Accounts**

Each participant’s account was credited with the participant’s contribution, Network matching contributions, Network nonelective contributions and Plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances or specific participant transactions, as defined in the Plan document. The benefits to which a participant was entitled were the benefits that could have been provided from the participant’s vested account.

##### **Vesting**

Participants were fully and immediately vested in their own contributions, rollover contributions and actual earnings thereon. Participants became fully vested in Network matching contributions and Network nonelective contributions after three years of service.

Notwithstanding the above vesting for Network matching and nonelective contributions, a participant became 100% vested in these accounts upon their attainment of normal retirement age (65), early retirement age (55 with 10 years of service) or on account of their termination of employment due to death or disability while an employee.

#### **Forfeited Amounts**

When certain terminations of participants in the Plan occur, the nonvested portion of the participant's account, as defined, represents a forfeiture. Forfeitures were used to reinstate previously forfeited accounts, to pay Plan expenses or to reduce employer contributions. The unallocated forfeiture balance was \$0 and \$26,455, as of January 1, 2023 and December 31, 2022, respectively. Due to the merger of the Plan, unallocated forfeitures of \$26,455 were transferred to the HMH 401(k) Savings Plan.

#### **Notes Receivable from Participants**

Participants could generally borrow from their fund accounts the lesser of \$50,000 or 50% of their vested account balance. Generally, the minimum loan amount was \$1,000. Loans were secured by the balance in the participant's account and bore interest at the prime rate plus 1% as of the date of the loan initiation. All loans were directly from the participant's accumulations of elective deferral contributions and rollover contributions. Notes terms ranged from one to five years or up to twenty years for the purchase of a primary residence. A participant could only have two loans outstanding at any time. Loans were repaid directly by the participant to the Plan trustee. Due to the merger of the Plan, notes receivable from participants of \$280,014 were transferred to the HMH 401(k) Savings Plan.

#### **Payment of Benefits**

Participants could elect to receive the vested portion of their account starting at age 59-1/2 without any penalty or upon the date on which the participant terminated employment with the Network. Hardship withdrawals were permitted for circumstances defined in the Plan document. In addition, minimum payments must have begun subject to Internal Revenue Service ("IRS") guidelines.

Participants were entitled to receive the full amount credited to their individual retirement accounts primarily in the form of a lump sum or partial withdrawals. No more than five distributions could be made to a participant during a Plan year. Provisions were also made for death, disability and termination benefits.

## **2. Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contracts and their related activity on a contract value basis (see Note 5).

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results may differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by trustees, custodians and investment advisors. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was accrued when earned. Dividend income was recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments included the Plan's gains and losses on investments bought and sold as well as held during the period. Income generated from revenue sharing agreements was reported in the statement of changes in net assets available for benefits as net appreciation or depreciation in fair value of investments.

#### **Notes Receivable from Participants**

Notes receivable from participants (participant loans for Form 5500 reporting purposes) were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans were reclassified as distributions based upon the terms of the Plan document.

#### **Excess Contributions Payable**

The Plan is required to return contributions received during a Plan year in excess of the IRC limits. As of December 31, 2022, the Plan had excess contributions. Such excess contributions are recorded as a liability with a corresponding reduction to contributions. The 2022 excess contributions were distributed to the applicable participants during 2023 subsequent to the Plan's merger into the HMH 401(k) Savings Plan (see Note 1).

#### **Payment of Benefits**

Benefit payments were recorded when paid.

#### **Administrative Expenses**

All reasonable administrative expenses and fees necessary to operate and administer the Plan were paid by the Plan, unless otherwise paid by Network. Expenses of maintaining the Plan that were paid directly by the Network are excluded from these financial statements. A participant's account could have been charged for expenses associated with a specific optional feature, including administration of participant loans, elected by that participant, and were included in administrative expenses. Certain investment-related expenses were included in the net appreciation or depreciation in fair value of investments.

### **3. Information Certified by Qualified Institutions**

The Plan administrator having determined that it is permissible in the circumstances elected to have the 2022 audit of the Plan performed in accordance with ERISA Section 103(a)3(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Teachers Insurance and Annuity Association ("TIAA") and College Retirement Equities Fund, insurance companies and qualified institutions, which controlled TIAA, FSB, trustee and qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-responsive investment contracts, at contract value and notes receivable from participants, as shown in the statement of net assets available for benefits as of December 31, 2022.

### **4. Investments and Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in

active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of January 1, 2023 and December 31, 2022.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Due to the merger of the Plan, there were no investments held by the Plan as of January 1, 2023 (see Note 1).

## 5. Contracts with Insurance Companies

The Plan holds the Teachers Insurance and Annuity Association ("TIAA") Stable Value Fund, a traditional investment contract. This fund meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings less participant withdrawals, and administrative expenses.

The fund is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified rate that is guaranteed to the Plan. The crediting rate is based on a formula established

by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a semi-annual basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. As of January 1, 2023 and December 31, 2022, the high credit ratings of Teachers Insurance and Annuity Association and College Retirement Equities Fund uphold its ability to meet obligations set forth in contracts.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. No events have occurred or are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value.

As part of the merger of the Plan with and into the HMH 401(k) Savings Plan, fully benefit-responsive investment contracts, at contract value of \$5,211,770 were transferred to the HMH 401(k) Savings Plan (see Note 1).

#### **6. Risks and Uncertainties**

The Plan provides for various investment options in any combination of registered investment companies (mutual funds) and a guaranteed annuity contract monitored by affiliates of the trustee. Investment securities are exposed to various risks; such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

#### **7. Related Party and Party-in-Interest Transactions**

Certain Plan investments are managed by affiliates of the insurance companies and trustee, and therefore, these transactions qualify as party-in-interest transactions. The Plan also issues participant loans to its participants, which are secured by the participants' account balances. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan are performed by officers or employees of the Network. No such officer or employee receives compensation from the Plan.

#### **8. Plan Termination**

The Network has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated or upon complete discontinuance of contributions, the rights of the participants in the Plan at the date of termination or discontinuance shall be nonforfeitable.

#### **9. Tax Status**

Effective January 1, 2022, the Network adopted TIAA's Non-Standardized Defined Contribution Pre-Approved Plan. The IRS issued an opinion letter, dated October 7, 2020, stating that the pre-approved plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of January 1, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

#### **10. Subsequent Events**

The Plan has evaluated subsequent events through July 15, 2024, the date the financial statements were available to be issued.
