**NOTE 1 - DESCRIPTION OF PLAN**

The following description of PALNET 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of Premier Asset Logistics Network, LLC, (the "Company" or "Plan Sponsor") who have completed 6 months of service and are age 21 or older. Employees classified as union employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions: Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan, not to exceed certain limits of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company contributes a safe harbor matching contribution in an amount equal to 100% of participant's elective deferrals up to 3%, plus 50% of participant's elective deferrals between 3% and 5%. Safe harbor matching contributions for the period from January 1, 2023 to September 5, 2023 were \$28,140. The Company may, at its discretion, make additional profit sharing contributions to the Plan on an annual basis. There were no such profit sharing contributions for the period from January 1, 2023 to September 5, 2023.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings, and (c) forfeitures of employer profit sharing contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Vesting: Participants are vested immediately in their contributions and rollovers plus actual earnings thereon. Participants are immediately vested in the safe harbor employer match. Discretionary employer contributions credited to a participant's account vest based on years of continuous service and become 100% vested after two years of service.

Payment of Benefits: Upon termination of service, a participant is eligible to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a single lump sum distribution or rollover to another qualified retirement plan. In certain circumstances, participants may make "hardship withdrawals" as defined in the Plan. Active participants may also take distributions from the Plan upon attainment of age 59½.

Forfeitures: Forfeitures of employer profit sharing contributions are used to offset future employer contributions or administrative expenses of the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. See below for discussion on September 5, 2023 Plan Merger.

**NOTE 1 - DESCRIPTION OF PLAN** (Continued)

Administrative and Investment Management Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Plan recordkeeping and custodial fees are paid by the Plan and are reflected in the financial statements as administrative expenses. Investment management fees are charged to the Plan as a reduction of investment return and included in net appreciation (depreciation) in fair value of investments reported by the Plan.

Plan Merger: Effective September 5, 2023, Plan assets held by PALNET 401(k) Plan were legally merged into Kamps Retirement Savings Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2023 to September 5, 2023.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 - CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements, including investments held at September 5, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest, and dividends for the period from January 1, 2023 to September 5, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Nationwide Trust Company, FSB, the trustee of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

*Mutual funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under the Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan invests in mutual funds that are managed by affiliates of Nationwide Trust Company, FSB (“Nationwide”), the custodian of the Plan. These transactions, as well as custodial fees, recordkeeping fees, investment management fees and certain professional fees for the administration of the Plan that were paid to Nationwide or its affiliates, Meeder Investment Management and Silver Oaks Securities, Inc., qualify as party-in-interest transactions. Some administrative expenses of the Plan are paid directly by the Company.

**NOTE 6 - TAX STATUS**

The Plan has adopted a Volume Submitter Profit Sharing Plan (“Volume Submitter”). The IRS issued an opinion letter dated June 30, 2020, indicating that the Volume Submitter adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan itself. Although the Plan has been amended from the original Volume Submitter document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 5, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

**NOTE 7 - SUBSEQUENT EVENTS**

Plan management has performed an analysis of activities and transactions subsequent to September 5, 2023 to determine the need for any adjustment to and/or disclosures within these financial statements for the period from January 1, 2023 to September 5, 2023. Plan management has performed their analysis through July 12, 2024, which was the date that the financial statements were available to be issued and determined there are no subsequent events to disclose.
