Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sigma Supply of North America, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of September 30, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through September 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2023 and December 31, 2022, and for the period from January 1, 2023 through September 30, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis-of-Matter

As further discussed in Note 1 to the financial statements, effective September 30, 2023, the Plan was merged into the Envoy Solutions Retirement Savings Plan. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the

supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements
September 30, 2023 and December 31, 2022

(1) Description of the Plan

The following description of Sigma Supply of North America, Inc. Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General: The Plan was a defined contribution plan intended to qualify under section 401(a) of the Internal Revenue Code, covering all full-time employees of Sigma Supply of North America, Inc. (the “Company”) and its affiliates, Sigma Supply, Inc. and Sigma Business Essentials, LLC, who had completed three months of service and were age twenty-one or older. Investments were directed by the individual participants within limits established by the Company.

The plan sponsor, Sigma Supply of North America, Inc. was purchased by another company during the year ended December 31, 2022. In May 2023, the plan sponsor resolved to merge the Plan into the Envoy Solutions Retirement Savings Plan. As a result, all investments were transferred from the Plan into the Envoy Solutions Retirement Savings Plan on September 30, 2023, with participants of the Plan becoming participants in the Envoy Solutions Retirement Savings Plan.

Contributions: Eligible employees could make elective deferrals of their compensation up to the IRS allowed limits. Participants could also contribute amounts representing eligible rollover distributions from other qualified benefit or contribution plans. Participants directed the investment of all contributions into various investment options offered by the Plan. The Plan offered various mutual funds, collective trust funds, and a guaranteed investment contract as investment options for participants. Annually, the Company could elect to make safe harbor matching contributions equal to 100% of participant contributions up to 3% of eligible wages, plus 50% of participant contributions from 3% to 5% of eligible wages. The Company could, in its sole discretion, make a profit-sharing contribution for each plan year.

Participant Accounts: Each participant’s account, in addition to a salary deferral contribution, was credited with an allocation of (a) the Company’s contribution, (b) the account’s earnings, and (c) charged with his or her withdrawals and an allocation of administrative expenses. Allocations were based on participant’s earnings or account balances, as defined by the plan document. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account.

Forfeited Accounts: Forfeited nonvested amounts could be used to pay administrative expenses of the Plan or to reduce the Company’s matching contribution. The Plan’s forfeiture account held balances of \$0 and \$118 at September 30, 2023 and December 31, 2022, respectively.

Vesting: Participants were immediately vested in their elective deferral, rollover, and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company’s

discretionary profit-sharing contributions plus earnings thereon was based on years of continuous service. A participant was 100 percent vested after six years of credited service.

Payment of Benefits: Upon termination of service, due to death, disability or retirement, an employee could elect to receive either a lump-sum amount equal to the value of his or her respective account or a direct rollover to another qualified plan.

Administrative Expenses: The Company paid certain administrative expenses of the Plan, which have been excluded from these financial statements. Certain administrative expenses of maintaining the Plan were paid by the Plan and allocated to participants. Participants could also be charged direct, one-time fees upon disbursement of certain distributions and loan proceeds, as stated in the Plan's service agreement with its third-party record keeper.

Notes Receivable from Participants: Participants could borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account and bore interest at a rate commensurate with local prevailing borrowing rates as determined by the plan administrator. Principal and interest was paid ratably through payroll deductions. All loans, other than those used to acquire the principal residence of a participant, were for a term not to exceed 5 years.

(2) **Summary of Significant Accounting Policies**

The following is a summary of the significant accounting policies used by the Plan in the preparation of the accompanying financial statements.

Basis of Accounting: The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America, requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value, except for the fully benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are recorded at their unpaid principal balance plus accrued interest. Interest income is recorded when it is earned. If a participant ceases to make loan repayments, and the plan administrator deems the loan to be a

distribution in accordance with the Plan's loan policy, the note balance is reduced and a benefit payment is recorded.

Benefits Paid to Participants: Benefits are recorded when paid.

(3) Risks and Uncertainties

The Plan invested in various investment securities that are exposed to significant risks due to the volatility of the stock market in general. As such, any significant change in the stock market as a whole could directly affect the value of the Plan's assets.

(4) Information Certified by Trustees

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedules that was certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustees that such information is complete and accurate.

- Investments, at fair value
- Investments, at contract value
- Notes receivable from participants
- Investment income
- Interest income on notes receivable from participants

(5) Reconciliation of Financial Statements to Schedule H of Form 5500

There were no significant reconciling differences between the financial statements and form 5500.

(6) Tax Status

The Plan obtained its latest determination letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan was designed and operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore believe that the Plan was qualified.

The Plan's information returns are subject to examination by the Department of Labor and the Internal Revenue Service generally for three years after they were filed.

(7) **Fair Value Measurement**

Under FASB ASC 820-10, three prioritized valuation inputs may be used to determine fair value at the measurement date: Level 1 – quoted prices (unadjusted) in active markets for identical assets or liabilities; Level 2 – observable inputs other than the quoted prices included in Level 1; Level 3 – unobservable inputs. There have been no changes in valuation methodologies during the periods under audit, therefore no recognition of gain or loss is required for these financial statements.

Mutual funds are deemed to be actively traded and valued at the daily closing price as reported by the fund.

Collective trust funds are valued at the daily net asset value (NAV) of units of each collective trust, as provided by the trustees. These funds are measured at fair value using the NAV per share practical expedient and have not been classified in the fair value hierarchy. The fair value amounts presented in the above tables are intended to permit reconciliation of the fair value of investments in the fair value hierarchy to the amounts presented in the statements of net assets available for benefits. Participant transactions may occur daily. There were no unfunded commitments or relevant redemption restrictions on such investments held by the Plan for the period and year ended September 30, 2023 and December 31, 2022. The investment strategies for these funds are not presented as each fund files as a direct filing entity.

(8) Contract with Insurance Company

Effective March 3, 2020, the Plan entered into a fully benefit-responsive investment contract with Great West Life and Annuity Insurance Company (GWI). GWI maintained the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The crediting interest rate was based on a formula established by the contract issuer but may not be less than 0%.

Because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by GWI, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limited the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Effective September 30, 2023, the guaranteed investment contract was terminated and proceeds transferred as part of the plan merger as described in Note 1.

(9) Party-In-Interest Transactions

During the period, the Plan incurred and paid \$40,943 to outside service providers for general administration, investment advisory, and record keeping services. Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employer association, or relatives of such persons.

(10) Subsequent Events

The Plan has evaluated subsequent events through July 12, 2024, the date the financial statements were available to be issued.
