INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Valley Community Mental Health 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits - modified cash basis as of September 30, 2023 and 2022, and the related statement of changes in net assets available for benefits - modified cash basis for the year ended September 30, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Valley Community Mental Health 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of September 30, 2023 and 2022 and for the year ended September 30, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Valley Community Mental Health 403(b) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

September 30, 2023

Note 1. Plan Description

The following description of the Valley Community Mental Health 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Valley Comprehensive Community Health Center, Inc., dba Valley HealthCare System (the Agency). The Agency is the administrator and trustee of the Plan. Equitable Financial Life Insurance Company is the custodian of the assets. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make contributions to the Plan by electing to defer a percentage of salary, up to the maximum percentage allowable under the provisions of the Internal Revenue Code. Participants may designate their contributions to the Plan as after-tax Roth deferrals. The Plan also permits participants to make catch-up contributions at age 50 and accepts rollovers from other qualified plans. The Agency makes a discretionary contribution to eligible participants that have attained age 21 and completed one year of service up to 4.5% of participant contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Agency's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in their employee contributions plus actual earnings thereon. Vesting in the employer contributions portion of their accounts plus earnings thereon is based on years of credited service as follows:

After 1 year of service - 25% vesting
After 2 years of service - 50% vesting
After 3 years of service - 75% vesting
After 4 years of service - 100% vesting

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or substantially equal installments. The Plan permits the Agency to automatically distribute the vested portion of a terminated participant's account balance if it is less than \$1,000. Hardship distributions are permitted, and are limited to the lesser of the cumulative value of the elective deferrals or the value of such contributions on the date of withdrawal.

Note 1. Plan Description (Continued)

Income Tax Status

The Internal Revenue Service has not established a process for individual plan determination letters for 403(b) plans. However, the plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of September 30, 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in financial statements.

Plan Termination

Although it has not expressed any intent to do so, the Agency has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Agency may determine.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared using the modified cash basis of accounting. Under this basis, investment income and contributions to the Plan are recognized when received rather than when earned and expenses are recognized when paid rather than when incurred.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are required to be reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Agency, as provided by the plan document. Certain administrative functions are performed by employees of the Agency, at no cost to the Plan. These employees are also Plan participants. No such officer or employee received compensation from the Plan.

Subsequent Events

The date through which events occurring after September 30, 2023, have been evaluated for possible adjustment to or disclosure in the financial statements is April 25, 2024, which is the date the financial statements were available to be issued.

Note 3. Certification

Certain information was certified as complete and accurate by Equitable Financial Life Insurance Company, the Plan's custodian. The information is as follows:

- Investment assets
- Investment transactions
- Investment income

Note 4. Investment Contract with Insurance Company

Assets of the Plan are held under a deferred annuity contract with Equitable Financial Life Insurance Company (Equitable). Participants may allocate their account values to the General Interest Account, an interest bearing account in connection with the General Account of Equitable, or to any of the funds of Equitable Separate Account No. 2.

Amounts allocated to the General Interest Account, which is not considered a fully benefit-responsive investment contract, become part of the general assets of Equitable which are available to support insurance and annuity obligations of all of Equitable's lines of business as well as its routine business activities. All amounts accumulated are guaranteed by Equitable and are generally payable in full upon the participant's request, subject to Plan and contract provisions, but assets of the General Account are subject to the claims of the general creditors of Equitable. Interest is credited to deposits held in the General Interest Accumulation Account at rates determined by Equitable (currently 1.00-3.00 percent). Withdrawals may be subject to withdrawal fees of up to 6%.

Note 4. Investment Contract with Insurance Company (Continued)

The Equitable Separate Account No. 2 (Separate Account) is registered with the SEC as a unit investment trust under the Investment Company Act of 1940. However, the SEC does not supervise the management or investment practices or policies of the Separate Account. The Separate Account is divided into distinct funds. Each fund invests its assets in an underlying fund, and the name of each Separate Account Fund reflects the name of the corresponding underlying fund. The assets of the Separate Account are the property of Equitable, however, assets attributable to participants' account values cannot be charged with liabilities from other businesses that it conducts. Investments in variable options are carried at fair value, as further described in Note 5.

Note 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at September 30, 2023 and 2022.

General Interest Account: Carried at contract value, as computed by Equitable, which equals contributions and transfers in, plus interest, minus withdrawals and transfers out, and annual and withdrawal fees specified in the contract. Contract value is deemed to approximate fair value, since participants may generally transact at contract value.

Pooled Separate Accounts: Reported at the daily Net Unit Values ("NUV's") which represents the Net Asset Value ("NAV") of the underlying mutual fund less daily charges. The NUV, as computed by the custodian, is used as a practical expedient to estimate fair value.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
