We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter

As discussed in Note 1 to the financial statements, the Plan was merged into the Westinghouse Electric Company Savings Plan effective September 27, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued. Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgement made by a reasonable user based on the financial statements. In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following description of the WECTEC Staffing Services 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document or summary plan description for a complete description of the Plan's provisions.

The Plan was established on February 1, 2016 to provide a retirement savings plan to eligible employees of WECTEC Staffing Services LLC (the Company), which was established as a new company on December 14, 2015.

On September 18, 2023, the board of directors adopted a resolution to merge the Plan into the Westinghouse Electric Company Savings Plan effective September 27, 2023. As a result of the merger, approximately \$6,368,000 in net assets were transferred from the Plan.

General – The Plan was a defined contribution plan covering all employees of the Company. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Each year, participants could contribute from 1% to 75% of their compensation, in increments of 1%, subject to Internal Revenue Code (IRC) limitations. Participants could also contribute amounts representing distributions from other defined contribution plans and, in certain cases, defined benefit plans. The Company was not permitted to make contributions to the Plan.

Employees who attain age 50 by the end of the calendar year could make voluntary catch-up contributions as permitted under the Economic Growth and Tax Relief Reconciliation Act (EGTRRA), subject to limitations of the IRC.

Upon enrollment, a participant could direct the investment of employee contributions and any earnings thereon. Participants could change their investment options daily.

Vesting – Participants were immediately vested in their contributions plus actual earnings thereon.

Participant Accounts – Each participant's account was credited with the participant's contributions and Plan earnings and was charged with an allocation of administrative expenses. Allocations of Plan earnings were based on account balances. Allocations of administrative expenses were based on a per-participant rate. The benefit to which a participant was entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants – Participants could borrow from their accounts 50% of their vested account balance, with a minimum of \$1,000 and a maximum of \$50,000, reduced by the highest outstanding loan balance during the preceding 12 months. Loan terms ranged up to five years. Loans were secured by the balance in the participant's account and bear a reasonable interest rate as determined by the Plan administrator. Principal and interest repayments were made ratably through biweekly payroll deductions.

Payment of Benefits – On termination of service, participants could receive a lump-sum amount equal to the value of their account. Upon death of the participant, the participant's beneficiary could receive a lump-sum amount equal to the value of the account. If the value of a participant's vested account is \$5,000 or less, payment occurred automatically via rollover if between \$1,000 and \$5,000, or via a cash lump-sum payment if less than \$1,000.

2. Summary of Significant Accounting Policies

A summary of significant accounting policies consistently applied by the Plan administrator in the preparation of the accompanying statements of net assets available for benefits and related statement of changes in net assets available for benefits and the related notes to the financial statements (financial statements) follows:

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes Receivable From Participants – Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded. As of September 27, 2023, notes receivable from participants were transferred to the Westinghouse Electric Company Savings Plan. No allowance for credit losses has been recorded as of December 31, 2022.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value (except for the guaranteed investment contract that is stated at contract value) (see Note 4), which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 5 for further discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses – Certain expenses incurred in maintaining the Plan are paid directly by the Company and are excluded from these financial statements, while others are paid for by the Plan and are included in administrative expenses. Expenses paid by the company are not material. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events – The Plan has evaluated subsequent events through July 11, 2024, the date the financial statements were available to be issued.

3. Investments (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held December 31, 2022, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period of January 1, 2023 through September 27, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (Empower) (the trustee of the Plan).

4. Guaranteed Investment Contract with an Insurance Company

The Plan has entered into a fully benefit-responsive investment contract with Empower that invests contributions in the Key Guaranteed Portfolio Fund, a general account product. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed annuity contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- a. amendments to the Plan document (including complete or partial Plan termination or merger with another plan);

- b. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
- c. bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan; or
- d. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The Plan does not believe any of the aforementioned events have occurred that would limit the ability of the Plan to transact at contract value. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

5. Fair Value Measurement

The Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 Fair Value Measurements, includes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs to the valuation methodology include:
 - Quoted prices for similar assets and liabilities in active markets.
 - Quoted prices for identical or similar assets or liabilities in markets that are not active.
 - Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals).
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

5. Fair Value Measurement (continued)

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value:

Registered investment companies: valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

As of September 27, 2023, all investments were transferred to the Westinghouse Electric Company Savings Plan. The Plan's assets at fair value as of December 31, 2022 set forth by level, within the fair value hierarchy, are as follows:

6. Income Tax Status

The Plan has adopted a volume-submitter profit-sharing plan with a cash or deferral arrangement. The volume-submitter profit-sharing plan received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020 as to the volume-submitter plan's qualified status. Although the Plan has been amended, the Plan administrator believes the Plan is designed and being operated in compliance with applicable sections of the IRC and, therefore, believes the Plan is qualified and the related trust tax-exempt.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of September 27, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. While there are no ongoing examinations, the Plan is subject to examination for years through 2020.

7. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

8. Related Parties

Certain administrative functions of the Plan are performed by members, officers and employees of the Company at no cost to the Plan.
