Independent Auditors' Report

To the Trustee and Participants of
United States Gold Bureau 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of United States Gold Bureau 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 7, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to September 7, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 7, 2023 and December 31, 2022, and for the period from January 1, 2023 to September 7, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Emphasis of Matter - Plan Merger

As discussed in Note 1, the Plan was merged with and into the Voyager Pooled Employer Plan effective September 7, 2023. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Notes to Financial Statements

Period from January 1, 2023 to September 7, 2023

1. Description of Plan

The following brief description of United States Gold Bureau 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - Effective September 7, 2023, USGB, LLC dba United States Gold Bureau (the “Company”) elected to merge the Plan with and into the Voyager Pooled Employer Plan (the “Voyager PEP”). Prior to the merger, the Plan was a defined contribution plan covering substantially all employees of the Company. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). An officer of the Company was the Plan’s trustee, Company management personnel administered the Plan internally and Nova 401(k) Associates (“Nova”) was a third-party administrator for the Plan. The Plan’s custodian and recordkeeper was Voya Retirement Insurance and Annuity Company (the “Custodian”).

Eligibility - Prior to the merger, employees that had completed sixty days of service were eligible to participate in the Plan on the first day of the month coinciding with or next following the date the eligibility requirement was met. Union employees and nonresident aliens were excluded from participation in the Plan.

Contributions - Prior to the merger, participants could authorize the Company to withhold pre-tax and Roth 401(k) contributions up to the annual limit established by the Internal Revenue Code (“IRC”). A participant’s pre-tax and Roth 401(k) contributions were separately accounted for, as were the gains and losses attributable to each. Participants who reached fifty years of age before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing pre-tax and Roth 401(k) distributions from other qualified retirement plans, annuity contracts, or individual retirement accounts and repayments of 2020 penalty-free distributions permitted under the Coronavirus Aid, Relief, and Economic Security Act.

The Company made a safe harbor employer matching contribution in an amount equal to 100% of the first 3% of contributed compensation and 50% of the next 2% of contributed compensation.

The Company could also make discretionary employer matching and profit-sharing contributions. The discretionary employer contributions were subject to certain conditions described in the Plan document, although none were elected during the period from January 1, 2023 to September 7, 2023.

Participants directed the investment of their contributions into various investment options offered by the Plan.

Participant Accounts - Prior to the merger, each participant's account was credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings, and could be charged with an allocation of Plan expenses, as applicable. Allocations were based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Notes Receivable from Participants - Notes receivable from participants were not permitted.

Vesting - Prior to the merger, participants were immediately vested in their voluntary and safe harbor matching contributions plus actual earnings thereon. Participants were 100% vested in the Company's discretionary matching and profit-sharing contributions plus actual earnings thereon after six years of credited service, as defined, which was earned in 20% increments annually after two years. Participants could also become fully vested upon reaching retirement age, if they became disabled while employed with the Company or terminated employment due to death.

Payment of Benefits - Prior to the merger, benefits were generally payable upon disability, death, retirement or termination of employment. Benefits equal to the participant's vested account balance could be paid to a participant or beneficiary by lump sum, partial withdrawals or rollover into a qualified plan, subject to regulatory requirements. Required minimum distributions were made to applicable participants in the absence of adequate distribution elections. Generally, if no longer employed by the Company, participants had to either take a lump sum distribution or begin systematic, actuarially determined withdrawals by April 1 of the year following the year in which the participant turns 73 years of age (an increase from 72 years of age effective January 1, 2023). The Plan administrator could, without the participants' consent, i) distribute separated participants' account balances that were less than \$1,000 in a lump sum or ii) transfer separated participants' account balances that were at least \$1,000 but less than \$5,000 into an individual retirement account. In-service hardship and qualified reservist distributions were permitted if certain criteria were met.

Forfeitures - Prior to the merger, forfeitures by participants of unvested Company contributions could be used to reduce future employer contributions and pay Plan administrative expenses. There were no forfeitures available for use as of September 7, 2023 and December 31, 2022, or during the period from January 1, 2023 to September 7, 2023.

Current Legislation - The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income and simplify plan rules and administrative procedures. Each of the provisions in SECURE 2.0 has its own effective date, all of which range over the next several years. Any SECURE 2.0 amendments must be adopted by the Plan no later than December 31, 2026, although it may operate under the new provisions as required or elected prior to amending the Plan document.

2. Significant Accounting Policies

Basis of Accounting - The Plan's financial statements are reported on the accrual basis of accounting.

Accounting Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's fiduciaries determine the Plan's valuation policies utilizing information provided by the investment advisors and Custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the Plan year.

Contributions - Contributions from participants and any related employer matching contributions are recorded in the year in which the participant contributions are withheld from compensation.

Benefits Paid to Participants - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from the financial statements. Fees related to distributions and certain other fees are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties - Financial instruments which potentially subject the Plan to concentrations of credit risk consist primarily of investment securities in which the Plan invests. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events - The Company has evaluated subsequent events through July 9, 2024, the date the financial statements were available to be issued, and no events have occurred through that date that would impact the financial statements.

3. Information Certified by the Custodian

All information disclosed in the accompanying financial statements, notes and supplemental schedule related to the Plan's investments as of September 7, 2023 and December 31, 2022, and the net appreciation in fair value of investments during the period from January 1, 2023 to September 7, 2023, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Custodian.

4. Fair Value Measurements

The Plan follows a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodologies used as of December 31, 2022.

Pooled separate accounts: Separate accounts are accounts maintained by an insurance company that are used for the collective investment of funds from multiple employee benefit plans. The fair values of these investments have been estimated using the net asset values per unit as a practical expedient, as provided by the insurance company, and are based on the fair value of the underlying assets of each separate account less accrued operating expenses. This practical expedient would not be used if it is determined to be probable that the insurance company will sell the investments for an amount different from the reported net asset values.

All of the Plan's investments at fair value as of December 31, 2022 were measured at net asset value; therefore, they are not leveled within the fair value hierarchy.

The following table details the fair value of the separate accounts by class, which is measured using the net asset value per share practical expedient as of December 31, 2022. The investment strategies for each class are also listed below. The Plan held no investment assets as of September 7, 2023.

^A These funds invest in a combination of assets such as aggressive stocks, international stocks, large-company stocks, government bonds, foreign bonds or money markets. The allocation percentage to each asset type may be fixed, bounded by a range, or determined at the discretion of the manager.

^B These funds seek long-term growth of capital or a combination of growth and income by investing primarily in stocks of larger, mature companies. Stocks are selected for price appreciation and for the value of the current income provided through dividends.

^C These funds employ investment styles of growth, value, or a blend of growth and value. These funds seek capital appreciation by investing primarily in stocks of small and medium-sized companies. Generally, these companies strive to develop new products or markets and have above-average earnings growth potential.

^D These funds invest primarily in stocks of larger United States (“U.S.”) companies. Funds emphasizing growth stocks will typically have higher price/earnings ratios and make little or no dividend payments.

^E There are three main types of funds in this category. International funds invest in stocks of companies outside of the U.S. Global funds invest in stocks of companies in the U.S. and developed countries outside of the U.S. Emerging markets funds invest in securities of developing countries and demonstrate the greatest volatility of performance due to the unstable nature of their economies, political structures and currencies.

^F These funds seek to balance growth of principal and current income by investing in a combination of stocks and bonds (generally holding 60-70% equity and 30-40% fixed income). The investment style is either moderate allocation or conservative allocation.

^G Assets are invested in fixed income securities that have been determined to be appropriate for the investment goal. Investors are primarily seeking income or growth of income, with less emphasis on capital appreciation. Funds in this asset class vary greatly in their risk profiles.

5. Fully Benefit-Responsive Investment Contract

The Plan invested in a fully benefit-responsive investment contract with the Custodian (or “Issuer”), the Voya Fixed Account (4450), where the Custodian maintained the contributions in a general account. The Custodian’s general account was credited with contributions and earnings, including interest and dividends, on the underlying investments and was charged for participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There were no reserves against contract value for credit risk of the Issuer or otherwise.

The investment contract, which totaled \$0 and \$726,730 as of September 7, 2023 and December 31, 2022, respectively, was considered a “traditional” contract, meaning that the Plan owned the contract itself and not the underlying assets of the investment contract.

The terms of the contract prohibit transfer or assignment of rights under the contract, as defined, and there was frequent resetting of contractual interest rates based upon market conditions and no defined maturities. Certain events could limit the ability of participants to withdraw their funds. Such events included the following: i) certain amendments to the Plan documents (including complete or partial plan termination or merger with another plan); ii) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions; iii) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. These events could limit the ability of the Plan to transact at contract value due to a market value adjustment, although the Company could elect an alternative payment option that allowed for installment payments at contract value over a period not to exceed five years. Although the Plan merged with and into the Voyager PEP effective September 7, 2023 (Note 1), a market value adjustment was not required as the Voya Fixed Account (4450) was also an available investment option under the Voyager PEP.

The Plan or the Custodian could terminate the contract by providing written notice to the other party 90 days prior to the termination date. If the contract was terminated, interest would not be less than the minimum interest rate established in the investment contract. The contract’s crediting interest rate was based on an agreed-upon formula with the Issuer, as defined, but could not be less than 1.00% and was credited daily.

6. Tax Status

The Company did not apply for a determination letter from the Internal Revenue Service (“IRS”) to determine if the Plan was designed in accordance with applicable sections of the IRC. The Plan document is based upon a pre-approved plan instrument from Nova which received an IRS opinion letter dated June 30, 2020. Although the pre-approved plan instrument was amended since receiving the IRS opinion letter, the trustee and Plan administrator believe that the Plan was designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party-in-Interest and Related Party Transactions

Certain Plan investments were units of separate accounts and a general account held by the Custodian as of December 31, 2022 and during the period from January 1, 2023 to September 7, 2023. Fees incurred by the Plan for related investment management services and contract administration were included in net appreciation in fair value of investments and administrative expenses. Transactions such as these qualify as party-in-interest transactions. The Company pays directly certain other fees related to the Plan's operations.
