Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of EmblemHealth Services Company, LLC 401(k) Plan for Collectively Bargained Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of September 5, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period ended September 5, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of September 5, 2023 and December 31, 2022, and for the period ended September 5, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

1. Description of the Plan

The following description of the EmblemHealth Services Company, LLC 401(k) Plan for Collectively Bargained Employees (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Health Insurance Plan of Greater New York (HIP); EmblemHealth Plan, Inc. (EHPI); and EmblemHealth Services Company, LLC (the Company or EHS) who have one month of service and are members of the collective-bargaining unit represented by the Office and Professional Employees International Union, Local 153 AFL-CIO (OPEIU Local 153). The Plan was adopted by HIP on September 30, 2003 and became effective January 1, 2004. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Great-West Trust Company, LLC is the trustee and custodian of the Plan. Effective August 1, 2022, Great-West Trust Company, LLC's name was changed to Empower Trust Company, LLC (Empower).

Effective July 1, 2020, the Plan was amended to spin off and transfer the assets and benefit liabilities of active and former participants in the Plan who were represented by the clerical, marketing, and Melville clerical collective-bargaining units of OPEIU Local 153 to the OPEIU National Retirement Savings Plan (the OPEIU Plan). Effective July 1, 2020, EHS makes future contributions for employees covered by OPEIU Local 153 to the OPEIU Plan, and employees covered by OPEIU Local 153 will cease participation in and are no longer be eligible to participate in the Plan.

Effective September 5, 2023 (the Merger Date), the Plan merged with the EmblemHealth Services Company, LLC 401(k) Plan, a qualified defined contribution plan sponsored by the Company. All assets and liabilities of the Plan were transferred to the EmblemHealth Services Company, LLC 401(k) Plan as of the Merger Date.

Contributions

Participants are permitted to contribute to the Plan an amount up to 80% of their annual compensation, as defined, not to exceed the dollar limitation of \$22,500 for 2023, in accordance with Section 402(g) of the Internal Revenue Code (IRC). Participants aged 50 or older are eligible to contribute an additional catch-up contribution of \$7,500 for 2023. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, deferrals, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan offers various mutual funds, common collective trusts, and a fixed annuity as investment options to participants.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings allocated thereon.

Payment of Benefits

On termination of service, a participant may elect to receive either a lump-sum amount equal to the vested value of their account or installment payments payable monthly or quarterly not in excess of 15 years. A terminated participant may also elect to maintain the account balance in the Plan or select a direct rollover to an individual retirement account or another qualified plan.

Forfeitures

Forfeitures of terminated participants' non-vested accounts are first used to reinstate previously forfeited participant accounts. Any remaining forfeitures are used to pay certain Plan expenses. Forfeitures occur in a Plan year when a terminated participant received the vested portion of their account. Forfeitures in the amount of \$2,121 were used to pay Plan expenses during the period ended September 5, 2023. At September 5, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$45,684, respectively.

Notes Receivable from Participants

Participants may borrow from their account balance up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Notes are repaid within a period not to exceed five years, except for the purchase of a primary residence, which may be repaid over a reasonable period of time not to exceed ten years. Notes are secured by the balance in the participant's account and bear interest at a rate of 1% above the prime rate at the note's inception. The loan interest rates for 2023 range from 4.25% to 9.50%. The loan interest rates for 2022 range from 4.25% to 6.50%. No more than two notes may be outstanding at any given time.

Any outstanding balance of a note at the time of any distribution due to death, retirement, or termination of employment shall be deducted from the amount, which would otherwise have been payable to the participant. Generally, principal and interest are paid ratably through payroll deductions.

Fees charged by the trustee relating to notes receivable from participants are paid from the related participants' accounts.

Other Income

Other income represents income from Empower for the ERISA Spending Account (ESA), which may be used to pay Plan-related expenses or can be allocated to Plan participants during the year. The ESA is a Plan-level unallocated account held under the terms of the Plan, which may be credited with revenue in excess of the amount of compensation Empower received during the year. The revenue may include distribution fees and administrative fees that Empower or its affiliates received from the Plan's investment options. Revenue earned for the period ended September 5, 2023 totaled \$10,614. As of September 5, 2023 and December 31, 2022, the ESA had a balance of \$0 and \$25,059, respectively.

Expenses of the Plan

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event that the Plan is terminated, participants would remain 100% vested in their accounts.

As discussed in Note 1, effective September 5, 2023, the Plan merged with the EmblemHealth Services Company, LLC 401(k) Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the fully benefit-responsive contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 5 for a discussion of fair value measurements.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of investments, which consists of realized and unrealized gains or losses on investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Benefits Paid to Participants

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance, plus accrued interest. Delinquent notes are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of September 5, 2023 and December 31, 2022.

3. Risks and Uncertainties

The Plan provides for various investment options in any combination of funds offered by the Plan. These funds are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

4. Certified Investment Information

Certain information disclosed in the accompanying financial statements, related to investments and notes receivable from participants held as of September 5, 2023 and December 31, 2022, and net appreciation in fair value of investments, interest and dividends, interest income on notes receivable from participants, and other income for the period ended September 5, 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower and Empower Life & Annuity Insurance Company of New York (formerly Great-West Life & Annuity Insurance Company of New York) (ELA of NY), both qualified institutions.

5. Fair Value Measurement

GAAP establishes the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy, as defined by GAAP, are as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at September 5, 2023 and December 31, 2022.

Mutual Funds - These assets are valued at unadjusted quoted market prices, which represent the net asset value (NAV) of shares owned by the Plan at year-end.

Common Collective Trusts - These assets are valued based on the value of the units owned by the Plan. Unit value is based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means. The Plan's investment in the common collective trusts can be redeemed immediately at the current NAV per share as a practical expedient. There were no unfunded commitments as of September 5, 2023 and December 31, 2022.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Group Annuity Contract

The Plan has a fully benefit-responsive contract with ELA of NY amounting to \$0 and \$1,094,646 at September 5, 2023 and December 31, 2022, respectively. ELA of NY maintains the contributions in general accounts. ELA of NY is contractually obligated to repay the principal and the specified interest rate that is guaranteed to the Plan. Because the group annuity contract is fully benefit-responsive, it is valued at contract value. Contract value, as reported to the Plan by ELA of NY, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with ELA of NY. Such events include (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (i.e., divestiture or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption from ERISA. Plan management does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with the participants, is probable.

7. Party-in-Interest Transactions

Recordkeeping and certain administrative services are provided by Empower or its affiliates. These transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 1, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions also qualify as exempt party-in-interest transactions under ERISA. Notes receivable from participants also qualify as exempt party-in-interest transactions.

8. Tax Status

The Plan received a determination letter from the Internal Revenue Service (IRS) dated February 21, 2014 stating that, in design, it is a qualified plan under Section 401(a) of the IRC and, therefore, the related trust qualifies as a tax-exempt trust under Section 501(a) of the IRC. The Plan has been amended since receiving the determination letter. The Company and Plan management believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Company and Plan management believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Transfers to an Affiliated Plan

In the event that a Plan participant has a change in employment status such that the participant is no longer eligible to participate in the Plan but is eligible to participate in another defined contribution plan maintained by the Company or affiliate, the value of such participant's accounts will be transferred to the other plan when the participant has become eligible as a result of the change in employment status.
