## **I.M. Sulzbacher Center for the Homeless 403(b) Plan Notes to Financial Statements**

### **NOTE 1: DESCRIPTION OF THE PLAN**

The following description of the I.M. Sulzbacher Center for the Homeless 403(b) Plan (the “Plan”) provides only general information. Refer to the Plan document for a more complete description of Plan provisions.

#### ***General***

The Plan is a defined contribution plan covering all qualifying employees of the I.M. Sulzbacher Center for the Homeless, Inc. (the “Organization”). The Plan is subject to the provisions of the Department of Labor’s (DOL’s) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan, determines the appropriateness of the Plan’s investment offerings, and monitors investment performance.

Some administrative functions are performed by employees of the Organization. No compensation is remitted to the Organization for these services.

Plan assets are held and managed by Reliance Trust Company, which invests contributions and Plan earnings, makes investment transactions as directed by the Board of Directors. Massachusetts Mutual Life Insurance Company (“MassMutual”) provides certain recordkeeping services. Admin Partners acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

#### ***Eligibility***

Employees may become a participant of the Plan when they have reached 2 (two) months of service to make elective deferrals and the Organization matching contribution. An eligible employee may enter the Plan on the first day of the month coinciding with entry requirements have been met.

#### ***Contributions***

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants can elect to make post-tax Roth contributions also. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization matched 5% for the years ended December 31, 2020 and 2019, of eligible compensation that a participant contributed to the Plan. Additional profit sharing amounts may be contributed at the option of the Organization’s Board of Trustees with executive management making the recommendation and are invested in a portfolio of investments as directed by the Organization.

During the years ended December 31, 2020 and 2019, the Organization did not make any profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

## **I.M. Sulzbacher Center for the Homeless 403(b) Plan Notes to Financial Statements**

### **NOTE 1: DESCRIPTION OF THE PLAN (CONTINUED)**

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and Organization's matching contributions, as well as allocations of the Organization's profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are vested immediately in both employee and employer contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts is 100% at all times.

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through monthly payroll deductions

#### ***Benefit Payments***

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over their assumed life expectancy. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. The Plan administration may direct that a distribution be made as soon as practical following termination for a participant with an account value of less than \$5,000

#### ***Forfeitures***

There are no forfeitures under the Plan due to 100% vesting being elected.

#### ***Hardship Withdrawals***

As permitted by the Internal Revenue Code (IRC), a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The participant must meet the condition that they cannot relieve the amount of the need by stopping the elective contributions to the Plan. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

### **NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

#### ***Use of Estimates***

The preparation U.S GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments generally are reported at fair value, but may also be reported at contract value or net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 4 and 5 for further discussion of fair value measurements, contract value, and NAV.

The Plan's Administrators determine the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2020 and 2019.

#### ***Payment of Benefits***

Distributions to participants are recorded when paid.

#### ***Expenses***

Expenses attributable to the general Plan administration were paid by the Plan and allocated among the accounts of all participants, in proportion to their account balances, unless paid by the Employer. During the years ended December 31, 2020 and 2019, expenses of \$15,314 and \$18,934, respectively, were paid by the Plan and allocated to participant accounts.

### NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

#### *Subsequent Events*

Management has evaluated subsequent events through the date that the financial statements were available to be issued, June 27, 2024. See Note 9 for relevant disclosures. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

### NOTE 3: INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

The Plan Administrator has elected the method of compliance, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. The following financial information included in the Plan's financial statements has been derived from information certified to be complete and accurate by the Trustee under such regulation:

- a) Total investments, at fair value and contract value, included in the statements of net assets available for benefits at December 31, 2020 and 2019.
- b) Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2020 and 2019.
- c) Investment income information included in the statement of changes in net assets available for benefits for the years ended December 31, 2020 and 2019.
- d) All amounts included in Note 4, *Fair Value Measurements (Unaudited)*.
- e) All amounts included in Note 5, *Investments Reported at Contract Value (Unaudited)*.
- f) All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2020.

### NOTE 4: FAIR VALUE MEASUREMENTS (UNAUDITED)

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
  - observable; or
  - can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2020 and 2019.

*Pooled Separate Accounts:* The Plan has investments in a pooled separate account ("PSA"), which invests mainly in registered investment companies ("RIC"), consisting of bond funds, growth funds, value funds and international funds. The PSA seeks long-term capital appreciation without undue risk to principal. The Plan's participants personally direct the amount of their fund holdings into the various RIC investments held by the PSA. Thus, while participants' contributions are purchasing units of the PSA, participants are making their investment decisions based on the underlying RICs to which their contributions are allocated. The presentation of the investments held by the Plan in the supplementary schedule and other schedules within the footnotes is at the RIC level, given this is the most meaningful measurement for the participants of the Plan and are valued as a Level 2 investment.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### NOTE 4: FAIR VALUE MEASUREMENTS (UNAUDITED) (CONTINUED)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

### **NOTE 4: FAIR VALUE MEASUREMENTS (UNAUDITED) (CONTINUED)**

#### ***Changes in Fair Value Levels***

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Management evaluated the significance of transfer between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2020, there were no significant transfers in or out of Levels 1, 2 or 3.

### **NOTE 5: INVESTMENTS REPORTED AT CONTRACT VALUE (UNAUDITED)**

In 2018, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with MassMutual totaling \$152,260 for 2020 and \$102,431 for 2019. MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.10%. The crediting rate is reviewed on a semi-annually basis for resetting. The guaranteed investment contract does not permit the insurance Organization to terminate the agreement prior to the scheduled maturity date.

The Stable Value Core Option seeks to provide maximum return consistent with a guarantee of principal. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, credited on a daily basis, and there is no set maturity. The effective credited interest rate is set semi-annually and effective on the first day of the semi-annual period. Contract charges may reduce this return.

These contracts meets the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

### **NOTE 5: INVESTMENTS REPORTED AT CONTRACT VALUE (UNAUDITED) (CONTINUED)**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

### **NOTE 6: TAX STATUS**

The Admin Partners volume submitter has received an advisory letter dated March 31, 2017 from the Internal Revenue Service (IRS) stating that the form of the Plan is acceptable under the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 7: RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Reliance Trust Company. MassMutual is the trustee and record-keeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

### **NOTE 8: PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

### **NOTE 9: SUBSEQUENT EVENTS**

Management of the Plan evaluated all events or transactions that occurred after December 31, 2020 through June 27, 2024 the date the Plan's financial statements were available to be issued.

In March 2020, the World Health Organization made the assessment that the outbreak of a novel coronavirus (COVID-19) can be characterized as a pandemic. As a result, broad domestic and international stock market indices have declined and the Plan's fair value of investments has declined similarly. Such declines in the fair value of investments held by the Plan have impacted participants' account balances and may affect the amounts reported in future financial statements.
