Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We were engaged to perform the audits of the financial statements of the MelroseWakefield Healthcare 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of September 29, 2023 and December 31, 2022, the related statement of changes in net assets available for benefits for the period January 1, 2023 through September 29, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of September 29, 2023 and December 31, 2022, and for the period January 1, 2023 through September 29, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion

We do not express an opinion on the accompanying financial statements of the Plan. Because of the significance of the matter described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.



Basis for Disclaimer of Opinion

As described in Note 2, the Plan has not maintained accounting records and supporting documents relating to certain contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficiently to determine the extent to which the financial statements may have been affected by these conditions.

Further, as described in Note 2, the Plan has excluded from investments in the accompanying statements of net assets available for benefits certain contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded from the accompanying statement of changes in net assets available for benefits. Under accounting principles generally accepted in the United States of America, these accounts and the related income and distributions should have been included in the accompanying financial statements. The effects of these excluded contracts and custodial accounts and the related income and distributions are not determinable.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our responsibility is to conduct an audit of the Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matter described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of the Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

Notes to Financial Statements

Note 1 - Description of the Plan

The following description of the MelroseWakefield Healthcare 403(b) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General, Plan Merger and Termination

The Plan was a defined contribution plan sponsored by the MelroseWakefield Healthcare Parent Corporation, including the following affiliated employers: MelroseWakefield Healthcare, Inc., Hallmark Health Medical Associates, Inc. and Hallmark Health Visiting Nurse Association, Inc. (through June 30, 2021) (the "Employer" or "Company"), covering substantially all employees of the Company. The Plan became effective January 1, 1995 and was most recently amended and restated effective January 1, 2021. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Substantially all investments were participant-directed.

The Tufts Medicine, Inc. Retirement Plan Oversight Committee authorized the merger of all assets of the MelroseWakefield Healthcare 403(b) Plan to the Tufts Medicine 403(b) Plan ("Tufts 403(b)") with an effective date of September 29, 2023, and accordingly, all plan assets were transferred to the Tufts 403(b) Plan on September 29, 2023. As a result of the merger, the Plan was terminated.

Eligibility

All employees employed by the Company were eligible to participate immediately in the Plan upon completion of a salary reduction agreement, regardless of age, with the exception of certain leased employees and certain nonresident aliens.

Participant Contributions

Participants were able to contribute up to 100% of their compensation, subject to Internal Revenue Code ("IRC") limitations. Participants who are at least age 50 were able to make an additional "catch-up" contribution subject to IRC limitations. Participants were able to also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements.

Employer Contributions

For the period ended September 29, 2023, the Company funded matching contribution equal to 50% of the first 6% of eligible compensation, subject to certain limitations. A participant was eligible to receive matching contributions upon completing one year of service, as defined.

Participant Accounts

Each participant's account was credited or charged with contributions, investment income, and administrative expenses. Allocations were based on participant earnings/losses, account balances or specific participant transactions, as defined. Participants were able to change their investment options as set forth in the plan document. The benefit to which a participant was entitled was the benefit provided from the participant's vested account.

Note 1 - Description of the Plan (Continued)

Vesting

Participants became immediately vested in their deferral, rollover, and after-tax contributions and actual earnings thereon. Participants became 100% vested in the Company's matching and discretionary contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age.

Otherwise, participants vest in the Company's matching and discretionary contributions based on years of continuous service, as follows:

Forfeitures

When certain terminations of participation in the Plan occurred, the nonvested portion of a participant's account represented a forfeiture, as defined by the Plan. If a forfeiting participant was re-employed and fulfilled certain requirements, as set forth in the Plan, the participant's account would be restored. Forfeitures of Employer contributions were used to reduce future Employer contributions, pay administrative expenses, or may be used to restore any amount previously forfeited by a re-employed participant. During the period ended September 29, 2023, \$36,502 of forfeitures were used to offset a portion of the Employer contributions for the 2022 Plan year funded in 2023 and \$0 of forfeitures were used to pay plan expenses. Total unapplied forfeitures were \$0 and \$34,149 as of September 29, 2023 and December 31, 2022, respectively.

Unallocated Assets

The Plan held assets in a recapture account which receives deposits as a result of a revenue sharing agreement with Fidelity Management Trust Company ("Fidelity"). Funds in the account were used to pay qualified plan expenses or allocated to participants. During the period ended September 29, 2023, \$10,420 was used to pay plan expenses and \$9,820 was transferred to the Tufts 403(b) Plan. The balance in unallocated assets was \$0 and \$19,911 as of September 29, 2023 and December 31, 2022, respectively.

Withdrawals and Distributions

Benefits were able to be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Participants were able to leave their funds invested in the Plan or elect a distribution in the form of a lump sum, installment payments or an annuity.

Withdrawals and Distributions (Continued)

A participant was able to request a withdrawal upon attainment of age 59 1/2 or upon demonstration by the participant to the Plan administrator that the participant was suffering from "hardship", as defined in the plan document. Hardship distributions were able only be taken from assets of their deferral accounts.

Notes Receivable from Participants

Participants were able to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. Loans bore a reasonable rate of interest. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period was allowed. No more than one loan may be outstanding at any time. Principal and interest is generally repaid at least quarterly by participants directly to the plan custodian.

Note 2 - Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

In November 2007, the Department of Labor ("DOL") issued amended regulations eliminating an exemption granted to 403(b) plans from the annual Form 5500 reporting, disclosure, and audit requirements under Part 1 of Subtitle B of Title I of ERISA. The Plan, however, was established in 1995, and historically the Plan was viewed as a collection of individual contracts with which participants could engage in a range of actions with limited involvement, if any, by the Plan sponsor. Accordingly, various accounting and payroll records related to the Plan's 403(b) contracts and custodial accounts issued to current and former employees prior to January 1, 2009 were not maintained by the Plan. Consequently, the financial statements have been prepared based on available records analyzed by Plan management. As certain records were not available from the inception of the Plan, there can be no assurance as to the completeness or accuracy of the Plan's reported financial information.

The Plan had excluded from investments in the accompanying Statements of Net Assets Available for Benefits certain annuity and custodial accounts issued to current and former employees prior to January 1, 2009. Management has made a good faith effort to obtain this information but has been unsuccessful. The investment income and distributions related to such accounts had also been excluded in the accompanying Statement of Changes in Net Assets Available for Benefits. The amount of these excluded annuity and custodial accounts and the related income and distributions are not determinable.

Investments, Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they are incurred. No allowance for credit losses was recorded as of September 29, 2023 or December 31, 2022.

Benefits Paid

Benefits were recorded when paid.

Plan Expenses

Participant transaction fees, investment expenses, and certain administrative fees incurred by the Plan were paid by the participants. Investment related expenses were included in net appreciation in fair value of investments. Any remaining fees not paid from plan assets were paid by the Company. Expenses that were paid by the Company were excluded from these financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Employer has evaluated subsequent events through July 15, 2024, the date that the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.

Note 3 - Information Certified by the Custodian

Plan investments were held by the Plan's custodian, Fidelity Management Trust Company, ("Fidelity"). The fair value of investments as of December 31, 2022, and all investment transactions for the period January 1, 2023 through September 29, 2023, including interest and dividends and net appreciation in fair value of investments were reported to the Plan and certified as complete and accurate by Fidelity. The Plan offered investment choices to allow Participants to create a diversified portfolio of assets based on a participant's risk tolerance. Participants in the Plan were able to direct contributions to a variety of investment options.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs that are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that is significant to the fair value measurement.

Note 4 - Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2022.

Mutual funds (Including mutual funds and cash reserves in Self-directed brokerage accounts): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Risks and Uncertainties

The Plan provided for various investment options in registered investment companies and self-directed funds. Investment securities were exposed to various risks which include, but are not limited to, interest rate, market and credit risks. Market risks include global events such as an international conflict, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities through December 31, 2022, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note 6 - Related-Party Transactions and Exempt Party-In-Interest Transactions

Investments were held by Fidelity, the custodian of the Plan. Accordingly, these investments were considered exempt party-in-interest transactions. During the period ended September 29, 2023, \$113,966 was paid to Fidelity and other service providers as administrative and investment expenses. In addition, notes receivable from participants are also considered exempt party-in-interest transactions. The Plan also received revenue credits from Fidelity in the amount of \$36,891 and reported as other income on the Statement of Changes in Net Assets Available for Benefits. The credits are used to offset Plan expenses.

Note 8 - Tax Status

The Plan was initially designed to comply with the provisions of Section 403(b) of the IRC and had been amended and restated effective January 1, 2021. The Plan has not obtained a tax determination letter from the Internal Revenue Service ("IRS"). However, the Plan administrator believed that the Plan and related trust was designed and operated in compliance with plan terms and the applicable requirements of the IRC and was, therefore, exempt from federal income taxes.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there were currently no audits for any tax periods in progress.
