Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Heritage Southeast Bank 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of May 23, 2023 and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 to May 23, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of May 23, 2023 and December 31, 2022, and for the period from January 1, 2023 to May 23, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by qualified institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is responsible for maintaining a current Plan instrument, including all Plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Plan approved a Plan termination effective December 31, 2022, and liquidation occurred May 23, 2023. As a result, the Plan has used the liquidation basis of accounting in presenting the 2022 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Notes to Financial Statements

1. Description of the Plan

The following description of the Heritage Southeast Bank 401(k) Profit Sharing Plan (the Plan) provides only general information.

General

The Plan is a defined contribution plan and was originally adopted by Heritage Southeast Bank (the Bank or Employer) effective January 1, 1970, and with the latest restatement on January 1, 2021, to provide deferred tax benefits to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Termination

The Plan was terminated by the Bank effective December 31, 2022 (termination date). The Plan was liquidated on May 23, 2023. Accordingly, assets of \$18,300,474 were distributed from the Plan. Upon termination, the Bank contributions became 100% vested.

Eligibility

Through the termination date, the Plan covers all employees of the Bank aged 21 years of age or older with at least 3 months of service. Employer entered the Plan on the first day of the month following meeting the eligibility criteria.

Contributions

Through the termination date, eligible employees may have elected to contribute, on a pretax or post-tax basis, up to 100% of their eligible compensation to the Plan, not to exceed the limit under the Internal Revenue Code (IRC). In addition, employees who are age 50 or older were permitted to make additional contributions of up to the maximum allowed by the IRC. Participants were also permitted to contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Plan provided for automatic enrollment and deferrals such that newly eligible or rehired employees were automatically enrolled at 2% of eligible compensation, unless the participant affirmatively made a different election, with an increase of 1% on the first day of each calendar year up to 5%.

The Bank was permitted to make matching contributions equal to a discretionary percentage, to be determined by the Bank, of the participant's elective deferrals. For the Plan year ended December 31, 2022, the Plan had employer matching contributions on a per pay period basis equal to 100% of the first 6% of compensation contributed to the Plan. During 2023, no employer matching contributions were made to the Plan.

The Bank was permitted to make discretionary profit-sharing contributions on an annual basis as a uniform percentage of participant compensation. All participants share in the allocation of profit-sharing contributions regardless of service completed during the Plan year or employment status on the last day of the Plan year. No profit-sharing contributions were made during 2023.

1. Description of the Plan (cont.)

Participant Accounts

Each participant's account was credited with the participant's contribution and allocations of the Bank's contribution and Plan earnings (losses). Allocations were based on participant compensation, deferrals or account balances, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant's vested account balance. All contributions made to these accounts are directed by the participant into a particular investment offered by the Plan and the allocations between investments can be changed.

Vesting

Prior to termination, participants were immediately vested in their voluntary contributions plus actual earnings (losses) thereon. A participant was 20% vested in the Employer matching contributions and earnings (losses) thereon, after one year of continuous service, and 20% annually thereafter, reaching full vesting after five years of credited service. Participants became or remained fully vested upon Plan termination.

Notes Receivable from Participants

Through the termination date, the Plan allowed for the rollover of loans as a result of a prior merger, however, new participant loans were not permitted by the Plan. Prior to the Plan's termination, the related principal and interest payments occurred ratably through regular payroll deductions in accordance with the loan agreements.

Payment of Benefits

A participant's contributions and vested Employer contributions may be withdrawn upon retirement (on or after the attainment of normal retirement age), termination of employment, disability, or death. Participants may elect to have distributions paid in the form of a lump-sum distribution. The normal retirement age is 65 years old. Through the termination date, certain in-service distributions at age 55 were also allowed, along with withdrawals in the event of financial hardship.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan as provided in the Plan agreement. Certain other administrative expenses of the Plan are paid by the Bank and are excluded from these financial statements. Investment fees are paid by the Plan in the form of reductions of net investment income (loss) earned by Plan participants.

Forfeited Accounts

Forfeited non-vested accounts are used to pay administrative expenses or offset Employer contributions. During the year ended May 23, 2023, \$1,553 of forfeited funds were used to reduce Plan expenses. As of May 23, 2023 and December 31, 2022, forfeited non-vested accounts totaled \$0 and \$1,553, respectively.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) require the Plan's management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (cont.)

Basis of Accounting

The accompanying 2023 and 2022 financial statements of the Plan are prepared on the liquidation basis of accounting. The liquidation basis of accounting was adopted as a result of the effective Plan termination. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value with the exception of the fully benefit-responsive investment contract which is valued at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount participants would normally receive if they initiate permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian and insurance company.

Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. No allowance for credit losses has been recorded as of May 23, 2023 and December 31, 2022. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Upon termination of the Plan, outstanding loans not repaid by the participants within a specified timeframe were subsequently treated as distributions and became subject to federal and state income taxes.

Payment Benefits

Benefit payments to participants are recorded upon distribution.

3. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly Nationwide Trust Company, FSB (Nationwide) certified that the financial information included in the financial statements as of May 23, 2023 and December 31, 2022, and for the period from January 1, 2023 to May 23, 2023, provided to the Plan is complete and accurate. The information as to investment assets and transactions therein, and investment income (loss) included in the accompanying financial statements as of May 23, 2023 and December 31, 2022, and for the period from January 1, 2023 to May 23, 2023, is covered by the certifications.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2022. The plan has no assets as of May 23, 2023.

5. Guaranteed Investment Contracts with Insurance Companies

The Plan invested in a benefit responsive guaranteed investment contract with Nationwide Life Insurance Company (Nationwide), the Nationwide Fixed Select Option (Fixed Select Contract). This contract is an insurance product which is a group annuity contract. Nationwide Life maintained the contributions in a general account. Nationwide credited the account with contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at fair value. There are no reserves against fair value for credit risk of the contract issuer or otherwise.

The contract may have certain restrictions that impact the ability to collect the full contract value including a potential market value adjustment if the entire contract is terminated. Nationwide was contractually obligated to pay the principal and specified interest rate that was guaranteed to the Plan. The interest crediting rate was based on a formula agreed upon with the issuer but may not be less than 0%. The interest crediting rate was reset quarterly. The methodology for calculating the interest crediting rate was based on the earnings of the underlying assets in the entire medium-long term portfolios compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Because of the nature of this group annuity contract, average yields were not available from Nationwide.

As described in Note 2, because the guaranteed investment contract was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Nationwide, represented contributions made under the contract, plus earnings or losses, less participant withdrawals and administrative expenses.

6. Tax Status

The Plan is based on the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA (pre-approved plan) sponsored by Pension Financial Services Inc. The IRS has opined and informed Pension Financial Services Inc. by letter dated June 30, 2020, that the pre-approved plan is designed in accordance with the applicable sections of the IRC. The Plan administrator believes that the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan had taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Parties and Party-In-Interest Transactions

Certain Plan investments were managed by Nationwide and therefore these transactions qualify as party-in-interest transactions. The investment contract held by the Plan was managed and provided by Nationwide. The notes receivable from participants were also defined by ERISA as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

Certain administrative functions of the Plan were performed by management or employees of the Bank but are not compensated from the Plan.

8. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities were exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities would have occurred and that such changes could have materially affected participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

9. Subsequent Events

Management has evaluated subsequent events through June 26, 2024, which is the date the financial statements were available to be issued.
