Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Heska Corporation 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 20, 2023 (in Liquidation) and December 31, 2022, and the related statement of changes in net assets available for benefits for the period from January 1, 2023 through December 20, 2023 (in Liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from qualified institutions as of December 20, 2023 and December 31, 2022, and for the period from January 1, 2023 through December 20, 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit Financial of the Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting

As described in Note 1 to the financial statements, the Plan Sponsor terminated the Plan effective June 12, 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used to present the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Note 1 – Description of the Plan

The following description of the Heska Corporation 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan's provisions.

General. The Plan was a defined contribution plan, which went into effect January 1, 1994, that was generally available to all employees of Heska Corporation (the "Company", "Plan Sponsor," or "Plan Administrator") and participating employers (collectively, the "Employer"). The Plan excluded collectively bargained employees, employees of a controlled group or affiliated service group employer that did not adopt the Plan, and independent contractors. Employees became eligible to participate in the Plan upon attainment of age 21. Employees were able to enter the Plan on the first day they became eligible. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). Benefits under the Plan were not guaranteed by the Pension Benefit Guaranty Corporation.

Plan Termination. Effective June 12, 2023, the Plan document was amended to terminate the Plan. In connection with the Plan's termination the following occurred:

- All participants in the Plan as of June 12, 2023, are 100% vested in their entire account balance;
- No further contributions will be made to the Plan;
- The Plan was amended to ensure document compliance with the most recent statutory or regulatory changes;
- The Plan's termination created a distributable event for all the Plan's participants and the Plan was fully liquidated on December 20, 2023; and
- As further discussed in Note 2, the Plan changed its basis of accounting from the going-concern basis of accounting to the liquidation basis of accounting.

On June 13, 2023, Mars, Incorporated completed the acquisition of Heska Corporation.

Plan Amendment. On January 3, 2023, the Company completed the acquisition of MBio Diagnostics, Inc. d/b/a LightDeck Diagnostics ("LightDeck Diagnostics"). In connection with this acquisition, the following:

- Effective January 3, 2023, the Plan document was amended to add LightDeck Diagnostics as a participating employer; and
- Employees of LightDeck Diagnostics became immediately eligible to participate in the Plan.

Contributions. The following types of contributions were allowable under the Plan:

- Salary Deferral Contributions – Participants had the option to contribute a percentage of their pre-tax annual compensation, as defined in the Plan document, subject to limitations. Participants also had the option to contribute a percentage of their after-tax compensation and designate it as a Roth deferral contribution. A participant's total salary deferral contributions cannot exceed \$22,500 (\$30,000 if age 50 or over) in calendar year 2023.

- **Discretionary Matching Employer Contributions** – The Company had the option to contribute matching amounts each payroll period to eligible participants. During 2023, the Company made a discretionary matching Employer contribution equal to 40% of participant salary deferral contributions up to 7% of eligible compensation.
- **Discretionary Employer Nonelective Contributions** – The Company had the option to make a discretionary nonelective contribution to eligible participants based on a per capita allocation method. During 2023, the Company did not make a discretionary Employer nonelective contribution.
- **Rollover Contributions** – Certain amounts distributed to eligible participants from other qualified employee benefit plans were able to be rolled into the Plan.

All contributions were allocated to the Plan's investment funds at the direction of the participants.

Investment Options . Participants were able to direct their investments into various mutual funds and any security offered under the Plan's self-directed brokerage account ("SDBA") option.

Participant Accounts . Each participant's account was credited with the participant's contributions (salary deferrals and rollovers, if any) and an allocation of (a) the Employer's discretionary contributions (matching and nonelective, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account balance.

Notes Receivable from Participants . Participants had the option to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms ranged from 1 month up to a maximum of 5 years (a longer term was available if the loan was being used to acquire a principal residence). The loans were secured by the balance in the participant's account and bore a rate of interest equal to the prime rate plus 1% at the date the loan was granted as determined by the Plan administrator. Principal and interest payments were paid ratably through payroll deductions.

Payment of Benefits . Benefits to participants or beneficiaries generally were payable as a lump sum, installments, or partial cash payments equal to the value of their vested account balance upon retirement, disability, death or termination of the participant. A terminated employee with a balance of less than \$5,000 had the option to be automatically paid out by the Plan upon termination. Additionally, participants had the option to request in-service withdrawals of their rollover contributions account, upon attainment of age 59½, or if they incurred a financial hardship, as defined, if certain criteria are met.

Vesting . Participants were vested immediately in all contributions plus actual earnings thereon.

Expense Budget and Other Unallocated Asset Accounts . The Plan maintained an expense budget account ("EBA") and other unallocated asset accounts. The EBA was funded with revenue sharing from certain Plan investments and was used to pay Plan administrative expenses or was reallocated to eligible participant's accounts. During 2023, \$42,181 of the Plan's EBA and other unallocated asset accounts were used to pay Plan expenses. The combined balance in the EBA and other unallocated asset accounts was \$0 and \$14,537 as of December 20, 2023 and December 31, 2022, respectively.

Note 2 – Summary of Significant Accounting Policies

Change in Basis of Accounting. As further discussed in Note 1, the Plan was terminated effective June 12, 2023, and management determined liquidation is imminent. As a result, the Plan changed its basis of accounting from the going-concern basis of accounting used to present the 2022 financial statements to the liquidation basis of accounting used in presenting the 2023 financial statements.

Use of Estimates. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition . The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Contributions. Participant contributions and the related Employer matching contribution are recognized in the period in which participant contributions are withheld from compensation.

Notes Receivable from Participants . Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 20, 2023 or December 31, 2022. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefits Payments. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account. Included in administrative expenses are claims processing, recordkeeping, investment management, distribution, account maintenance, securities brokerage, and other fees. Additionally, certain investment related expenses are included in investment income.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 20, 2023 and December 31, 2022. The following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds and money market funds (including those held in the self-directed brokerage accounts ("SDBA")) are valued at the quoted net asset value ("NAV") of shares held by the Plan at year end.
- Equities and exchange traded funds held in the SDBA are valued at the closing price reported on the active market on which the securities are traded.
- Certificates of deposit held in the SDBA are valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit-worthiness of the issuer

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6 – Tax Status

The Company has adopted a Transamerica Retirement Solutions, LLC Non-Standardized Pre-Approved Profit Sharing Plan ("pre-approved plan"). The pre-approved plan received an opinion letter from the Internal Revenue Service ("IRS") on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan and pre-approved plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related trust is tax exempt as of December 20, 2023 and December 31, 2022. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 20, 2023 and December 31, 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Party-In-Interest Transactions

The Plan's trustees, State Street Bank and Trust Company and Transamerica Trust Company; the Plan's custodian, Transamerica Life Insurance Company; the Plan's SDBA custodian, Charles Schwab; the Plan's recordkeeper, Transamerica; the Plan's investment advisor; the Plan's auditors; the Employer; and Plan participants were all parties-in-interest to the Plan. Additionally, the Plan maintained notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 8 – Concentrations

As of December 31, 2022, there was one investment which individually represented more than 10% of net assets available for Plan benefits.

Note 9 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 12, 2024, which is the date the financial statements were available to be issued.
