To whom it may concern,

Venicom experienced an extreme business downturn due to the Covid pandemic. It struggled to maintain business operations as best it could but was unable to and eventually had to let most employees go when it became clear it would not recover prior business operation levels.

The individual responsible for filing Form 5500 indicated it was a completed task however we are now being notified it is not. This individual no longer works for Venicom. We also requested that the 401K plan be closed, as Venicom could not afford to maintain, and are assuming this is now correctly done?

We are asking for a hardship waive of late filing fees and penalty with our sincerest apologies for this error.
