To the Trustees of the SPORTFIVE U.S., LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed an audit of the financial statements of SPORTFIVE U.S., LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

As discussed in Note 1 of the financial statements, effective April 29, 2022 the Plan merged into the Insperity 401(k) Plan. As a result, all assets of the Plan will be transferred out of the Plan. Our opinion is not modified with respect to that matter.

Notes to Financial Statements For the Period from January 1, 2022 to April 29, 2022 and the Year Ended December 31, 2021

1. Description of Plan

The following brief description of the SPORTFIVE U.S., LLC 401(k) Plan (the “Plan”) is for general information only. Participants should refer to the summary plan description and plan document for more complete information.

The Plan was established on January 1, 2010, and amended and restated effective August 1, 2020. The Plan was a defined contribution plan that covered all employees of SPORTFIVE U.S., LLC (the “Company” or the “Employer”) and participating affiliates. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective April 29, 2022, the Plan was merged into the Insperity 401(k) Plan (“Successor Plan”), and the Plan ceased to exist.

Eligibility

All employees, except those that were covered by collective bargaining arrangements, were eligible to participate in the Plan on the first day of the month following their date of hire. There was no minimum age requirement for participation.

Contributions

Participants could elect to contribute pre-tax contributions, at a minimum of 1% up to 75%. Participants could also elect to contribute Roth deferral contributions.

Participants of the Plan received a matching contribution equal to 100% on the first 3% of compensation which did not exceed \$4,000 for the plan year.

The Company could contribute non-elective contributions for eligible participants. There were no non-elective contributions made for the period from January 1, 2022 to April 29, 2022 and for the year ended December 31, 2021.

Vesting

Participants are always fully vested in their own contributions and employer matching contributions, plus earnings thereon. Non-elective contributions and discretionary matching contributions made prior to July 1, 2017, plus actual earnings thereon, vested according to the following schedule:

Forfeitures

The portion of a participant’s account balance, which was not vested upon termination of employment, was forfeited and remained in the Plan. Forfeitures could be used to reduce employer contributions and to subsidize certain administrative expenses. For the period from January 1, 2022 to April 29, 2022, no plan forfeitures were applied in conjunction with the payment of the employer matching contributions or administrative expenses. Due to the Plan merging with the Successor Plan, forfeitures in the amount of approximately \$12,100 were transferred to the Successor Plan. The available balance of forfeitures as of April 29, 2022 and December 31, 2021 approximated \$0 and \$8,900, respectively.

Participant Accounts

Each participant's account was credited with his or her contributions, employer contributions, and actual earnings thereon. Contributions to the Plan were invested by Reliance Trust Company ("Reliance" or the "Trustee") as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Notes Receivable from Participants

Participants were permitted to borrow 50% of their vested account balance up to a maximum of \$50,000. The term of the loan could exceed five years except when the loan was used to acquire or construct a principal residence, which could be repaid over a longer period. Loans were repaid through payroll deductions and monitored by the plan administrator. Loans were measured at their unpaid principal balance plus any accrued but unpaid interest. The loans were collateralized by the balance in the participant's account and bore interest at rates commensurate with the prevailing rate, as determined by the plan administrator. As of December 31, 2021, the interest rate on participant loans was 5.25%. There were no outstanding loans as of April 29, 2022.

Benefits

A participant's vested account balance was distributable generally upon termination, disability, early retirement (age 59 ½), normal retirement (65) or death, as defined in the plan document. A participant could receive a distribution in the form of a lump sum payment. In certain other cases, subject to the approval of the plan administrator, and after receiving the maximum loan available from the Plan, participants could request a withdrawal of a portion of their vested account balance in the case of financial hardship.

Administrative Expenses

Substantially all administrative expenses of the Plan were paid by the Company.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America required management to make estimates and assumptions that affected the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net (depreciation) appreciation included the Plan's gains and losses on investments bought and sold as well as held during the period from January 1, 2022 to April 29, 2022 and the year ended December 31, 2021.

Payment of Benefits

Benefits were recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through February 27, 2023, the date these financial statements were available for issuance.

4. Fair Value Measurements

The Plan's investments were stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy were based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at April 29, 2022 and December 31, 2021.

- Mutual funds: the fair value of mutual funds is based on quoted prices in an active market for each share held by the Plan.
- Common collective trust funds: The fair value of the common collective trust funds is determined by the trustee of the fund based on the underlying assets, which represent the net asset value of units held by the trust. The common collective trust funds do not have any unfunded commitments or significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

SPORTFIVE U.S., LLC 401(k) Plan

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Merger

Effective April 29, 2022, the Plan merged into the Successor Plan, all assets of the Plan were transferred to the Successor Plan.

6. Tax Status

On July 8, 2014, the Internal Revenue Service (the "IRS") stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself. However, the plan administrator believes that the Plan was designed and was being operated in compliance with the applicable requirements of the IRC from January 1, 2022 to April 29, 2022 and during 2021. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2019.

7. Risks and Uncertainties

The Plan's investments are concentrated in mutual funds and common collective trust funds that invest in various investment securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

8. Party-in-Interest Transactions

Fees paid to ADP by the Plan for administrative services qualify as party-in-interest transactions and were \$4,153 and \$9,264 for the period from January 1, 2022 to April 29, 2022 and for the year ended December 31, 2021, respectively.

To Whom it May Concern:

We are filing with this letter the Form 5500 for the above-named Plan for the calendar plan dates of Jan. 1, 2022 through April 29, 2022. These filings are late; however, we believe we have circumstances that qualify as reasonable cause, and therefore request that the IRS grant a waiver of any penalties that may be assessed due to these late filings.

Our Plan auditors, Mazars USA LLP, sent SPORTFIVE US a list of requested Plan documents, reports, and information on Oct. 31, 2022. SPORTFIVE sent the requested documents list (via email) to ADP Retirement Services on Nov. 3, 2022 by Colin O'Brien – Technical Controller. After no confirmation or response from ADP RS, a follow-up request (via email) was sent on Dec. 2, 2022 by Matt Leos – HR Associate (Plan Administrator). Again, after no confirmation from ADP RS, Matt called ADP RS, where he was told that document request was archived because it was marked as a 2021 request, though the form stated 2022.


Following multiple phone conversations with ADP RS throughout January 2023, the initial document request was completed and sent to Mazars on Jan. 20, 2023. After Mazars reviewed the documents, they came back to SPORTFIVE with several items that were missing from ADP's file (Jan. 30). Matt reached back out to ADP RS (via phone) on Feb. 2 regarding the missing documents. ADP partially completed the missing documents on Feb. 3, and another document request was sent (via email) to ADP RS on Feb. 6 with the remaining items:

- Statements of distribution for (4) employees
- Trustee certification letter
- ADP SOC1 report or Bridge letters for Q1 2022 and Q2 2022

Matt made another phone call to ADP on Feb. 9 to inquire about the status of the request. The ADP representative saw that the request had not been completed and escalated. SPORTFIVE received only the distribution statements on Feb. 13 but did not receive the other documents until Feb. 17. Mazars provided SPORTFIVE the drafted 5500 on the night of Feb. 15, as they were delayed due to not receiving the proper documents.

Our company has every intention of complying with the IRS' reporting and disclosure rules. We believe the late filing for this Plan is the result of reasonable cause and was out of SPORTFIVE's control. Accordingly, we request relief from any and all late filing penalties which may be assessed.
